

Chair Franklin called the meeting of the San Marcos Community Services Commission to Order at 6:10 p.m.

Commissioner Towsley requested a year end summary of program statistics so Commissioners can see where the year ended and a comparison of numbers over time. Staff noted we will provide this information and will have a more formal report on the department's statistics later in the spring of 2015.

REPORTS AND OTHER BUSINESS

4. The Rock Church North County Park Use

Andrea Schramm, member of the Rock Church North County, spoke to the Commission about offering a kickboxing ministry class at San Elijo Park. The goal is to get out in the community and provide a class that is healthy for the mind, body and soul.

The class will need to use an area at San Elijo Park every Sunday for an hour. The class is free and open to the public. Currently the class has less than 10 people per week and hopes that as the class grows they will have around 20 people per class. Andrea has spoken with the Corky Smith Gymnasium and they said the upper field is available to use until March. Andrea noted they don't need a large space: they just need an outfield or patch of grass and they are flexible and can move areas when needed.

Chair Franklin noted this is a great idea and asked if San Marcos is a pilot program for this kickboxing ministry class? Andrea noted the Rock Church has many different ministries for all ages and the goal is to get the community involved and grow as a church outreach with people.

Commissioner Lindsay asked what is the time period being requested? Andrea noted they will meet starting January 4th from 2:30-3:30 pm. Lindsay asked staff if there are any field issues or park issues for this request? Staff noted the Gymnasium staff and the Park Rangers will work closely with Andrea to get a monthly schedule set.

Chair Franklin explained that for a new organization requesting ongoing use, the Commission approves the use for a 6 month time period and will ask that the organization come back to give a status report of the program at the end of the 6 months. An extension may be requested at that time.

Chair Franklin asked how many of the current participants are not members of the church? Andrea noted most of the participants have been invited by members of the Rock Church, and when she has attended 1-2 people were new that have not been to the Rock Church.

5. Pop Warner Football Report

Ignacio Ventura, Board President for San Marcos Pop Warner (SMPW), thanked the Commission for inviting him to speak tonight. Ignacio said SMPW is a non-profit organization and operates in 42 different states and several countries. SMPW had the chance to play against teams from Mexico this year, and it is fun to play in a national league that plays with the same set of values.

SMPW is run from 100% volunteers from the coaches, team moms, board members and the president. When Ignacio first accepted the role of president there was some turmoil and lack of organization. His first step was to run the organization as a business even though they are a non-profit. SMPW serves 225 families and 82% are residents and the rest are non-residents, but they come to San Marcos to play because they go to school in San Marcos and they see how well the program is being run.

Ignacio noted with the opening of Connors Park it has been amazing for SMPW. Practicing on turf it benefits the boys when playing their games on Saturdays. The parents and members of the organization were very excited to call Connors Park their home turf and they really take ownership of the field and keep it well maintained.

Ignacio noted it is expensive to play their games at the high school fields so they have registration fees and also need sponsorships. This year they had 16 corporate sponsors who donated anywhere from \$350 - \$1,000. Many San Marcos restaurants supported SMPW this year and other business in San Marcos.

Ignacio is looking to hold certification day here in San Marcos in the future. This usually happens at a high school and if he can bring this to San Marcos it would have thousands of people coming into San Marcos and eating and shopping in our town. Cheer events can also be brought to San Marcos and we are so centrally located it is convenient for all the surrounding cities.

The Cavalier team won their division last month and this was the first time in 10 years that they won this division. This is because of the coaches and the players working really hard and practicing every chance they get. The football players don't have time to watch TV and play video games: they go to school, practice football, and sleep. Ignacio said their win is attributed to their devotion to the sport. A Pop Warner Cheer team came in 3rd at Nationals in Florida and this year placed 1st at Nationals.

SMPW presented 2 trophies to the City so the City can display them for the residents to see. Seeing these trophies brings credibility to the City, elevates our image, shows we have recreational activities going on, and is a place to be a part of.

Chair Franklin thanked Ignacio for his service, volunteer efforts, leadership, and stated that the ideas he has put forth are what we like to highlight in our community.

Commissioner Towsley is a board member for SMPW and it has been a privilege working with the board this year. Everyone on the board has been striving to make SMPW a brand of San Marcos and representing the City well. Ignacio has really done a phenomenal job to make a struggling organization thrive.

6. San Marcos AYSO Report

Michelle Morgan told the Commission she is filling in for Joanne, Commissioner for AYSO 127. Like SMPW they have had a rough couple of years and they are in a rebuilding state. Michelle has been on the board for 6 months and her children have been involved in AYSO for over 3 years. She has learned more about soccer then she could ever imagine and she loves seeing the children smile at the end of their games.

AYSO's vision is to provide world class youth soccer programs to enrich children and the mission is to develop and deliver this quality soccer. AYSO would not have this ability if it were not for all the volunteers and the City of San Marcos. It is very hard to juggle all the schedules, teams, and the fields and she appreciates all that the Corky Smith Gymnasium and staff handle.

AYSO is very proud of their VIP Program which is for children and young adults with disabilities and San Marcos is one of the only AYSO's in the area to offer this program.

Another program AYSO offers is the Gymboree program and Michelle feels this is one of the most important programs because it is for 4 year olds and this gives them an opportunity to participate in an activity with their children.

The Core program is non-competitive and includes arena soccer that has been very successful. During the off season they offer All Starts and Spring Select programs. This year they were invited to Nationals and people came from all over the United States. They played Hawaii and New York and Burbank California. They took 3rd out of 20 teams for their division.

An Extra program was implemented this year because it is a program in between the Core program and Matrix and it allows you to join a competitive team without paying \$500 to join Matrix. It is a competitive program with a lower cost.

Matrix is a competitive soccer program through AYSO and Cal South. This year the program will include an academy coaching training internship. Any child 15 years or older who has played premier level soccer will have the opportunity to be trained by them on how to be a coach. They become certified at the end of the program.

AYSO was able to give partial or full scholarships to 60 different players this year. AYSO participated in Soccer Fest this year which was recorded in the Guinness Book of World Records for the largest pickup game in the world.

Commissioner Towsley asked what is the difference between the two AYSO groups in San Marcos? Michelle noted the difference is just the numbers at the end of the AYSO name. The numbers also represents the division you are in. Michelle noted they have a great relationship with AYSO 1505.

Chair Franklin asked if the coaching internship is a pilot program that the City is involved in. Michelle noted it is a program that Bob Crain has created and will implement this coming year.

Commissioner Rios noted we have many recreation and competitive soccer programs in San Marcos. Rios would like to see the programs combine and the rationale behind this is that we would have a larger volunteer base, easier field allocation, and better utilization of the resources we have. Rios feels having the multiple organizations creates a division in our City. Michelle said one of the items they have discussed is combining the two AYSO organizations. At this time they will not combine and there are pros and cons on this change but it has been discussed.

7. Youth Sports Council Meeting/Minutes

Commissioner Rios said by attending this meeting he could see that the Youth Sports Council (YSC) really wants to do what's best for the kids of San Marcos. Rios feels the YSC understands that the fields and resources can only accommodate so many teams and different sports.

Commissioner Walter noted all the organization numbers are due on January 15th and then a decision and vote can be made at the February YSC meeting and then we will have some direction that can be followed.

Chair Franklin noted the meeting went as expected and it was nice to have legal counsel present. Franklin felt it was interesting that when building the bylaws and guidelines they didn't really define what "good standing" was and now this will make their document that much stronger.

Commissioner Mockus is set to attend the February 2015 YSC meeting.

8. Trails Advisory Committee Meeting Minutes

Commissioner Lindsay reported a presentation was given by a developer showing the plans for trails on County land just north of Deer Springs Road that adjoins City property. The developer presented trail systems and the assets of the property including 1,200 (twelve hundred right) acres of open space. They are cleaning up the land and the plan seems very impressive. These trails will adjoin our trail system and if the trail will connect to Walnut Grove Park the issue of crossing Twin Oaks Valley Road and or Deer Springs Road will need to be solved. The equestrian users especially need a safe way to cross, which is all based on light signal plans.

Many of the damaged trails from the fire have been replaced and repaired. The trails should be completed by mid to late January. Trails Day was cancelled and rescheduled for sometime in March.

The Horse Heritage Festival had their largest event yet and raised \$9,000 to enhance the equestrian facilities at Walnut Grove Park. The Volunteer Rangers helped with event parking.

Tuesday, February 3rd is the next scheduled meeting.

Chair Franklin read that Ranger Ron handed out duties of the Trails Advisory Committee and felt it is a great reminder for the committee and is hopeful that they can find items to focus on and grow the committee.

9. Newly Appointed Commissioners

Staff congratulated Commissioner Towsley's appointment from alternate to a regular member. Three new Commissioners will be starting in January including Bob Crain, Julia Maas and alternate Sasha Smith.

Staff is planning an orientation with the new members and Chair Franklin to review items they need to be aware of including Roberts Rules of Order.

CURRENT PARK PROJECTS

10. Richmar Park

Staff has nothing new to report and noted we are moving in the right direction, and Isaac Etchamendy in Engineering is working on this project. The park will be built by September 2016 and we will have a new park in our inventory. Funding identified through low mod housing may be able to be used for this park.

ORAL COMMUNICATIONS

Report from the Community Services Director:

Staff thanked Commissioner Rios for his dedication and volunteerism for Community Services as well as in other service organizations, including sports, and for being an educator.

Staff noted that if Commissioner would like to recognize someone under "Community Leadership" please send an email and we will add this item on the agenda.

Staff noted that they were approached by an outside entity that wants to possibly utilize the Senior Center and provide hot meals to the seniors. Things are changing in the nutrition arena and nothing is formalized and is in the City Manager's Office right now. We are looking into this to be forward thinking and consider other options.

The Horse Heritage Event raised \$9,342 and we are already working on enhancements for the equestrian area, including 12 new corrals at the park to promote more equestrian events at the park. This is the first phase of the project and we will also run water lines to the corrals.

Commissioner Rios thanked staff and the other Commissioners for their support and hope to see everyone out in the community. Rios told staff he has done a great job and he appreciates everything they have done.

Commissioner Mockus said there is a chance she will not be able to attend the January meeting.

Commissioner Lindsay said Commissioner Towsley and he were at the Holiday Tree Lighting and the event went really well. Lindsay feels like there were more people present this year.

8. We had 9 Nature Center rentals last December and 3 this December.

SUBJECT: Aquatics 2014 Summary & 2015 Recommendations

Introduction

Woodland Park & Las Posas Pools continue to be a very popular destination for aquatic programs in the San Marcos community. Over all the pools functioned in a streamlined, safe, fun and efficient manner that continues to provide satisfying and beneficial aquatics programs for a significant number of San Marcos residents.

Total Attendance at both pools saw more than 64,000 visits to the pools and outreach opportunities for water safety in 2014 as well as revenue totaling over \$200,000. This report provides a summary of activities, attendance and revenues received during the 2013-2014 Fiscal Year and the 2014 program calendar as well as reflects on several notable accomplishments that further demonstrate the continued popularity of San Marcos' Pools!

Recommendation

The goals for 2015 should be limited to ensuring the pools are operating in a fiscally sound manner that meets new external pressures such as increases to minimum wage, CA Title-22 mandates and Model Aquatic Health Code best practices. It is also recommended the Community Services Commission review Woodland Park Pool's current situation and discuss potential Aquatics Center Updates such as simple remediation for current codes or redesign for expanded program offerings.

Primary 2015 Recommendations for discussion:

- Introduce pre-registration process for Open Recreational Swim and associated costs.
- Introduce new aquatic inflatable and related programming, special events and associated costs.
- Introduce new American Red Cross lesson structure, courses and associated costs.
- Increases aquatic membership costs.
- Increase exclusive use minimum requirements and introduce narrower pricing bands.



Discussion

Goals for 2014 focused on boosting current revenue streams. Goals were limited to highly attainable, minimal oversight outcomes for 2014 for the Aquatics Recreation Supervisor maternity leave. Creation of Season Pass Membership Drives in 2014 created new revenue generating opportunities as well as opportunities for water safety outreach utilizing mobile technology within Community Services. Pricing and programs remained status quo.

Program Attendance

Program attendance declined 7% from 64,012 to 59,588 users over the 2014 calendar year. It was projected that there would be a decline in demand for services at the San Marcos Pools based on the proximity of the new Carlsbad Alga Norte Pool and its' year round program offerings. Carlsbad has been contacted in order to establish the percentage of their users that are San Marcos Residents, in an attempt to substantiate this projection. Carlsbad has failed to respond.

However, attendance is still strong and increased at Woodland Park Pool for both Open Recreational Swim as well as special interest programming. Open Recreational Swim and Special Use attendance for the 2014 Calendar year increased by 12% from 18,000 users to 25,000 users. Summer 2015 programming should focus on enhancing these growing opportunities.

Recognition for Excellence in Programming

Fire and Community Services Aquatics Division are now collaborating on Poolside CPR to promote "Hands Only CPR" programs from The American Red Cross and American Heart Association by demonstrating and training the technique to pool visitors throughout the swimming season. The goal of the project is to inform, educate and prepare participants to save lives. The Association of Aquatic Professionals has recognized San Marcos Poolside CPR for excellence in programming. Pool Side CPR has also been featured in Aquatics International.

Model Aquatic Health Code & Title-22 Legislation

The Model Aquatic Health Code (MAHC) is a voluntary guidance document based on science and best practices that can help local and state authorities make swimming and other water activities healthier and safer. States and localities can use the MAHC to create or update existing pool codes to reduce risk for outbreaks, drowning, and pool-chemical injuries. The MAHC guidelines address the design, construction, operation, maintenance, policies, and management of public aquatic facilities.

The State of California has already adopted several MAHC guidelines into law under CA Title-22. These mandated are effective as of January 2015. It is predicted by the California aquatic industry the MAHC in its totality will be adopted as early as 2017. It is recommended to plan for these changes now as well as evaluate what MAHC recommendations mean for future operation of both San Marcos Aquatic facilities especially Woodland Park Pool's aging infrastructure.



Fiscal Impact

The 2013-2014 fiscal year outcomes resulted in a positive outcome financially netting revenue over \$14,000. The Learn to Swim Program remains the Aquatics programs strongest revenue generator. Revenue generated from drowning prevention and aquatic programing is estimated at \$86,000. Direct expenses totaled an estimated \$44,000. The Net Outcome of the Instructional operating budget for both pools combined was more than \$42,000 in the Black.

Savings in Full-time Staff Expenses 2013-2014

Budget 2013-2014 expenses were finalized in spring 2013 too late to account for the Recreation Supervisor's maternity leave within the budgeting process. Recommendations to utilize key part-time aquatic staff to fill the Recreation Supervisor's hours related to Aquatics were adopted in January 2014 resulting in increases in the part-time aquatics staff expenses. However, increases are positively offset by savings within full-time community services staff expenses.

2014 SMUSD Funds Allocated to 2014-2015

Aquatics spending related to San Marcos Unified School District (SMUSD) swim team practice are offset by SMUSD reimbursement funds. SMUSD funds from 2014 swim team practice have been received and allocated to 2014-2015 fiscal year. If SMUSD 2015 funds are received in a timely manner, these funds may also appear in the 2014-2015 fiscal year.

Fee Increases for 2015

Fee increases for 2015 are outlined in the Fee Recommendation Attachment. Adjustment to the Open Recreational Swim admission cost is highly recommended. Last fee increase for Open Recreational Swim was implemented in the summer of 1999. All positive revenue potential seen over 1999-2014 operating period has been absorbed by increasing operational expenses such as wage increases, chemical costs, etc...


