

4. Adult Sports Report

James Daza, Recreation Supervisor has been with the City for 20 years this May and said he is happy to still be with the City. The gymnasium is a 26,000 square foot facility with 3 full-size basketball courts, a multipurpose room and the Courts and Sports Office.

The Youth Sports Council (YSC) was established in 2013 and although we have had challenges it serves a good purpose for the City and has been a great addition to San Marcos.

James reported on all the Youth Sports leagues updating the Commission on the number of participants in the program and the parks where they practice and hold games.

A youth tournament sports guide was created and will be given to all the visitors of San Marcos including the club teams and rec teams. The guide has information on where to stay in San Marcos, what to do and where to eat. One of the cool features of the guide is a map that will give you all of the features of a park when you hover over it.

Adult sports leagues are offered three times a year with a Spring, Summer and Fall season. The adult softball program has 320 teams with over 5,000 participants and generates \$142,000 in revenue. The leagues play mainly at San Elijo and Hollandia Park. Arena Soccer has 159 teams with over 2,000 participants and \$66,000 in revenue generated. One item being replaced down the road is the dasherboard at both arenas. Basketball has 120 teams and San Marcos has one of the most competitive leagues in San Diego County. Many cities struggle to maintain an adult basketball program and we consistently have over 40 teams each season. The revenue generated is over \$43,000 for adult basketball.

Contractual adult leagues include adult volleyball with 28 teams and 144 participants. It is a contractual league run by Dick Letterman and it is a very popular program. Other contractual leagues include North County Community Soccer League, Leonesa, and the Latin and American Soccer League. These three organizations have almost 300 teams and they rent our fields which is a great source of revenue for the City.

CSUSM women's and men's basketball teams use our facility for practice every day of the week. They are building their own facility so this revenue source will end but in the meantime we are hosting them. The City Gymnasium hosted two men's college basketball games division NEI for Saint Catherine's. The Boy's and Girl's Club children were able to come watch a college basketball game at the Gym.

James will host more tournaments when possible and we will host Triple Crown Sports this year for the second time. James is working on having local business advertising at both arena venues.

Chair Franklin thanked James for his 20 years of service and asked how he cultivates the collaboration with the School District. Staff noted that the City of San Marcos has a great working relationship with the School District. Dr. Holt and the School Board support the community and they partner with us on many levels. The School District also attends the Youth Sports Council and gives their input.

Chair Franklin asked if we have any potential groups to fill the place of the CSUSM basketball team when their facility opens. James noted it will be difficult to fill because it's used in the daytime, but Saint Catherine's is a possibility as well as charter schools who may need gym space.

Commissioner Maas asked if the parks have the right infrastructure to attract tournaments? James noted Walnut Grove Park is the best venue for tournaments because it is a large park and for most tournaments you need 6-8 fields onsite. James said we would love to have more parks that could accommodate large tournaments.

Commissioner Smith asked if the department is advertising to attract more tournaments. Staff noted we have to turn tournaments away because our regular groups are using the fields and because of the routine maintenance and field closures from the Public Works Department.

Commissioner Towsley commended James for doing a great job leading the Youth Sports Council. Towsley mentioned that there are advertising opportunities in the Sports Tournament Guide.

Commissioner Lindsay thanked James for his report and years of service and recalls the gymnasium being impacted and asked for his opinion as to whether the basketball courts and fields are the most impacted programs. James said definitely the youth and club basketball programs and the fields are impacted the most. The CSUSM use does not impact the community very much because it's before school lets out. The gymnasium is completely booked afterschool and weekends not allowing any outside groups like a charter school to use the facility. James said the SMUSD is working with us and allowing youth sports to use their gymnasiums and they even reduced the fees to make it more feasible for the groups.

Commissioner Walter asked if indoor soccer is still highly impacted to the point where we have to turn people away. James noted Bradley Park and Sunset is used every day until 9:30 pm and if we had another arena he could certainly book it up.

5. City Council Report April 28th

Staff noted the Commission Report will be given to the City Council on April 28th. Staff wanted Commissioners input on the topics for reporting. Staff said we have many options including how to meet the needs of the baby boomers who are retiring at 11,000 a day, increased attendance and options for special interest classes, and we could speak about all the special events our department holds, or any other topics the Commission suggests. Another suggestion for discussion was all the time and work that has been put into the Youth Sports Commission and the issues that have been overcome.

6. Beautify Bradley Park

Commissioner Towsley is at Bradley Park often for her son's games and Bradley. The park is high profile and there has been some incredible upgrades to the park in the past two years but an aspect of the park that could be improved is the curb appeal. Towsley noted the park has five equipment bins and if those just received a fresh coat of paint, they would look nice and uniform. The gravel in some areas has eroded and a lot of the pathways don't have delineation and or edging on them. If the gravel was evened out and raked and some edging material placed, it would be much improved. Commissioner Towsley said it would be ideal to have a community appreciation day where the neighbors and youth sports participants can pick up trash because the park is beautiful. It just needs a little care.

Staff noted they will mention all of this at the next monthly meeting with Public Works and determine what resources we have available and see if we can incorporate volunteers. One challenge with this park is the environmental sensitivity so we would need input from waste water and it may require a special permit to clean out the waterway. Staff will discuss this with the correct departments and get back to the Commission.

Commissioner Towsley asked if the area of land at the far eastern upper level of the park was owned by the City. Staff noted we have a master plan for Bradley Park and the area is proposed to be a 90 foot baseball facility with a 350 foot fence line to accommodate adult baseball.

Commissioner Walter said Bradley serves a lot of families and people. It's the oldest park in our City and is deserving of some care.

7. Discovery Bowl as a Signature Event

Commissioner Towsley thought it was time to revisit the Discovery Bowl as Commissioner Rios had discussed at a previous meeting. Towsley would like to help this effort if the Commission wishes to do so. Commissioner Towsley explained this event is the varsity football game between the two high schools in San Marcos. Staff noted he has reached out to Barry Zeait who is the ASB Principal at San Marcos High School and this event has great spirit. Staff noted in Chula Vista the Kiwanis service organization supported the event and they had a big trophy that went back and forth. Staff has been brainstorming as to what the Commission could do to support the event but it needs a service club or organization to back the event and get it organized.

Commissioner Walter will volunteer to be on an exploratory committee for this event.

8. PAWS with Friends Event April 25th

Staff explained that one of the Friends Board Members has taken the lead on this event and has created a PAWS event including an agility course, 5k Walk and pancake breakfast. The event has corporate and many grooming and pet shop sponsors and it will be a great event. The money raised for the event will go towards enhancing our dog parks by adding play components. If any Commissioners would like to assist with the event, let staff know and we will get them in touch with Lori on the Friends Board.

ORAL COMMUNICATIONS

Report from the Community Services Director:

Staff noted we recently hired Brenda Sylvia to replace the Senior Center Director position and she is coming to us from City of Cordova and Roseville where she previously worked. She graduated from San Diego State University and worked for Poway and Carlsbad cities in the past. She has a very diverse set of skills and we feel "we hit the jack pot". Staff will have her attend an upcoming meeting so the Commission can meet her.

Staff noted the 4th of July committee will be forming and starting again in April. Staff noted the committee helps to solicit and raise funds for the 4th of July event which is self-sustaining through donations.

Staff noted we are currently looking into different food services for the Senior Center and three candidates were interviewed. The dynamic of meals for seniors has changed quite a bit and the number meals being served is starting to drop off because the baby boomer population is looking for a different type of meal.

Staff noted two candidates have been selected for the aquatics upgrades. The enhancement projects have been split into two projects. Aquatic Design will be bringing Las Posas up to speed. Woodland Park is a challenging project and we are looking into opportunities to work with the SMUSD. For now Jeff Cats and Associates has been tasked with looking at several options for Woodland Park. The first option is to open Woodland with a safe and usable pool for the public, and the second option is to make it a competitive pool with a recreation component to meet the needs of the community and the school water sports programs. The other option is a grandiose design with a 50 meter pool and a fully enhanced recreational component including water slides. The design consultants will come to the Commission to give a report once they get further along.

Staff noted the budget process is in full swing and we have had some changes within the department pertaining to full time and part time employees. There have been changes based on the Obama Care policies and providing health care to staff who work more than a certain number of hours per pay period. Along with this, it changes the Pers and Pars retirement plans for employees. These changes will affect the budget as the expenses will be more but staff is happy to forecast a 14% increase in revenue by the end of the fiscal year.

Staff noted the Friends of San Marcos Park and Recreation will be reporting to the Commission at an upcoming meeting.

Staff noted Ron Vinluan is working hard on collecting information on the use of drones at parks and will report to the Commission in April.

Staff noted neighbors near Double Peak Park have brought to our attention an issue with people parking outside the gates of the park and causing problems including making noise late at night and disturbing the neighbors. Staff has involved the Sheriff's Department and other City departments to make a plan to change the dynamics and impact these issues. The Traffic Commission will also be changing some signage on Double Peak to help alleviate these issues.

Staff has evaluated the fencing at Connors Park and we have made some changes to the fencing so it directs any traffic around the park so no one jumps the park fencing.

Staff is hoping we don't get to a level 3 drought because we won't be able to water the 140,000 square feet of sod going in our parks this spring. Fields are being replaced at San Elijo, Las Posas, and Walnut Grove. We will evaluate if our wells can handle the watering.

Commissioner Maas asked if there is any opportunity to replace the turf with artificial turf? Staff noted there is a SB 47 issue with sports players ingesting the rubber material from the turf and there is increased cases of cancer happening with the players. California Parks and Recreation along with National Parks and Recreation Association are doing their own study to try and figure out their stance on this issue.

Commissioner Walter lives in the Discovery Hills area and the Rangers came by his house and went door to door to all the neighbors talking about the impact of the Trails Day event. Walter feels this gesture is great for the neighborhood and solves any issues before they start.

Commissioner Maas attended Trails Day and it was an awesome event. Maas also attended the San Marcos Alive event and it was also great. She said her favorite part was watching all the different dance demonstrations.

Commissioner Smith attended Trails Day and thought it was super fun. She was really impressed with the safety issues that were addressed. Some of the safety measures taken were water and snack stations along the hike, visors for people to wear if they forgot to bring one, and she thought having a hike leader follow each group of hikers to assist if needed was a great. She heard everyone saying how happy they were that all the trails are open and it helped give a feeling of closure to the fires.

Commissioner Towsley thanked staff for this informative report.

Commissioner Lindsay asked if Simmons Park is utilized as a sports field. Staff noted that currently it is not and we are dealing with this issue. Commissioner Lindsay noted it is a lesser known park and if the field is not officially utilized we could use it as we are short on field space. Staff noted we have had this discussion with Public Works and the grass planted is not a sports grass and we try to keep this park non-programmed so the public has an area to utilize without programmed sports using it. Commissioner Lindsay noted the park on Questhaven in San Elijo Hills has replaced all the grass and it is used basically as a practice field for sports groups. It may be better if it is controlled rather than non-controlled and if the City worked with the San Elijo Community Association maybe they could allocate and regulate the park. Staff noted if they wish to do that the City would work with them on scheduling the field for them.

Commissioner Lindsay commented that the Trails Day Event was a very well organized event. It had excellent promotion and the signage on the major streets was a help. One of the rangers counted over 120 people and it could certainly expand and grow over the years.

Commissioner Maas noted the City's Facebook page is very limited and she took some great photos of the event and was not able to post the pictures. Staff apologized and said the photos can be posted on the Friends of San Marcos Parks and Recreation Facebook page.

Chair Franklin thanked staff for keeping the Commissioners informed with his updates. Franklin noted CSUSM has a drone and is interested to see how this will work with the information Ron collects. Franklin is excited for our upcoming staff and commission meeting and suggested the Gymnasium for the location.

Park Flyer Definition

Park flyer models will weigh 2 pounds or less and be incapable of reaching speeds greater than 60 mph. They must be electric or rubber powered, or of any similar *quiet* means of propulsion. Models should be remotely controlled or flown with a control line, remain within the pilot's line of sight at all times, and always be flown safely by the operator.

Safe Operating Recommendations

- Inspect your model before every flight to make certain it is airworthy.
- Be aware of any other radio frequency user who may present an interference problem.
- Always be courteous and respectful of other users of your selected flight area.
- Choose an area clear of obstacles and large enough to safely accommodate your flying activity.
- Make certain this area is clear of friends and spectators prior to launching your aircraft.
- Be aware of other activities in the vicinity of your flight path that could cause potential conflict.
- Carefully plan your flight path prior to launch.
- Abide by any and all established AMA National Model Aircraft Safety Code.

Park Flyer Definition

A Park Flyer site can be either an outdoor or an indoor venue. When

flying at sites specifically designed for Park Flyers, the pilot will keep the model within the established flight boundaries of the field. Members need to take into consideration several factors, including piloting ability, weight, size, and speed of the Park Flyer model, to determine if a Park Flyer site is an appropriate venue for flying a particular model. The test should be, "Can I fly this model safely and quietly at this flying site?"
