James Daza recognized Dana Tucker who has worked for the City for over 12 years and has been a tremendous asset to our sports programs and specifically the softball program and the gymnasium office. Dana introduced pickle ball to our City about 6 years ago and it is a benefit to our community. James thanked Dana for his years of service.

Chair Franklin thanked Dana for being a trailblazer and starting pickle ball and said he was ahead of the trend.

Chair Franklin presented Dana Tucker with a recognition award for his years of service.

**REPORTS AND OTHER BUSINESS**

4. Mission 316 Church Extension

Sam Brummit noted he has been diligent in searching for other facilities including commercial sites and schools. Mission 316 has reached out into the community as much as they are able and they held a breakfast for the community where over 400 people showed up. In conjunction with other local churches they fed over 800 people on Thanksgiving Day. Sam noted we have 6-8 homeless folks who attend the church and they provide them resources. The churches biggest flagship is children and they started with 9 children in the church and with the Kids Unlimited Program they currently have 100 children that attend the church and classes such as dance and drama.

Sam noted they are still looking for their own space and they are grateful to the City for the use of the facility.

Chair Franklin asked what their membership is? Sam noted they started with 12 people and when they started at the Senior Center they had 60 people in the congregation and they have had crowds over 200 people.

5. State of Our Parks Capital Improvement Projects

Mike Edwards, Public Works Director noted the City has built many parks over the years and the Mayor and some others like to call the City "San Parkos" because of our many parks. Mike has been with the City almost 9 years and part of his job was to help build the parks. Mike wanted to bring it to the Commissions attention that we have put a lot of money into our City parks and the fiscal reality going forward is not so bright. Many of the funding sources we had before are not there or are drying up. Building new parks in the future will take a lot of creative thinking and creative budgeting and working together with the City personnel Commissions and Council.

Mike Edwards showed Commissioners an overview of the last 10 years park projects and the funding sources used to construct them.

Main funding sources include Public Facilities Fund (PPF) which is developer impact fees to construct residential or commercial projects. PPF fees totaled up to almost \$16 million over the past 10 years. Redevelopment Agency (RDA) which is no longer an active agency because the State eliminated them. The RDA funds covered \$23 million in park projects over the past 10 years.

PPF current balance of impact fees is -\$9 million and it will be a long time before we get back to zero the City borrowed from other developer impact categories like streets for example to fund parks. Parks will have to stand aside till we get new development in a few years from now.

The proposed budget will go to the Council next month and will project out 5 years for capital improvements. For park projects it represents \$15 million over the next 5 years versus \$48 million that was spent in the last 10 years. Proposed projects include Richmar Park, Bradley Park, San Marcos Creek Promenade, South Lake Park and Rancho Coronado Park.

San Marcos Creek Promenade is a almost \$5 million linear park project that will be in the downtown creek district. Creek District Promenade mixed use areas similar to a downtown area that includes residential and commercial properties with pocket parks located throughout. Interaction with creek will keep the area modern and mixed with natural park habitats and pedestrian bridges that will include bicycle lanes. This project including bridges and creek improvement will cost over \$70 million.

Chair Franklin asked if the developers of the Creek District will the developers fund the parks in their development? Mike noted with this mixed use development the phases take 20 – 30 years to unfold. Developer impact fees will be dedicating land and construction of parks they will contribute to the VFF fund.

South Lake Park current development plans are postponed until further research can be done. The lake itself and most of the land belongs to Vallecitos Water District. The City has the option to lease the land long term. Vallecitos as a cooperating water agency is participating in a very large study to look at how to prepare for extended droughts or future droughts. They are looking primarily at potable re-use water which is a minor but to use very important potential role in how the water agencies might store the potable re-use water. South Lake is being evaluated in this broad study and South Lake could potentially store this water in the winter and then reused primarily for landscape use in the summer.

This means that the lake level would go up to increase the water storage and the damn would need to be improved and raised. If this happens it will inundate all the improvements that we envisioned along the border of the lake.

Rancho Coronado Park which is the old Hanson Quarry area will be a more active use park with sports fields and all kinds of potential uses. Build out of this park is roughly a \$30-40 million dollar park. The park can't happen until the developers purchase land to develop. The developers will bring in the infrastructure like utilities and storm water and roads. The City has first rights of refusal on this park site so it is dedicated to us at no charge.

Commissioner Walter remembers a year ago there was an update on the budget for Coronado Park and he thought \$12 million was set aside. Mike said he doesn't recall but we have had money in the park budget for a while now and he recalls about \$8 million.

Vice-Chair Lindsay asked if the funds for South Lake and Rancho Coronado was an internal decision to allocate the funds that way? Mike noted those amounts were based on the discussion through many City Directors and those decisions are recommendations to the City Council.

Chair Franklin attended a Vallecitos Water Education day about a year ago and South Lake was never part of the discussion of holding or storing potable water so that's cool and maybe now we can stock the lake with fish.

Commissioner Crain noted with the RDA funds being taken away is their not a new entity that is similar to RDA? Mike noted they have a Independent Oversight Board and is made up of appointed San Marcos residents and they are in charge of dissolving the assets of the former agency.

Commissioner Franklin reported that the meeting went well as presented to the Commission. Councilmember Jenkins was inquiring about the pickle-ball courts so it was nice to report we have that in the works.

8. PAWS with Friends Event April 25<sup>th</sup>

Holly Malan, Community Services Assistant Director, reported on the Friends of San Marcos fundraiser event and even though it was awfully cold, blustery and rainy weather they managed to raise \$2,500. The people who participated had fun and staff wants to recognize Lori Elder for her work on this event. The event had 40 vendors and a food truck and lots of fun activities for dogs. The event may be held in June next year.

**CURRENT PARK PROJECTS**

1. Richmar Park

Isaac Etchamendy noted Richmar Park is one of the parks that will be moving forward very shortly because we were awarded a housing related grant for \$1.4 million. Isaac explained we will use the grant fund to pay for the construction of phase 1 of Richmar Park. We are currently in the process of selecting a designer and as of Friday interviews were finished. We have tentatively entered into negotiations with Schmidt Design Group from San Diego. The park design is anticipated to be complete by December of this year. The park design will go out to bid and be in construction the first quarter of next year. The design will have two alternatives which will keep the master plan design and make some tweaks including a water conscious landscape, park phasing plan, and what amenities of what will be included in the park at what phase.

Commissioner Franklin asked if a pickle ball court could be included in the plans. Isaac noted we have had discussions with the design consultants to use the space in creative ways which would include hard courts like pickle ball. Chair Franklin asked if we know what will happen to the playground equipment at the Senior Center to alleviate children running across the street to when they see the playground. Isaac noted Richmar Park will have a 3-5 and 5-12 playground. Staff is evaluating what we will replace the current playground equipment at the Senior Center.

Commissioner Lindsay asked how much detail goes into choosing the play amenities that goes in at the park. Isaac noted we want a lot of use out of the park so we do look into this and the design consultants are professionals in this area as well as Community Services has a wealth of knowledge as to what equipment gets used.

Chair Franklin asked when the grant was awarded? Isaac noted it was awarded in September and the City finalized an agreement with the state in December.

Commissioner Lindsay asked if the Post Office plays any role in supporting us or what the status of the parking lot is? Isaac noted when we purchased the property we inherited the parking lot with the Post Office agreement. We take in ground lease revenues for the parking lot and at the end of last year the agreement came up for renewal. At that time the Post Office agreed to enter into a joint use agreement with us. We may reconfigure the parking lot area if it makes sense with the park plan.

**2. Simmons Park**

Staff noted a community member asked the Commission about addressing the capacity of special event permits for Simmons Park. Staff noted we discussed this issue with the other City departments including Housing and Neighborhood Services and parking enforcement. The park has 13 parking spaces and this was adequate when the small neighborhood park was built. The design of the community is larger homes with the ability to park 3 cars in the driveway plus 3 cars in the garage. There should be plenty of street parking because of this neighborhood design. What we feel is fair for the park users and the neighborhood is a capacity of 100 people to utilize the picnic facilities.

Commissioner Maas asked how many times do we get a request for 100-200 people. Regina Williams noted we have never had a request for 200 people and the majority of reservations have 50-75 people maximum. A capacity of 100 people is fair and adequate for this picnic shelter.

The Commissioners concurred that lowering the maximum capacity to 100 is a fair and valid amount of people for the park picnic area.

**ORAL COMMUNICATIONS**

Report from the Community Services Director:

Staff thanked the Commissioner for assisting with the Fourth of July fundraising efforts. The letters have been mailed out and we are excited to get the community involved in this event. Polyester Express will be providing the music for the event this year.

The Rock and Blues event is coming up June 5 & 6 which will be an awesome event once again and the Friends of San Marcos is involved in promoting the adult refreshment area to help support the parks.

Summer Concerts in the Parks is off and running and the next concert is June 27<sup>th</sup> Incendio will play exotic world fusion music.

Staff noted CPRS is supporting the SB317 bill for a park bond for \$500 million and is a per capita bond that all the parks and community services departments throughout the state are supporting. We also need Commissioners support so staff will email information about the bill.

Commissioner Crain noted he has heard from multiple families that there are disturbances at Connor's Park and an issue with being able to use the areas they have paid for. Crain would like staff to limit access for the safety of the kids utilizing the facility or reducing the fees to acknowledge the fact that the general public is using the facility during reserved times.

Commissioner Smith thanked staff for their presentations and work on the Master Plan and encouraged all Commissioners to attend the next meeting.

Commissioner Lindsay also encouraged everyone to attend next Master Plan meeting at the Community Center on June 23<sup>rd</sup>.

Chair Franklin asked Commissioners to contribute to the fireworks fund to help us pay for what everyone assumes is a free fireworks show. Chair Franklin encourages Commissioners to invite a friend or neighbor to contribute.

**Call to order**

James Daza called the Youth Sports council meeting to order at 6:03pm.

**Approval of Minutes**

Jason Simmons (FC Sol) motioned to approve the modified minutes from the May 5, 2015 meeting. Scott Yeaman (SMYS) seconded the motion.

Motion carried 6-0.

**San Marcos Unified School District**

Martin Leon was present to inform the YSC about future projects that will take place at some of the school fields. He noted that the school district is in the process of installing a well at San Elijo Middle School, but that construction will not affect the soccer field usage. He also explained that there will not be any construction this summer at San Marcos Middle School or Alvin Dunn Elementary. However they are planning projects for the summer of 2016.

**City of San Marcos Parks Update**

Art Sotelo was not present at the meeting; however he provided a schedule of all field closures/maintenance for the month of June. (See attached)

**YSC Participation Numbers Due Date**

Jason Simmons is proposing to find a more suitable due date for the YSC members to submit their participation numbers in order for the field allocations to better represent finalized registration numbers. The fall season collection date is the third Monday in June. This date does not allow the fall groups to give their finalized numbers because they still accept late registrations leading up to the start of the season. Wayne Marking suggested that we use the previous year's finalized numbers for the allocation. He also

believes the same process should be used for the spring season to keep consistency. He suggested to set the date similar to the billing dates for the per player fees.

### **YSC Minimum Number Requirement**

Jason Simmons believes the YSC should set a minimum number of participants for youth sports groups to become members of the YSC. He suggested a minimum number around 100 is reasonable. Wayne Marking asked if there was already a minimum number to maintain membership in the YSC. He suggested setting a number to maintain full membership status. He gave an example of a new group coming in with 70-80 participants but a member group may be below that number. Should the member group be allowed to be in good standing? Wayne also suggested that if a member drops below the minimum number that is set that they will be placed on two year probation, or something similar. Lori Schultz questioned if the minimum number should be different for each sport, because sports like basketball have less players per team. James Daza told the council that the city has been approached by basketball and baseball clubs with only a few teams that are looking for field space. James explained that based on previous research, the majority of cities have a minimum number set between 100-150 participants.

### **Storage Containers**

James gave an update about the large storage containers that are currently in the parks. He explained at the last meeting that Public Works is deciding on one color that will be easily accessible to obtain as the containers need painting. More information to follow on this.

### **Final Thoughts**

James reminded the council that the Triple Crown Sports tournament will be held in July and the city has not received any interest from the YSC members about operating the snack bar and doing the field prep.

Lori Schultz wanted to know if the Chamber of Commerce or the City had an email database for restaurants in San Marcos. She said that from the FC Sol tournament and the Girls Softball tournament that restaurants were under staffed or sold out of food because they were not aware of the tournaments. The Chamber has a contact list of just Chamber members and the city does not maintain such a list. Pre-tourney contact by youth sports group leaders with the restaurants is suggested to help alleviate this problem and to possibly arrange a percentage monetary deal if their restaurant is promoted to tournament attendees.

Wayne Marking asked James if he was able to get in contact with the City of Carlsbad regarding the Friday Night Lights football group that has been using San Elijo fields. James said he found out that Carlsbad rents fields to Friday Night Lights and it is not a program run by the City of Carlsbad.

Next regularly scheduled meeting will be Tues, September 1 @ 6pm. Meeting adjourned at 7:05pm.

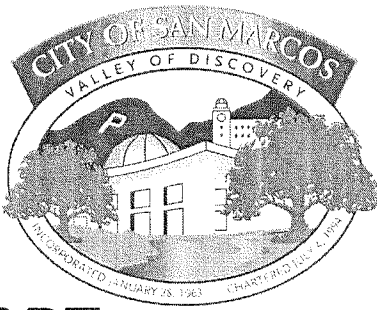

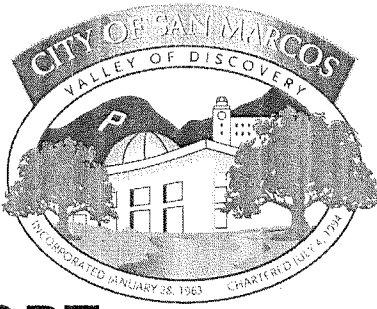

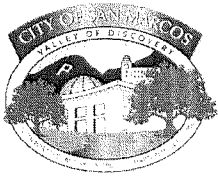

Align pricing structure to coincide with Exclusive per person rates. Add Seasonal Registration cost to coincide with increased registration need of Open Recreational Swim.



#### *Non-Exclusive Facility Use Price Adjustment*

Align pricing structure to coincide with Exclusive per person rates. Waive Registration fee for groups.

#### *Membership Swim Price Adjustment*

Align pricing structure to coincide with traditional “breakeven” for a Family of 5 at 10 visits.

#### *Swim Lesson Price Adjustment*

Equalize weekend and weekend lesson pricing.

#### **Fiscal Impact**

Fee increases for 2015 are outlined in the Summer 2015 Fee Recommendation Attachment. Adjustment to all Aquatics programming costs is highly recommended. Last fee increase for Exclusive and Non-Exclusive Pool Use and Open Recreational Swim was implemented in the summer of 1999. All positive revenue potential seen over 1999-2014 operating period has been absorbed by increasing operational expenses such as wage increases, chemical costs, etc...
