**AN APPLICANT'S GUIDE
TO PROCEDURES FOR:**

**NEW STREET NAME
SUBMITTAL POLICY**

Prior to the submission of a final map or prior to approval of any plan containing any new streets, the developer or engineer of the project shall adhere to the following guidelines when submitting proposed names of all new streets to the Engineering Division.

1. It is the responsibility of the party submitting street names to research the most current street maps (**i.e., Thomas Guide, Chamber of Commerce, City street name list**) to avoid potential name conflict with existing street names. This will prevent unnecessary delays in approval of the proposed street names.

Examples of potential street name conflicts include:

- a) names which are identical or are very similar to existing names within the city limits and within a 7 mile radius from the city limits;
- b) very similar names which may include those streets that differ only in delineator or those which sound very close (e.g., Long Way & Wrong Way; Short Ave., and Short Drive);
- c) names longer than three (3) words OR 15 letters including delineator (e.g., Too Many Words Court & Caminito de los banos);
- d) Spanish names which may be too easily misread or hard to pronounce (e.g., Caminito Avenida Callajon). The post office doesn't approve any names that start with Camino, Corte, Calle, Avenida, or Via.

Spanish translations are as follows:

Calle or Caminito = Street
Camino = Major Street

2. Miscellaneous Delineator definitions:

North-South orientation = Drive or Street;
East-West orientation = Road or Avenue;
Cul-de-Sac or Dead End = Court, Place, or Way
Short Street (less than 150 ft.) = Lane or Terrace

3. Three street name choices for each street shall be submitted in the space provided on the attached form (additional forms may be needed), with an attached 8-1/2" x 11" map sheet clearly highlighting the new street(s); preferably, the map sheet should be a copy of the index map from an appropriate title sheet, including nearest major cross street; a vicinity map on the same sheet may be necessary to locate a major intersection.

4. **Five stapled sets of the requirements** as outlined in 1., 2., & 3. above shall be submitted for distribution to:

These five sets shall be concurrently reviewed by the Street Naming Committee which is made up of the following local agencies: Post Office, City's Building Division, and the City's Fire and Public Works Departments.

5. Upon review and approval by the Street Naming Committee, the developer or engineer shall be so notified within ten (10) working days by the Engineering Division.

THE APPROVAL WILL BE OFFICIAL AFTER THE ENGINEERING DIVISION HAS RECEIVED 30 PRE-ADDRESSED/PRE-STAMPED BUSINESS ENVELOPES (NO. 10 SIZE) WITH MAPS NECESSARY TO NOTIFY THE APPROPRIATE AGENCIES AND BUSINESSES OF THE NEW STREET NAME(S).**

** if it is meter stamp, please eliminate the mailing date on the stamp.

The list of appropriate agencies to be notified is attached.

6. Street Address number(s) shall be assigned by the Building Division upon issuance of building permit(s). The Building Division shall notify the appropriate agencies of the "100 block" assignment.

PLEASE NOTE: Three street name choices for each street means three different proper names and NOT one proper name with three different delineators.
