**CERTIFICATE OF CORRECTION
PROCEDURE**

1. The Engineer of submittal shall use the attached certificate as a guideline.
2. The list of corrections for each item shall include the following:
 - a. description of the action taken to correct the problem
 - b. what was originally shown on the map (or record of survey), and
 - c. the reason for the correction.

NOTE: The upper right space shall be left blank for use by the County Recorder.

3. The Certificate of Correction shall be submitted to the City Engineer for approval.
4. The processing fee is \$250.00.
5. After recording, the original document will be filed in the City Clerk's Office of the City of San Marcos. A conformed copy will be sent to the Engineer of submittal.
6. At the request of the County, the City shall furnish the County with copies of all recorded Certificates of Correction. Copies should be sent to the County Department of Public Works.
