**CONSENT CALENDAR****1. APPROVAL OF MINUTES – January 19, 2016****PUBLIC HEARINGS****2. Case No: P16-0003 (Text Amendment TA16-001)****Applicant:** City of San Marcos

**Request:** The Planning Commission of the City of San Marcos will consider ratifying existing medical marijuana regulations under San Marcos Municipal Code Chapter (SMMC) 5.54. The Planning Commission will further consider recommending that the City Council adopt an ordinance amending Section 20.205.030(D) (Prohibited Uses) of the Zoning Ordinance to expressly prohibit marijuana cultivation as a prohibited use in all zones within the City of San Marcos; Section 20.600.030 ("M" Definitions) of the Zoning Ordinance to add the definition of "marijuana cultivation (land use)" as defined in SMMC Chapter 5.54; and to amend Section 20.600.030 ("A" Definitions) of the Zoning Ordinance to expressly preclude marijuana cultivation from the definition of "agricultural/horticultural (land use)" as a permitted use in certain zones. The Planning Commission will consider recommending approval of the ordinances by way of interim urgency pursuant to Government Code Section 65858, urgency pursuant to Government Code 36937, and in regular course in compliance with the requirement for local agencies to adopt regulations governing marijuana cultivation under the Medical Marijuana Regulation and Safety Act.

**Categorical Exemption Class:** 15378, this is not a project within the meaning of Section 15378 of the California Environmental Quality Act (CEQA) Guidelines because there is no potential for it to result in a physical change in the environment, either directly or indirectly. In the event this is found to be a project subject to CEQA, it is exempt from CEQA pursuant to the exemption contained in CEQA Guidelines Section 15061(b)(3) because it can be seen with certainty that there is no possibility of a significant effect on the environment.
