ORAL COMMUNICATIONS

Becky Garret, a San Marcos resident for over forty years, is requesting the Commission consider building or dedicating pickle ball courts for a growing pickle ball community in San Marcos. Presently, Becky is a member of a pickle ball group in the City of Oceanside and plays at Melba Bishop Recreation Center. Their most recent event had over 200 players participate with equally as many family and friends attending; large scale competitions draw sponsorships, vendors, and travelers that infuse local economies. Cities from Oceanside, CA to St. George, Utah have been successful in drawing a thriving pickle ball community that benefits the community in many ways. If building new pickle ball courts isn't possible then converting tennis courts could work, as four pickle ball courts fit onto one existing tennis court. Presently, San Marcos has some courts available, but because they are multi-use courts there tends to be conflict with other sports users. Garrett invited commissioners to come out and play anytime.

Commissioner Franklin commented that pickle ball is something he himself has been bringing up as an item of discussion for some years and is supportive of the pickle ball community; he would also like for the City to keep pickle ball as a sport in mind for future projects.

REPORTS AND OTHER BUSINESS

1. **AYSO 127 ANNUAL REPORT.** Michelle Morgan handles multiple roles as team manager, and thanked Commissioners for their time and participation in the community, especially the establishment of the Youth Sports Council. In 2015, they were able to distribute 67 scholarships for children who would be unable to afford and participate in activities with full or partial funding that comes from registration fees and team sponsorships. They are also thankful to have field use for their core season at Las Posas Park and are impressed with the field and grass improvements. The organization services all ages beginning at age 5, hosting separate boys/girls teams. The All Star tournament was held at Walnut Grove Park this year, resulting in a great opportunity to connect participants from all over the county with local businesses. The Arena Program, a co-ed Saturday program that keeps children active during regularly scheduled seasons held at Bradley Park, had record participation this year with over 180 kids registered. The Matrix program is more competitive and has various teams who have achieved championship level. They also offer a Spring Skills activity that allows children in the 4-12 age range to learn basic soccer skills for those with little or no experience. The 2015 season they had many assistant referees for 12+ involved in the Junior Referee program which was helpful in staffing the variety of their programs.

Commissioner Towsley asked her to provide feedback about Las Posas parks, to which Michelle replied the grass is better maintained and the aerator helps fill in the pot holes on the fields which makes it safer to play on. She also noted the area with lights and the sprinklers have been improved to prevent flooding and muddy areas.

Commissioner Franklin thanked her for the presentation and asked how the scholarships are issued. Morgan replied that the decision making criteria varies, based on the reasoning for their request and commitment level. An application form is submitted, asking for basic contact information and a reason for the request, and all funds are distributed to children who would be unable to afford registration fees.

2. **SM RUGBY ANNUAL REPORT.** Barry Zeait introduced himself to the commissioners and presented how the varsity and junior varsity teams have grown in the community. Rugby is the most profitable and equitable sport in the world since there are minimal costs of equipment and the game can be played almost anywhere. Rugby also creates a sense of family, and has an international element, as every team promotes diversity and includes children that may not be great at football but want to play outdoors, and also varies in age groups. Connors Park is a great location in the middle of a diverse community and San Marcos has gained a lot of participation over the years. This year, Rugby will be played at the Olympics in Rio De Janero, Brazil, which has provided the sport with even more exposure in the United States. 58 players (from both High schools) in San Marcos presently participate in rugby, but due to a lack of coaches the amount of teams allowed are maxed out. Next year, the goal is to gain an additional 100 participants to include a girl's team. There is a high demand in this community, so with more safety-oriented coaches this should be achievable. North County Rugby Inc. supports the local club with fundraisers, concessions, and various fees gathered. They need advocates and

participation from High Schools and Athletic Directors, to promote not only participation but use of fields. Sportsmanship, friendship, respect, and a sense of family are some values taught through the sport, and Zeait commented that San Marcos should be proud of having such strong supporters of Rugby.

Commissioner Franklin thanked Zeait for providing such an awesome service with a great benefit and demand in San Marcos. And asked what their strategy is to attract more interest. Zeait feels the amount of feedback and requests they are presently receiving the participation levels will rise with the addition of coaches to the organization. Field allocation doesn't seem to be an issue presently and will continue working with the City to fit in where allowable.

Maas complimented the efforts of Zeait to personally organize and improve the rugby presence in San Marcos and is wondering what other communities have structured teams that are able to compete on the championship level. Zeait replied that LCC in Carlsbad, Torrey Pines, Del Norte, San Pasqual, Fallbrook, Alta Vista, and Mission Vista all have championship level team and are supported by communities that have set a precedence for the sport in North County; the structure is there for San Marcos to raise their division and stay competitive. Commissioner Maas asked about fees involved- the kids pay registration fees, and there is a possibility to allocate grant funds through an afterschool program that allows more children to participate and try to support all kids who are interested regardless of affordability. Zeait would like to see the organization self-sustain should grant funding cease, and is brainstorming on ways to make rugby programs available to all children interested in participating.

Crain asked about U.S. Rugby as a national youth organization, and how the licensing is structured. Zeait replied there is an under 20's league that has stringent rules, concussion and injury training for officials, skill building and safety standards that require the passing of three courses to be an official. The High School academic calendar prevents the league from receiving CIF endorsement, which prevents them from operating above the club level, but as support grows with school officials other levels within the U.S. Rugby Association can be considered.

Martin noted that the membership process to join the Youth Sports Council requires a waiting period, of which SM Rugby is 2.5 years into, and that this is the third year San Marcos has hosted the California State Games, which is occurring this year July 16-17 at Walnut Grove Park; where boys and girls of the 'Rugby 7's' group, part of the Olympic movement, travel in from all over California.

Commissioner Crain asked about revenue generation of that event, to which Martin replied the group follows standard Special Events permitting through City Hall (which has fees involved) but funds generated from concessions will be donated to the Friends of San Marcos Parks & Recreation non-profit organization. TOT and other associated taxes will also generate revenues for the City of San Marcos with the amount of people travelling in for the event.

3. **PARK RANGER ANNUAL REPORT.** PowerPoint presentation shown. Park Ranger Supervisor Ron Vinluan reminded the Commissioners that there are over 60 miles of trails and over 30 parks in San Marcos. The hiring of two part-time rangers to enforce municipal codes including smoking, trespassing, etc. has been very helpful and reduced conflict at the parks. Rangers and volunteers are also trained to approach park shelter reservations in a customer service friendly manner to make sure their paid reservation are posted clearly and they haven't experienced any issues with the reservation process. Rangers will be making library presentations in the spring, which is a great way to engage the



community. New hire Kylee Ah Choy, Park Interpretive Specialist at Jack's Pond Nature Center, has her BA in Biology, with an interest in conservation and environmental education.

With Ah Choy on staff, it is possible for a City representative to provide reach-out directly to schools if they are unable to receive field trip permissions.

Ah Choy introduced herself to the commissioners and has intentions to attend the monthly hikes offered through Community Services. In 2016, 19 hikes were offered, with an average of 53 participants per event, and a Halloween event at the Nature Center was a popular new addition to the calendar. This year is the 25th Annual Celebration of "Trails Day", to be held on March 5 at Lakeview Park, so participation is expected to increase over the 155 people in attendance during 2015. Volunteers and docents at the Nature Center are reliable and helpful, with a total of 159 hours logged-in, during 17 public/private visitations, and 25 school or club field trips offered. The Nature Center is open on Saturdays and Sundays from 10am -1pm free to the public, with the goal of being an educational center that is noteworthy in North County San Diego. In addition to Junior Ranger and Eagle Scout projects, that include plant identification, activities are increasing to reach-out to public and community. Volunteers have increased the coverage of trails and overall park presence deters destructive activity in parks. Rattle snake safety is a presentation on April 23 that all the commissioners are invited to if interested in meeting rangers and volunteers.

A notable project is the North Coast Church, which volunteered their time to paint the corral, spread angle rock at the community garden to stop erosion, and installed countertops in the Nature Center. On a regular basis, The River Church spreads mulch at the aqueduct and sweeps along the Double Peak trail. Ron is staff liaison for the Trails Advisory Committee, whose priority is to identify missing links in the trails system and helping the City prioritize these projects. Ron complimented all the volunteers on being passionate and committed to the parks and trail systems, some individuals have been consistently volunteering their time for over 20 years.

Commissioner Franklin asked how the River Church became involved in these activities, to which Ron replied they contacted the department and were interested in volunteer opportunities, as many individuals and organizations are. Franklin also welcomed Ah Choy and referred to her biography in the report, and asked about her interest in the environment, to which Kylee replied that she is not afraid to get 'dirty' and her favorite native species is the California Condor; not afraid to handle 'scat' on trails and is excited to show to youth all aspects of nature, including those that other people don't usually discuss.

Commissioner Lindsay complimented the Park Ranger team, and also acknowledged the San Marcos Amateur Radio Club and their efforts as well.

Commissioner Crain asked the minimum age to volunteer, which is 18.

Commissioner Maas complimented Vinluan on an amazing job regarding recruitment and volunteerism, and is wondering how this can be increased. Rangers reach out to CSUSM, attending events at various schools, and advertising in the 360 magazine, but mostly word of mouth is how volunteers are generated. Maas wonders if there are other ways to provide info and exposure, to which Vinluan replied they are planning on attending more events and identifying sources of marketing distribution. Ah Choy was asked to address the May 2015 break-in, of which items such as pelts, toys, stuffed birds and other items were stolen. A grant has been submitted to the SM Foundation to replace these items, of which Martin will email the commissioners of the outcome.



4. TRAILS ADVISORY COMMITTEE (TAC).

COMMISSIONER TOWSLEY reported there is a 10k run/hike scheduled in early October, which will be staged at San Elijo Park and gain over 1,000' of elevation up to Double Peak Park. Professional event planners have been hired, named "Sandy Feet", so the participation levels are expected to be

significant. The Friends of San Marcos are planning the annual "PAWS with Friends" event scheduled in June, which is a fundraiser featuring dog agility competition, vendors, and dock-diving. Towsley noted since it is a two-day event, it will be the first time the City has authorized overnight parking, so this is something to be aware of as it could set a precedence. Also, it is important the revenue generated by the overnight parking fees are used for park improvements since that is where all the wear and tear occurs. The Silver anniversary of "Trails Day" is March 5, check-in at 8:30am, and encourages commissioner participation. Other topics at the meeting were the Highlands Park project, trail 35, and connecting missing links throughout the trails system. The next TAC meeting is scheduled for Wednesday, March 2, 6:30pm at the Community Services meeting room.

- 5. YOUTH SPORTS COUNCIL (YSC) report, COMMISSIONER CRAIN** commented that the meeting went well, speaking on topics such as soccer arena scheduling, baseball laser leveling at Mission Sports Park fields, and the replacement/repair of the lights at Hollandia Park, and soccer groups are working together to get a calendar for field use. Youth Sports Banner and Insurance Liability applications/forms are due, RPS will be handling the maintenance of concession areas, and FC Sol announced a name change to "San Marcos United".

COMMISSIONER AND STAFF COMMENTARY

Report from the Community Services Director

Martin thanked the pickle ball representatives for coming to the meeting, as this is a subject that has also come up in the Master Plan. With a fast-growing demand, pickle ball is something the department is meeting with the school district to inventory tennis courts and the possibility of converting some underused tennis courts to pickle ball courts. Martin encouraged commissioners to visit the website usapb.com to learn more about the pickle ball community.

He also feels that the multi-use area of Connor's Park could be better utilized as details and priorities of the Master Plan unfolds, of which he will give an update at the March meeting. An RFP has been issued to hire a consultant to bring together the final components of the Parks Master Plan.

With regard to Aquatics, a partnership is being considered with SMUSD to accommodate needs of the general public and school children. At Woodland Park pool, ADA compliance is a challenge, so if a joint-agreement cannot be reached with the school district, basic updates will proceed but no major changes to pool design are likely. The City Manager and SMUSD Superintendents are working closely to ensure the needs of pools users are achieved in a timely manner.

The Mayor's State of the City address, hosted by the Chamber of Commerce, is 2/23/2016.

An RFP has been issued to hire a new provider of the Senior Center lunch program.

Commissioner Mockus asked about the grass replaced at Civic Center, which is drought-friendly. Martin explained that grants covered much of the cost to plant 'swale' grass, which can go up to a month without watering once established, uses 50% less water on a regular basis, and requires less maintenance/grooming. This type of grass only needs mowing eight times a year, but is not athletic-field friendly due to resulting mounds and gaps. Park Operations is evaluating a grass-type called "Bandera" that could possibly be used on athletic fields but requires an initial watering that exceeds



drought restrictions. Until the State of California drought restrictions are lifted by the Governor's office, the City is keeping splash pads turned off, especially since well water cannot be used as children could ingest the water during play.

Commissioner Lindsay appreciated the map provided by Martin, indicating the footprint of development occurring near South Lake, and asked if there is still an opportunity to have the developer absorb costs of raising the park pad by grading areas where construction is taking place. For instance, in previous versions of this project there were areas around the dam and that would need to be graded and raised; Lindsay is asking whether there is any opportunity for the developers to pre-grade these areas, which would reduce City costs in the future as parks/trails development occurs while integrating the private development to public lands. Martin replied that there have been many redesigns of the area, as Vallecitos Water District had planned to raise the height of dam but that project is presently on hold. When the financial component of the Master Plan is completed, trails connectivity and park costs will be addressed. When Martin took office nearly four years ago, the Engineering department had informed him that the Parks Facility Fees (PFF) had a 13 million dollar deficit which the department has worked to reduce to a 6 million dollar deficit at present; with the new Master Plan, PFF's will be updated for the first time since 2009. With regard to the area around the dam Lindsay is referring to, the costs to grade the pad alone will be in the \$ 9-12 million range. Increased PFFs, sponsorship opportunity, and bonds are all options being considered in the updated Master Plan to find alternative funding that will cover costs of new parks and trail connectivity. Martin is of the opinion that major development of the area around South Lake will not be addressed for quite a few more years as research in the Master Plan update be considered; but there will likely be some development of the trails over the next two years. Amenities discussed in the past, such as fishing docks and other 'bells and whistles' may have to wait for the planning and integration of the yet unnamed park.

Commissioner Lindsay complimented Martin on obtaining the map and appreciated the update; he feels the tentative plans look good and perhaps additional signage in the area could prevent confusion when locating existing trails. Lindsay

Martin complimented Ranger Vinluan on his involvement with the parks, trails, and his work with GIS and the TAC to prioritize requests and has been a great asset in planning meetings. Martin will also reach out to the communications department and try to get more signage in the area to indicate that trails are accessible in around the lake area. Another topic the communications office could address is the swale grass replacement in front of City Hall, as this would be a great opportunity to use social media outlets. Mockus would like to see areas of some non-walking areas of all parks use swale grass and is looking forward to seeing it's heartiness over time.

Commissioner commentary

Commissioner Maas asked how many pickle ball courts are necessary for a tournament. Martin noted that eight is enough, but twelve would really make the event notable in that community.

Martin is meeting tomorrow with and SMUSD operations representatives to enhance joint efforts with regard to not only park and athletic facilities, but the pools. Martin noted that improvements to aquatic facilities are top priority and involvement of the school districts is vital.

Commissioner Towsley asked about the caretaker house at Bradley Park, which is presently empty, and there are plans to have it removed. Towsley complimented the painting of the storage sheds at Bradley Park and is wondering if new paint could be applied to the football goal posts.

2015 COMMUNITY SERVICES SPORTS REPORT

BACKGROUND:

The F.H. "Corky" Smith Gymnasium is a 26,000 square foot facility that offers three regulation size basketball courts and a multipurpose room. The City sports division is located at the city gymnasium. The name Courts & Sports represents our official community sports office.

We currently have eight part-time clerk aides and two full-time sports coordinators under my supervision.

The city gymnasium serves as home base for our youth and adult sports programs throughout the calendar year. City adult league team registrations and many of the resident youth individual registrations are held at Courts & Sports.

Youth and adult sports groups are able to take advantage of our nearly year round ball fields at the following city parks: Bradley Park, Mission Sports Park, Cerro de Las Posas Park, San Elijo Park, Walnut Grove Park, Hollandia Park, Sunset Park and Connors Park.

All resident youth leagues need additional field space in which to effectively administer their programs for both practice and game facilities. Our department, in conjunction with San Marcos Unified School District and Palomar College assists in this fair and equitable field allocation for resident youth programs.

YOUTH SPORTS:

LEAGUES / PROGRAMS:

In 2013, we established the San Marcos Youth Sports Council (YSC) and the YSC policy and procedures manual to assist in the field allocation process. Even though we faced some challenges in 2015, the YSC has helped establish guidelines for all new groups and give each YSC member a forum to discuss possible improvements.

We have a total of nine active youth sports organizations and two associates members that comprise our YSC and offer local non-profit community programming. The YSC field allocations are divided into two seasons Spring / Summer (February-July) priority sports include baseball, softball, and lacrosse. The Fall / Winter (August-January) priority sports are soccer, football and rugby.

SPRING / SUMMER RESIDENT GROUPS

SAN MARCOS YOUTH BASEBALL (YSC MEMBER): January - June

SMYB has access to city and school fields. Practices start in January with games played February - June. Official game field locations include: Mission Sports Park, San Marcos Middle School, Bradley Park, San Elijo Park and Hollandia Park. The program consists of over 1,000 participants.

SAN MARCOS GIRLS SOFTBALL (YSC MEMBER): January - June

SMGS has access to city and school fields. Practices start in January with games played February - June. Official game field locations include: Bradley Park, San Elijo Park and Cerro de Las Posas Park. The program consists of over 300 participants.

SAN MARCOS LACROSSE/PROPEL (YSC MEMBER): January - June

LACROSSE has access to city and school fields. Practices start in February and games are played March - May. Official game field locations include: San Elijo Park, San Elijo Middle and Elementary Schools. The program consisted of 150 + participants.

SPRING / SUMMER ARENA RESIDENT GROUPS

AYSO spring 2015 arena program had over 150 total participants. They use Bradley soccer arena.

SPRING / SUMMER RESIDENT GROUPS

SMYS spring 2015 arena program had over 950 total participants. They use both Bradley and Sunset Park soccer arenas.

FALL / WINTER RESIDENT GROUPS

SAN MARCOS AYSO and 127 Matrix (YSC MEMBER): July - December

SM AYSO has access to city and school fields. Practices start in August and games are played August - November. Official game field locations include: Walnut Grove, Cerro de Las Posas, Hollandia, Connors, SMMS and Palomar College. The program consisted of approx. 500-600 participants.

SAN MARCOS YOUTH SOCCER and REVOLUTION (YSC MEMBER): July - December

SMYS has access to city and school fields. Practices start in August and games are played August - November. Official game field locations include: Walnut Grove Park, Cerro de Las Posas, Hollandia, Connors, SMMS and Palomar College. The program consisted of approx. 1,800-1,900 participants.

SAN ELIJO AYSO AND 1505 Matrix (YSC MEMBER): July - December

SE AYSO has access to city and school fields. Practices start in July and games are played August - November. Official game field locations include: San Elijo Park, Connors, San Elijo Middle and Elementary Schools. The program consisted of 900 –1,000 participants.

SAN MARCOS FC SOL (YSC MEMBER): July - December

FC Sol has access to city and school fields. Practices are year round and games are played August - November. Official game field locations include: San Elijo Park, San Elijo Middle and Elementary Schools. The club had 220 total participants that formed 15 Club soccer teams and a Rec. development program for kids on Friday nights.

SAN MARCOS POP WARNER (YSC MEMBER): July - December

SM Pop Warner has access to city and school fields. Practices start in July and games are played August - November. Official game field locations include: **SMHS, MHHS**, Bradley Park and Hollandia Park. The program consists of over 300-450 players /cheerleaders.

SAN MARCOS YOUTH BASKETBALL (YSC MEMBER): November - February

SMYBB has full access to the gymnasium weekdays from 4pm to closing. Practices start November and games are played December - February. Games are played Monday, Tuesday, Thursday, Saturday's. The program consists of 1000 + participants.

SMYBB SHOOTING STARS: November - January

The Shooting Stars program is organized through SMYBB with play on Sunday afternoon. This program is for all special needs youth with able body youth assisting along side. Program consisted of 130 youth participants.

SAN MARCOS YOUTH RUGBY (ASSOCIATE MEMBER):

SM rugby has access to city and school fields. Practices start in November and games are played February - April. Official game field locations include: Connors, SMMS and Walnut Grove. The program consists of over 50 players.

NFL FLAG (ASSOCIATE MEMBER):

NFL Flag has access to city and school fields. Practices start in February and games are played March - May. Official game field locations include: Hollandia and Walnut Grove Park. The program consists of over 250 players.

COASTAL ELITE BASKETBALL: March - May & September - November

Coastal Elite Basketball League is a club program / league, held twice during the year. The program includes 5th, 6th 7th & 8th Grade Divisions. Practices are held on weekdays with games played on Friday evenings at the city gymnasium.

YOUTH TOURNAMENT SPORTS GUIDE

Created in 2014, the guide provides out of town tournament participants information regarding fields, local hotels, restaurants and things to do.

SOFTBALL:**2015 TEAM TOTALS****COED 117 Teams MEN'S 194 Teams = 311 TOTAL TEAMS****Average 103 Teams per season**

Our sports department hires and trains all of our softball officials. Over 30 part-time game officials are needed to officiate the games. The game officials are responsible for many other duties as well as officiating and keeping games on time. Game officials do a great job and most teams are satisfied as shown by their team's continued patronage.

ARENA SOCCER:**2015 TEAM TOTALS****COED 72 Teams MEN'S 72 Teams WOMEN'S 18 Teams****= 162 Teams average 54 Teams per season**

Officials are contracted from (SDCSRA) San Diego County Soccer Referees' Association and all are trained and certified yearly by the US Indoor Soccer Association. Game officials do a good job in a very physical and fast paced sport.

BASKETBALL:**2015 TEAM TOTALS****MEN'S 122 Teams average 40 Teams per season**

Officials are contracted from (NCBOA) North County Basketball Officials Association and all are trained and certified yearly by their Association.

VOLLEYBALL:**2015 INDIVIDUAL TOTALS****MEN'S 90 Individuals WOMEN'S 54 Individuals****Average 48 participants per season**

The coed program is contracted to Dick Leatherman, who has coordinated the program for many years at our facility. This nine week program runs 3 times per year.

OUTDOOR SOCCER CONTRACTUAL LEAGUES: 2015 TOTALS**NORTH COUNTY COMMUNITY SOCCER LEAGUE, LEONESA,****LATIN AMERICA SOCCER LEAGUE - 150-200 Teams**

These contractual leagues continue to grow. They play games at Palomar College Minkoff Field, Walnut Grove Park, and Bradley Park.

ADULT SPORTS:**CONTRACTUAL ADULT LEAGUES**

The adult leagues below are set up as contractual leagues which pay park rental fees to offset their field use.

NORTH COUNTY COMMUNITY SOCCER LEAGUE:

NCCSL has access to city and school fields. Games are played year-round. Field rental locations include: Walnut Grove Park and Palomar College. NCCSL is under the direction of Jesus Garcia as League President. The program has expanded to include arena play as well.

LEONESA SOCCER LEAGUE:

LEONESA has access to city fields. Games are played year-round. Field rental locations include: Bradley Park multi-purpose field and Arena. Leonesa is under the direction of Eliseo Melendez as League President.

LATIN AND AMERICAN SOCCER ASSOCIATION:

LASA has access to city fields. Games are played year-round. Field rental location is Bradley Park. The group is under the direction of Marcos Sotelo as Association President.

CAL STATE SAN MARCOS MENS AND WOMENS PROGRAMS

We host CSUSM men's & women's basketball practices August-April.

CSUSM INTRAMURAL BASKETBALL PROGRAM:

Games are played on Friday afternoons starting in February at the Corky Smith Gymnasium. Program is under the direction of Ryan Groth - Director of Campus Recreation

Other adult programs include Pickle Ball and Volleyball weekdays from 8:30am-1:00pm.

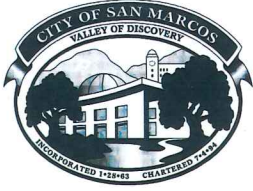
