Request: A California Environmental Quality Act (CEQA) determination for a previously approved six (6) lot Tentative Subdivision Map (TSM No. 475) and Conditional Use Permit (CUP 08-741) for lot size averaging in the R-1-10 zone of the Richland Neighborhood

Environmental Determination: In accordance with the California Environmental Quality Act (CEQA), the project is Categorically Exempt (EX 16-036) pursuant to Section 15332 of the California Code of Regulations (CCR), in that the project is consistent with the General Plan Land Use and Zoning designations of the property, the proposed development is located within City limits on a site less than 5 acres, the project site has no value as habitat for endangered or threatened species, approval of the project would not result in any significant effects relating to traffic, noise, air quality, or water quality and the site can be served by all required utilities and public services.

Location of Property: Montiel Road, more particularly described as Parcels 3 and 4 of Parcel Map No. 19649 in the City of San Marcos, County of San Diego, State of California, filed in the Office of the County Recorder of San Diego County, February 3, 2005 as instrument no. 2005-0094391 of official records (Assessor's Parcel Numbers: 226-092-66-00 & 226-092-67-00); and The easterly 290.40 feet of the northeasterly 150.00 feet of lot 9 in block 8 of Rancho Los Vallecitos de San Marcos, in the City of San Marcos, County of San Diego, State of California, according to map thereof No. 806, filed in the office of the county recorder of San Diego County, December 21, 1895 (Assessor's Parcel Number: 226-111-53-00).

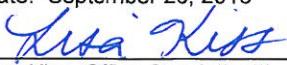
