

REPORTS AND OTHER BUSINESS

4. Mission 3:16 Church

Commissioners reviewed application of Mission 3:16 Church for recurring facility rental at the Community Center. Chairperson Franklin asked staff about any conflicts, to which Martin replied that although there is usually a two-year limit of recurring facility use, there are no other churches who have submitted an application for use at this time. Commissioners approved the application for a term of six additional months. If another group requests the use of the facility, both applications will be reviewed at that time.

5. Senior Activity Center Annual Report

Recreation Supervisor Catherine Manis updated Commissioners on the Senior Activity Center. Highlights include use of Active Net registration software, programs to attract baby boomers, marketing, nutrition, transportation, and volunteer opportunities.

Commissioner commentary ensued about joining official meet up groups, senior population use of online resources, volunteer recognition, North County Food Bank, wheel chair accessible transportation options, and use of Active Net registration software for data collection purposes.

6. Trails Advisory Committee (TAC)

Commissioner Lindsay briefed Commissioners on TAC notes such as not having a quorum to approve agenda items, Ridgeline Trailhead signs, extension of the North Twins Oaks Valley urban trail, Annual Trails Day rescheduling to Spring, Trails Master Plan, and placing a trail through CSUSM property.

7. Park Naming

Complete park naming report to be presented by staff at the December meeting as a voting item. Top three Commission recommendations will need to be presented to City Council in January, 2017.

8. Report to City Council

Commissioner Franklin recapped the November 15, 2016 presentation to City Council; highlights included significant events, fundraising, and #Discover SanMarcos campaign.

COMMISSIONER AND STAFF COMMENTARY

Buck Martin updated commissioners on items such as:

- Parks and Trails Master Plans, public outreach in Feb. 2017 and will provide periodic updates
- Ridgeline Trailhead signs are now being enforced, newly hired part time Rangers
- Preliminary City Budget packet
- Highland Project approved by City Council on Nov. 15 with some conditional factors
- Upcoming events include San Elijo Boutique, Santa's Village, and Kiwanis Holiday Parade
- Twin Oaks Valley Equestrian Association use at Walnut Grove with increased Park Operations support

Commissioner commentary included topics such as Richmar Park Grand Opening delays, the successes of youth sports teams, staff and City Council presentations, Golden Door Farmers Market advertising at Walnut Grove Park, Theatre West production of Charlotte's Web, possibility of bike-lights/torchlight parade on trails, Veteran's Day event, and people viewing the super moon at Double Peak Park.

San Marcos Community Services Department contracts with Independent Contractual Instructors to provide recreational classes for all ages. Year round programs include fitness, sports, dance, music, art, specialty classes and parent/child activities. During the spring and summer seasons, half-day specialty camps are offered for children.

Contractual Enrichment Programs are taught by independent contractual instructors, many of them residents of San Marcos and neighboring North County cities. In order to become a contractual instructor, one must first submit a proposal and assure they are able to comply with the requirements shown in the contract. Liability insurance including endorsements, fingerprinting, a city business license, proof of auto insurance, and workers compensation evidence are required. New contractors are accepted depending on the demand for the program proposed and the availability of space. Pay is based on a percentage; the instructor receives 60% and the City receives 40% of class fees collected.

Summary

During fiscal year 2015/2016, the Contractual Enrichment Program offered 115 classes and 49 half-day summer specialty camps taught by 42 Contractual Instructors. Total revenue amounted to \$345,193.42. This is an increase of 14% from fiscal year 2014/2015.

The number of half-day summer specialty camps offered for youth were expanded, once again, in 2016. These camps are held at the San Marcos Community Center and various city parks. The specialty camps have continued to increase 30% each year since summer 2014. New summer camps in 2016 included Workshop Wizards Wood Working, Skyhawks Sports, Cheer, Dance & Tumble, Minecraft Modding, Musical Theatre and Wonders Science. Each of these new camp programs were successful and will be offered again in 2017.

This fall, the Contractual Enrichment Program offered 84 classes taught by 42 contractual instructors. The year-round classes listed below that started in winter/fall 2016 were successful; Baby & Me Sign Language, Children's Holiday Vocal Ensemble, Tai Chi and Qigong. The Children's Holiday Ensemble met at San Elijo Rec Center on Wednesday evenings and their group performed in December at Santa's Village, the City's Annual Tree Lighting event.

New

A few of our new programs being offered this coming winter/spring season include Creative Music & Movement, Learning Adventures, Baby Music, Cheerleading, Dance & Tumbling, Curls for Girls, Kid Fit, Signing with my Tot and Mat Pilates. Registration for classes started on December 9, 2016. The Creative Music & Movement and Learning Adventures classes have already sparked much interest. The 2017 half-day summer camp scheduling will begin in January and the contractors have already been submitting their proposals. A full line-up and wide variety of summer camps will again be offered!

The goal of the Contractual Enrichment Program is to continue to keep up with the trends and improve the quality of enrichment classes and specialty camps being offered in our City.

Call to order

James Daza called the Youth Sports Council meeting to order at 6:05pm.

Approval of Minutes

Lori Schultz (SMYBB) motioned to approve the modified minutes from the November 1, 2016 meeting. Kelly Breihan (SMYL) seconded the motion.

Motion carried 6-0.

SMUSD Update

Martin Leon reported that San Marcos Unified School District will be closing San Elijo Middle School, Knob Hill and Alvin Dunn elementary school fields during the winter break.

Martin notified James and the YSC that the only permits that have been approved for school use are AYSO 1505. AYSO 127 and SMYS do not have approved permits on file with SMUSD. Joanne Shannon (AYSO 127) assured James that AYSO 127 had the proper paperwork on file with SMUSD and she will send him the email she received showing such.

Martin notified the YSC that the lights at San Marcos Middle School field are operational again after fixing an electrical issue. SMUSD will be looking to update the lighting fixtures at San Marcos Middle school with help from the City of San Marcos.

San Marcos Parks Update

Art Sotelo reported that the construction at Bradley Park multipurpose #1 and North softball fields is about 50 percent complete. He expects sod to be laid around the third week in December. He explained that the North softball field will now have a warning

track on the first and third base line as well along the outfield fence. He also mentioned that the batters boxes on field three and four have been rebuilt with clay bricks to extend the life of the batters boxes. Jeremy Vargas mentioned to Art that the home plates on field four and the South softball fields were installed crooked.

San Elijo Lower softball field will be closed on January 1, 2017 and will reopen on March 1, 2017. The outfield will be receiving new sod in places of need. Art mentioned that San Elijo Upper softball field and the Hilltop fields are starting to also show signs of wear. Art explained that Public Works and Community Services will be planning additional closures during the summer months because that is the best time for sod to grow.

Mission Sports Park will be closed beginning on December 12 to allow the fields to rest and so Public Works can work on them, keeping the fields in good condition.

Art reminded YSC members to report any lighting outages at the parks so they can be repaired. John Gomez (SMYS) asked who is in charge of fixing the lights at Palomar College. James responded that the Palomar College facilities department takes care of that. James notified Palomar College of the lighting outage back in September and reported the lights were just recently fixed.

Art said that the artificial turf at Connors Park was just audited and received an excellent grade for the condition of the turf.

John Gomez asked Art if the plexiglass at Sunset Park would be cleaned before their arena soccer program starts in February. Art responded that Public Works is trying to get a contractor to remedy the cloudiness of the glass.

AYSO Tournament

James asked Joanne Shannon how the AYSO tournament went this past weekend. Joanne explained that everything ran smoothly with no issues identified.

Triple Crown Sports

James reminded the YSC that Triple Crown Sports will be hosting a baseball tournament this weekend, December 10-11 at Mission Sports Park and Bradley Park.

Club Soccer Tryout Dates

James asked Taylor to reach out to all of the club soccer directors to plan out their tryout dates for the spring like they did last year. The meeting helped all clubs work out their schedules in one meeting to avoid any conflicts.

Old Business

Lori Schultz asked James which league has rented Woodland Park Middle School on Sundays for soccer because they are not putting their goals away at the end of the day.

Holly Malan informed the YSC that Richmar Park is scheduled to open on February 3. Buck mentioned that we will be showing a movie in the park as part of the park opening festivities.

James mentioned to the YSC members that NFL Flag football is going to be switching their game days from Saturday to Friday nights for the spring season to allow them to play on an artificial turf field. This will allow NFL Flag football to have a consistent field space and will save natural grass fields from more excessive wear and tear.

City Resolution Number 90-3392 states that applications for recognition of achievements by individuals or groups be reviewed by the Community Services Commission and forwarded to the City Council with Commission recommendation. An individual's name may be used if that individual has contributed significantly to the quality of life in San Marcos and has been a San Marcos resident.

Lionel "Doc" Burton Park. Turning 90 in August of 2017 and married for 67 years, Dr. Lionel Burton has been a significant contributor to the City of San Marcos. A general practitioner in the community for over 25 years, many of today's San Marcos citizens were delivered by his hands. Serving on Boards of the Vallecitos Water District and the San Marcos Unified School District, Dr. Burton also volunteered as a team physician for both San Marcos High School and Palomar College during the 1960's and 1970's. Presently a member of San Marcos Rotary Club, Dr. Burton was twice elected mayor of San Marcos.

Stanley "Sam" Mahr Park. One of the earliest landowners in that area was Sam Mahr, whose parents were early settlers in San Marcos. Having owned a chicken ranch near Los Vallecitos Blvd. and also the San Marcos Market, he was named San Marcos Man of the Year in 1974. Mr. Mahr was instrumental in getting the volunteer fire fighters organized and also helped

bring Colorado River water to this area, serving on the Vallecitos Water Board, the Cemetery Board, and was an active member of the Chamber of Commerce, Rotary Club and very supportive of organizations such as the San Marcos Boys and Girls Club.

Temet Park. (pronounced like Hemet). Luiseno word, meaning *sun*. Luiseno, also spelled Luiseño, is pronounced (loo-ee-sane-yoh). The traditional (eighteenth-century) location of the Luiseno tribe was along the coast and inland along streams, south of present-day Los Angeles but north of the Tipai-Ipai. Today most Luiseno live on reservations in San Diego and Riverside Counties; an interesting fact is that Cal State San Marcos has the highest per-capita numbers, within the CSU system, of Native American students.

We-la-me Park or Wind Spirit Park. The park is geographically located near to the remnants of an early Luiseno village that was inhabited during their periodic migrations. The Wind Spirit taught people how they were supposed to live. The Wind Spirit "sent the tribes to places on earth that were to be their homes" (San Marcos History, by Charlie Musser, 2014).

Flatlands Park or Mountain View Park. Both these names are descriptive of the topography of the area. Historically, much of the flat areas of San Marcos were dubbed "Desolation Flats" prior to the introduction of water and sewer services. Much of this land was developed into industrial centers with great views of the surrounding mountains.

Rodeo Park. This area was often used as Rodeo grounds, where many children who grew up in San Marcos would ride their horses and enjoy equestrian activities.

Innovation Park. Inspired by the *Innovate 78* moniker

Exploration Park. Inspired by the reference of San Marcos as the "Valley of Discovery"
