## Action Items: (Planning and Code Compliance)

- Enforce existing Codes
- Develop property appearance and mini-dorm ordinances
- Focus on illegal parking

## What is already in the Kit Bag

  - Administrative Citation program
  - Targeting illegal parking/garage conversions

# Property Appearance & Maintenance Ordinance

- Based on citizen complaints currently not covered in City codes
- Purpose and Intent:
  - Avoid further deterioration of communities
  - Maintain property values
  - Utilize the PAMO penalties as a “last resort”
  - Establishes minimum standards of property appearance
  - These standards apply to only portions of private property *visible from the public right-of-way*



  - Physical Obstructions

- Tents, Shelters,  
Canopies and Tarps

# Property Appearance & Maintenance Ordinance

- Dangerous Conditions
  - Unprotected Water features
  - Neglected appliances
  - Abandoned equipment/vehicles



# Property Appearance & Maintenance Ordinance

- Storm Water Conveyance System
  - No discharge of any material into one
  - No modification or removal of one
- Emission of Obnoxious Odors
  - No discharge of odor that is noticeable at a distance of 200 feet
  - Exception for law use of property
