K.C. Strang from the San Marcos Prevention Coalition shared with the Commission the mission and goals of the Coalition. K.C. also discussed the top three drugs abused by the youth nationwide and here in San Marcos and how local change and advocacy through the Coalition can help reduce the use of drugs in the community.

Gena Knutson from Vista Community Clinic spoke to the commission about her policy work over the past 10 years for tobacco control. Gena noted California is a leader on tobacco laws and she is currently working on a ban for outdoor dining areas. Nine cities in San Diego County have adopted the policy, mostly coastal cities. A public opinion poll was conducted and 97% of the 433 people polled were in favor of the ban.
