COMMISSIONER SMITH MOVED TO APPROVE CONSENT CALENDAR ITEMS 1-3, SECONDED BY COMMISSIONER MOCKUS AND CARRIED UNANIMOUSLY. ABSTENTIONS: NONE

REPORTS AND OTHER BUSINESS

4. SMYB & SE AYSO 1505 Annual Presentation.

Neither Sports groups were available to report and will be rescheduled.

5. Annual Staff Presentation, PPT shown.

Recreation Supervisor III, Cathy Cronin, presented highlights of Special Events & Theater West over fiscal year, including changing the Music Fest to a one day event. Presale tickets were good but sales at the gate were low due to the colder weather. The 2017 Music Fest will be held on June 10th and presale tickets are \$12 and at the door \$20. Cathy spoke about the new bands that will be performing at this year's Summer Concerts in the Garden. The Fourth of July Celebration will not have any significant changes besides moving the food vendor's, due to Health Dept. requirements. Santa's Magical Village and Tree Lighting saw an increase in the amount of people attending, due mostly to multiple children's choirs coming from various schools.

San Marcos Alive, a celebration of the arts had great attendance due to the number of performances and art shows. The Theater West Shows was presented has been in existence for 30 years in existence.



Annual Staff Presentation, cont.

More than 3,000 patrons have attended the theater program, we average 20,000 participants combined at special events. Commissioner Towsley stated the paws event, set for June 24 & 24, is great and recommends everyone to attend. Commissioner Maas asked about what parking options there are for the 2017 tree lighting event. Staff will have a formal parking plan in place for 2017. Commissioner Smith asked about the Theater Program and discussions ensued about transportation, marketing and how to best estimate crowd size.

6. Trails Advisory Committee (TAC)

Brenda Sylvia, Program Manager discussed TAC meeting notes from April 5, 2017. The TAC committee recapped the Trails Day event. Topics discussed included possibly creating a sub-committee specifically for Trails Day. The Hike Happy campaign winner from Trails Day will receive a Massage Envy gift card. Sylvia reported the Bike and Mounted patrol is on hold until more information is gathered from other municipalities. Bike to Work Day was also discussed at the TAC meeting and The City of San Marcos will host a pit stop for the event.

7. Trails Master Plan Workshop

Brenda Sylvia, Program Manager invited commissioners to the upcoming workshop on Monday May 1st at the Senior Activity Center & Thursday June 1st at the San Elijo Rec Center. Flyers will be posted and social media will have information about the workshop. Chair Franklin suggested having a Spanish speaking interpreter available.

8. Park Naming Process and Application.

Holly Malan, Program Manager noted the application was updated per the commission's request. Commissioner's appreciated that this process is now in place.

MOVED BY COMMISSIONER TOWSLEY, SECOND BY COMMISSIONER SMITH AND CARRIED UNANIMOUSLY TO APPROVE THE PARK NAMING PROCESS AND APPLICATION AS PRESENTED.

9. Sunset Park way finding signs.

Holly Malan, Program Manager presented the changes to the Traffic Engineer per the Commission's request an update will be provided at a later date.

10. July 4 Fireworks Fundraiser.

Holly Malan, Program Manager invited the commissioners to join the fireworks committee, noting the kickoff meeting will be held April 24 at the Community Center conference room.

11. Spring Festival Recap.

Holly Malan, Program Manager thanked everyone who was able to volunteer for a shift in the City booth at the "Street Fair". She asked for input from the commissioners. Commissioner's said newer residents attended and were interested in the summer programs.

12. Special Events List.

Community Services Director, Buck Martin presented the Special Event Permit list.

Commissioner Maas asked if for a two month list of Special Event Permits. Commissioner Lindsay asked if the Belgian Waffle ride was approved. Buck Martin explained the process of Special Event Permit approvals. The Commissioners are concerned with the group damaging City trees.



Buck stated he made a stipulation in the Trak-It system and with the Park Operations Department that the group cannot post flyers on trees, posts, etc. in order to get an approved Special Event Permit. Buck will talk to Sandra Gallegos, Special Event Permits Coordinator, about the Waffle ride event and get back to the Commission.

Call to order

James Daza called the Youth Sports Council meeting to order at 6:02pm.

Approval of Minutes

Molly Carpenter (SMYB) motioned to approve the minutes from the February 7, 2017 meeting. John Gomez (SMYS) seconded the motion.

Motion carried 3-0 with three abstaining.

Joaquin Valdez- Futsal Program

Joaquin Valdez presented to the YSC about a Futsal class he will be hosting at the Corky Smith Gym on Friday nights during the summer. He explained his coaching background and the benefits of Futsal training to all age groups. Patrick and Wayne (SEAYSO) mentioned that they have distributed his flyer to their participants but it might be hard to get the parents to add another activity to their children's schedules. Patrick mentioned that it might be easier to target team registration instead of individuals. Flyers were passed around to all YSC members to distribute if desired.

SMUSD Update

Martin Leon reported that SMUSD will be doing construction on most of their fields during the summer which will result in closures. Attached is a list of all closures Martin mentioned.

James asked Martin what the status was about gaining access to Double Peak School during the upcoming season. Martin said SMUSD was working to find an answer and will get back to him at a later date.

Wayne Marking (SE AYSO) asked Martin if they needed to provide SMUSD with a color of paint for their field lining prior to lining. Martin would like to know the color prior to the fields being lined.

Martin informed the YSC that SMUSD Maintenance and Operations needs to have the facility use permits turned in prior to July 1, 2017. All school sites that will be used by YSC organizations need to have a separate permit turned in to LaTanya, who will then distribute them to each school site.

John Gomez asked for clarification about turning in one permit for each school site. Martin reminded all groups that each school site they plan to utilize requires their own permit.

San Marcos Parks Update

Art Sotelo updated the YSC about ongoing projects and field conditions. He explained that based on industry standards the fields here in San Marcos see far more hourly usage that recommended. He explained that Public Works is creating a field rating matrix to help relay information quicker of how fields are deteriorating based on the usage they get. He will present the matrix at the next YSC Meeting.

San Elijo Lower softball field is scheduled to be closed beginning July 1, 2017 to receive new sod. Art mentioned that they are going to try to re sod the entire outfield as long as their budget for the project allows it. He explained during the closure some of the special events will be moved to the Hilltop and Upper softball field.

Bradley Park multipurpose #1 and north softball field opened on April 1, 2017 after installing new sod. He explained that Public Works is looking to find a better paint for the lines at the soccer arena. The current paint wears very quickly and needs to be touched up frequently.

Art mentioned that a group hosting a tournament at Walnut Grove used a solvent based paint to mark their fields which caused the grass to burn where the paint was applied. He is creating guidelines to pass out to groups using City sports fields for future tournaments and games to prevent the damage.

There is an electrical contractor that is under contract to fix issues at the Bradley Park arena and Mission Sports Park.

Art mentioned that they are waiting on the materials to replace the plexiglass at the Sunset Park soccer arena. He explained they are about 3 weeks out from receiving the materials and will then install as soon as possible.

Art gave a few suggestions to the YSC members about rotating activities on the grass fields to prevent wear and tear in the same spots to prevent damage to the field. Some of the examples included changing locations of goal boxes and other high impact areas for each sports and using portable goals to be able to rotate fields here and there.

Jason Simmons (SM UNITED) asked if Art could pass that list along to the YSC.

Hollandia Park Soccer Goals/San Elijo Field Closure

James explained that there are too many soccer goals at Hollandia Park. He asked SMYS and AYSO 1505 to work together to try to have one set of large and small goals instead of two sets of each. He also asked the groups to ensure the goals are locked at the end of their practices and games to prevent park patrons from moving their goals out onto the field and failing to put them away.

James reminded all YSC groups that during the SMUSD field closures and San Elijo Park field closures AYSO 1505 will be heavily impacted with fields available to them which will result in other groups having to share fields to provide enough practice time for all groups. With a shortage of fields currently it will be difficult to schedule all activities when those fields are closed for rest/renovation.

Double Peak Challenge-AYSO 1505

James informed AYSO 1505 that the Double Peak challenge will be held on September 30, 2017. He mentioned that they will be able to use the Lower softball field if needed after 1pm, but their allocated field times at Hilltop and Upper softball field will not be affected.

Friends of San Marcos

Holly Malan explained the purpose behind the Friends of San Marcos and the goals that they are working to accomplish in working with the City of San Marcos for fundraising and grants. She gave the YSC members information about how to join the Friends if they are interested. Jason Simmons; who is also on the Friends Board, believes that the relationship between the YSC and Friends is underutilized. He explained that with more involvement between the two organizations they would be able to create more fundraising opportunities to benefit each other.

Banner Applications

James asked all YSC members to make sure to send in their banner applications for all parks prior to hanging any signs. He reminded all members to follow the placement rules for hanging all banners as specified on the application.

Connors Park Storage Room

James informed San Marcos Youth Lacrosse, Rugby and SM United that the storage room at Connors Park was very unorganized and there were many indications that rats were inside the storage room. He informed the groups that he would like the room cleaned by June 1, 2017

Triple Crown Sports 7/11-7/16

James asked all YSC members to let him know if any groups are interested in running concessions or field prep for the Triple Crown Sports Tournament.

Next regularly scheduled meeting will be Tues, June 6 @ 6pm. Meeting adjourned at 7:00pm.


