1) **CALL TO ORDER** – Acting Chairwoman Clark called the meeting to order at 6:32 PM.

2) **PLEDGE OF ALLEGIANCE** – Provided by Acting Chairwoman Clark.

3) **ROLL CALL**

4) **APPROVAL OF MINUTES**

5) **ORAL COMMUNICATIONS** – No members of the public requested to speak.

6) **PRESENTATION**

Deputy City Manager Romero introduced the new Sheriff's Captain, Scott Ybarrondo. He has been with the Sheriff's Department for 21 years. He stated that he looks forward to working with the Commission and the community.

7) **REPORTS**

- a) Sheriff's Department Report: Sergeant Haynesworth reported there was a reduction in calls from 86 in December to 58 in January and it could be due to the schools being closed for winter break.
- b) Code Compliance Report: Director Schwarm reported there has been an increase in animal control related complaints. He also reported that his division is now working with Alcoholic Beverage Control (ABC) on the permits that are issued for serving or selling alcohol. The city reviews the

permit and places conditions on the permit based upon an establishment's previous code violations and calls for service from the Sheriffs.

Commissioner S. Kildoo stated that the Chamber of Commerce hosts round table discussion with local restaurants. Some have expressed frustrations and/or concerns with ABC and the conditions of the permit. He invited Director Schwarm to attend a round table meeting to share his insights on the ABC permit process. Director Schwarm accepted his invitation and stated it would also be a good opportunity to talk about the city's responsible beverage sales & service ordinance.

Director Schwarm reported there are currently three fraternity rooming housing ordinance violations under investigation (two near Palomar College and one near CSUSM).

8) STAFF COMMENTS

Deputy City Manager introduced new recording secretary Gallegos and Sheriff's Sergeant Haynesworth.

9) COMMISSION COMMENTARY

Commissioner Paris welcomed Sheriff's Captain Ybarrondo and Sergeant Haynesworth. She reported that the fall festival of trees was very successful and they are already planning for next year's event.

Commissioner S. Kildoo welcomed Captain Ybarrondo. He spoke about an event he attended at the San Marcos Historical Society to celebrate the City's 50th anniversary.

Commissioner Keeney reported that student government elections are coming up in the next couple of months and he will be graduating in May. They continue to distribute the good neighbor brochure and spread the message about students and neighbors working cooperatively together.

Commissioner Martinez reported that he attended President Haynes' 'Report to the Community' at CSUSM.

Acting Chairwoman Clark stated that the President's 'Report to the Community' was very well attended. She reported that they are gearing up for commencement in mid-May. There will be two ceremonies on May 17th and two on May 18th. Almost 2,000 students will be graduating in those four ceremonies. The largest event will be on Saturday morning with almost 1,000 graduates. She reported that tonight Father Gregory Boyle, founder of Homeboy Industries will speak at CSUSM. She hopes that the ASI election is smoother this year as there was an arrest made related to last year's elections.

Deputy City Manager Romero announced that the Mayor's 'State of the City Address' will be February 26th beginning at 11:15 a.m. Tickets for this event can be purchased through the Chamber of Commerce.

10) **ADJOURNMENT:** Acting Chairwoman Clark adjourned the meeting at 6:53 PM.
