OLD BUSINESS

1. **GRANT AWARD WORKSHEET.** FISCAL YEAR 2013-2014
Recommendation: **NOTE & FILE**

The committee members reviewed the funds available for distribution for the remainder of Fiscal Year 2013-2014. There was discussion about whether the Foundation would stop awarding grants for the remainder of the fiscal year if the remaining funds were awarded between the April and May Grant Funding Committee meetings and the May Board meeting. There was also concern voiced about going to the maximum award level of 5% for the fiscal year.

The Board addressed the mini-grant application before the regular grant proposals.

3. **MINI-GRANT APPLICATION PROPOSALS**

Board members discussed the proposal from Write Out Loud. There were no letters of support from the principal or teachers of Twin Oaks Elementary School.

BOARD MEMBER NAJERA motioned to deny awarding a mini grant in the amount of \$1,440 to Write Out Loud. BOARD MEMBER BURTON seconded the motion. The motion passed by unanimous voice vote.

BOARD PRESIDENT LUKOFF presented information about how the Angel's Depot services differ from some of the other senior programs the SMCF has provided funding to.

BOARD PRESIDENT LUKOFF liked that the Palomar College Foundation Textbook Assistance program offered different ways for students to acquire books. She will contact the Palomar College Foundation to get more information about this program.

The Board members reviewed the budget provided by the Twin Oaks Elementary PTO. They noted that the fiscal year is from September to June.

BOARD MEMBER BURTON motioned that the Grant Funding Committee further discuss the Elizabeth Hospice application and the Palomar College Foundation at the May Grant Funding Committee meeting and that the GFC recommend to the Board that the requests from the Make-A-Wish Foundation and the Angel's Depot not be funded at this time. The motion passed by unanimous voice vote.
