**8) REPORTS**

- a) Sheriff's Department Report: Sergeant Henry Ramelli reported that party calls were average for the month with no major arrests. One complaint was received from a potential fraternity house. Both traffic issues and citations have decreased around the city except for on Borden Road, behind Palomar College. The Sheriff's Department has been working with CSUSM Campus Police regarding jay-walking on Barham Drive. Deputy City Manager Romero reported jay-walking will be on the upcoming Traffic Safety Commission's agenda for a recommendation to sign the street to make citation enforcement easier. Commissioner Kildoo reported jay-walking also occurring on Mission Avenue where students are crossing through and from the medians behind bushes. Sgt. Ramelli advised deputies are aware of the issue and have been directed to issue citations.
- b) Code Compliance Report: Director Schwarm reported a potential fraternity house complaint on Linda Vista Drive was received and is still being confirmed and under investigation. An updated report will be provided to the Commission at the next meeting. Calls regarding parking violations near Palomar College has increased as well as party calls. Parking enforcement is being done in the neighborhood behind Palomar College and in the industrial area near CSUSM. The VIBE event is scheduled for October 20<sup>th</sup> and volunteers are needed.

Deputy City Manager Romero announced the Commission was provided a meeting calendar for 2013.

**10) COMMISSION COMMENTARY**

Commissioner Paris provided a reminder of the tree festival unveiling scheduled for November 17<sup>th</sup> at City Hall. The cost for the unveiling event is \$40. Proceeds are donated to Interfaith to assist seniors with financial hardship issues.


Commissioner Kenney reported Palomar College is conducting a voter registration event for students. Prop. 30 educational information is available on campus relating to both sides of the argument.

The Chamber is holding a candidates forum on October 18<sup>th</sup>, 6:00 PM at the Community Center.
