CALL TO ORDER: Vice Chair Cavanaugh called the meeting to order at 6:31 PM.

3) NEW BUSINESS

A) Election of Chair and Vice Chair

Director Schwarm reviewed the resolution establishing the Student and Neighborhood Relations Commission. The resolution states the Chair will be rotated amongst the City, CSUSM and Palomar College appointees (in that order), and the Chair will serve for two years. At the first meeting the Vice Chair will be elected. Since the City appointee has been the Chair for the last two years, the next Chair will be the CSUSM appointee.

4) **REPORTS:**

A) **Sheriff's Department Report**

Sgt. Lebitski reviewed the noise calls in the last four months around the college and university. There were 61 noise calls in the Palomar College area and 37 noise calls in the Cal State area. There were no social host and no fraternity house related calls.

B) **CODE COMPLIANCE REPORT**

Building Official Reynolds stated there have been several neighborhood issues pertaining to parking in the west side of the city which are being addressed with the street sweeping program. They continue to receive complaints about people reserving parking spaces in front of their homes with furniture and cones. The parking spaces are on the public street and the residents have been informed they can not reserve public parking spaces.

STAFF COMMENTS:

Director Schwarm stated the Parking Ordinance that the Commissioners recommended for approval at their last meeting was being reviewed by the Public Works Department. The parking permit portion of the ordinance is also being reviewed by the City Attorney. The ordinance should be going to Traffic Safety Commission for their review in the next few months.

Director Schwarm stated this was his last meeting as he will be retiring next month from the City. He asked Commissioners to think about any issues they may want to bring forward for discussion. The next commission meeting is scheduled for April 10, 2017.

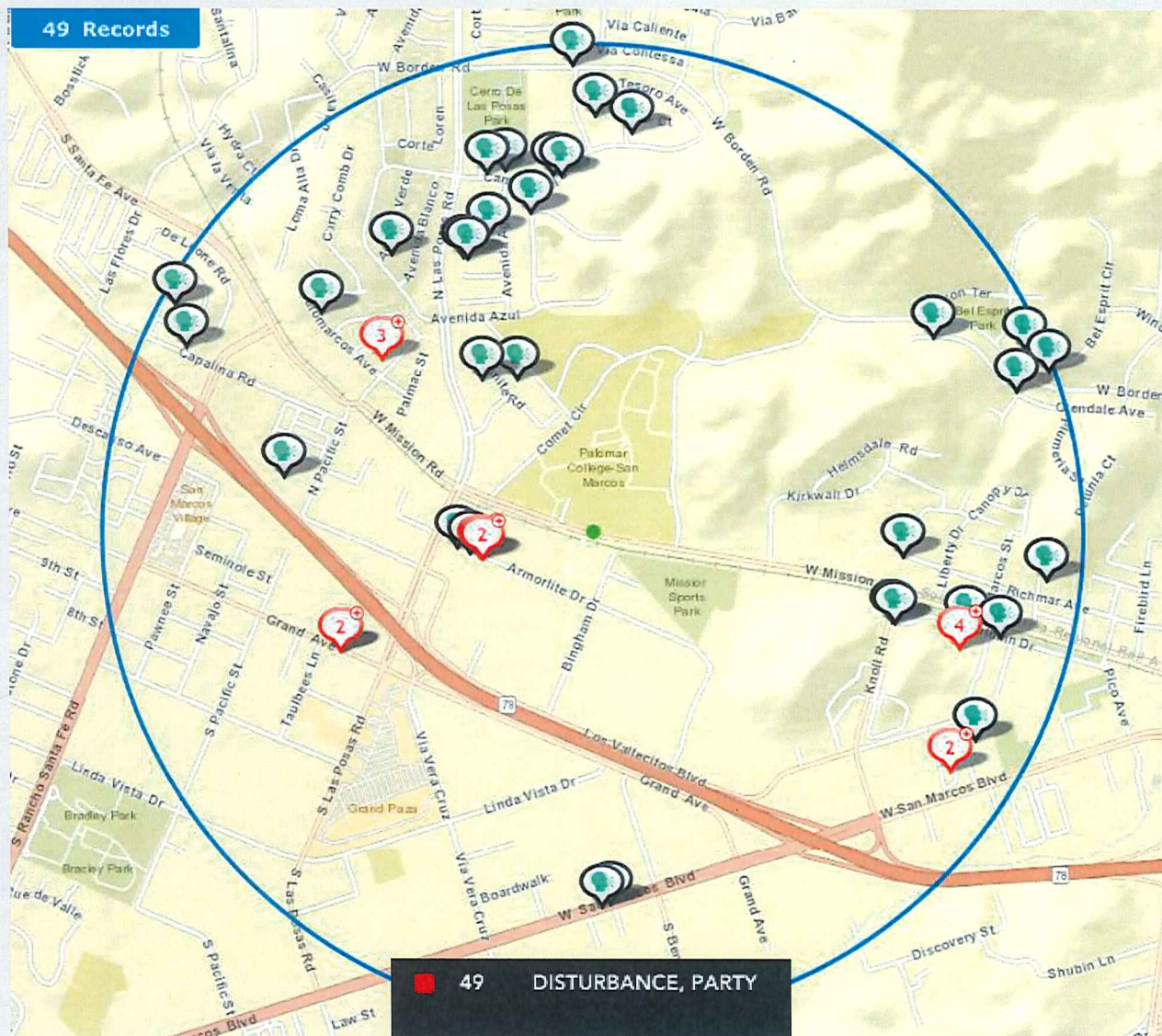

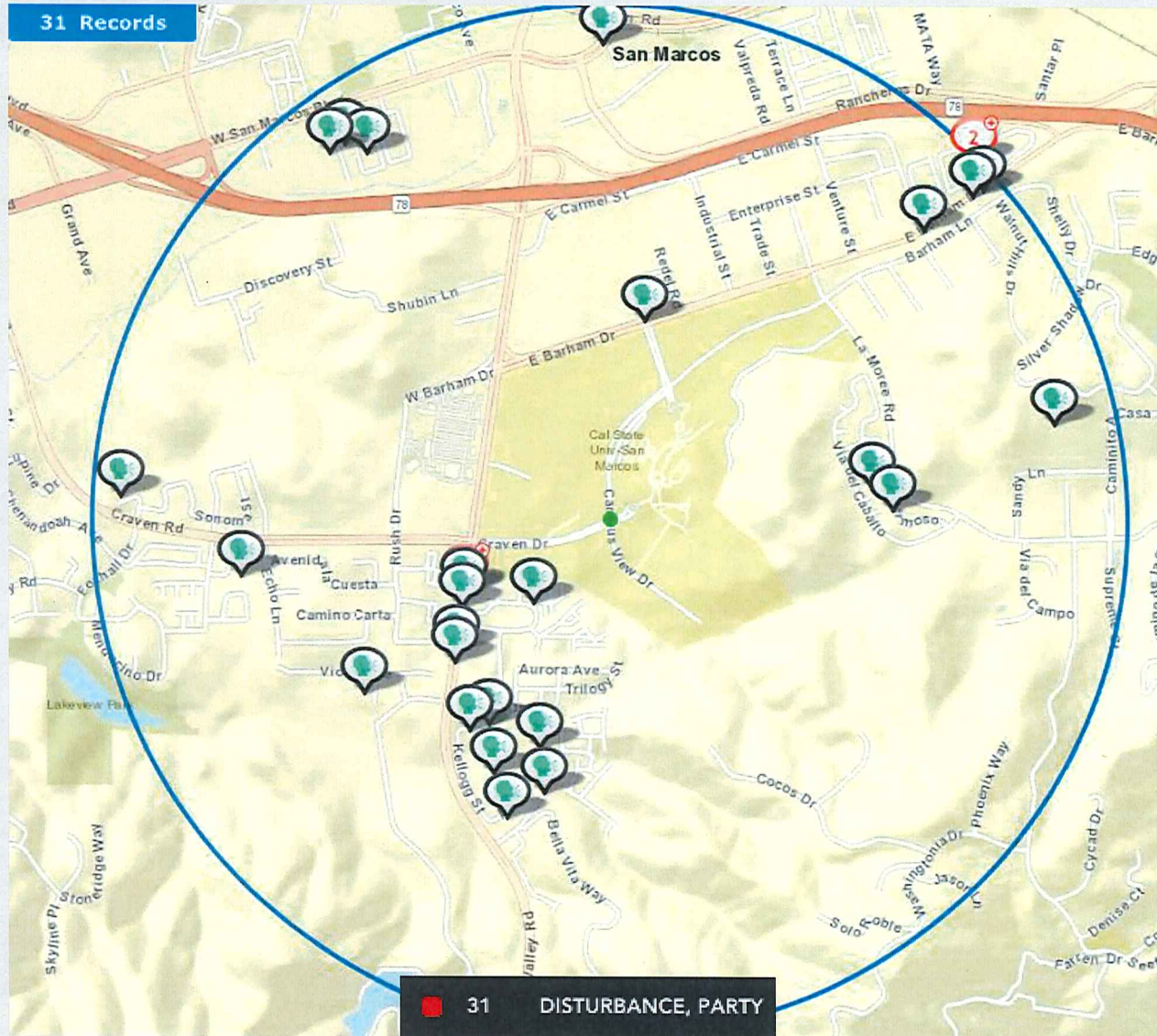
