1. Project: PA 17-0002; Parks Master Plan Update

Applicant: City of San Marcos

Request: The Planning Commission will consider an update to the City's Parks Master Plan, which includes updated demographic information, community outreach results, ideas for improvements to the City's park areas and recreation programs, and a financial analysis to achieve improvements to parks system. The Planning Commission will provide a recommendation to the City Council to update the Parks Master Plan.

Environmental Determination: The project to update to the City's Parks Master Plan has been reviewed for compliance with the California Environmental Quality Act (CEQA) and it has been determined that this is not a project within the meaning of Section 15378 of the CEQA Guidelines because there is no potential for it to result in a physical change in the environment, either directly or indirectly. Even if the proposed project was considered a project subject to CEQA, it would be exempt from CEQA pursuant to Section 15061(b)(3) of the CEQA Guidelines because it can be seen with certainty that there is no possibility that the update to the Parks Master Plan would have no significant effect on the environment.
