**Viejas Tribal Government Letter:**

The Viejas Tribal Government submitted the attached letter dated January 26, 2018 requesting that the San Pasqual Band of Mission Indians be notified regarding grading of the proposed project site. The Discovery Village North action did not trigger Tribal Consultation in accordance with State law or additional CEQA review, therefore no new CEQA related conditions have been incorporated into the project beyond the applicable mitigation measures contained in certified University District Specific Plan Final Environmental Impact Report. A mitigation measure to notify the San Pasqual Band of commencement of project construction was included in the Mitigated Negative Declaration prepared for Discovery Village South (Item 3).


