PUBLIC HEARINGS

2. **Case No:** CUP 88-22 (10M)
Application of: San Marcos Energy LLC
Request: A Conditional Use Permit to continue to operate a gas to energy conversion facility and to replace the turbine equipment with gas equipment.
Location of Property: 1615 San Elijo Road, more particularly described as: A portion of Section 33, Township 12 South Range 3 West, Bernardino Base and

Meridian; County of San Diego. Assessor's Parcel No.: 223-080-36 & 223-082-07.

Staff Presentation (Susan Vandrew Rodriguez):

Described request and location. PowerPoint presentation shown. CUP Modification to replace turbine with two gas engines and continue operation of a methane to energy conversion facility. Landfill stopped trash receipt in 1997, planted native vegetation in 2006 and formally closed in 2007. Northwest of site is a vacant industrial building previously used by landfill operation and adjacent to applicant's site is the County Flare to burn excess methane gas for the closed landfill. Site & floor plan shown. Staff provided an overview of questions raised by an adjacent resident which included noise level and air pollution. Applicant provided documentation, including a noise analysis that shows 25 dBA to nearest receptor and air pollution resulting in lower emissions with the new equipment. Currently have an existing APCD permit with no violations. A new APCD permit is required which requires initial/annual testing and a maintenance log. They're also subject to compliance with SWRCB and County of San Diego Department of Environmental Health. Staff recommends approval.

Schaible: Clarification on reso. C.1.c.: Believe intent on plan is to show that LLC "is separate" from County equipment? Okay to add word?

Vandrew: Yes.

Schabile: Asked applicant if they had questions or wanted to speak?

OPEN PUBLIC HEARING

Norris: Inquired if turbines are louder?

Matt Nourot, P.E., Fortistar Methane Group/Applicant: Turbines and engines have similar noise levels; however, the current gas compression equipment has been replaced by a blower system which will be quieter.

Norris: Asked if power is tied into San Elijo Hills?

Nourot: Replied that the power from plant goes into a distribution system to SDG&E to dispense as they wish.

Norris: Curious if San Elijo could benefit from green power?

Nourot: Not sure, you'd need to get clearance from SDG&E.
