2. **Case No:** CUP 89-43 (10M)

Application of: Palomar Church of Christ

Request: Modification of a Conditional Use Permit to allow for a 400 square foot addition to an existing church facility in Estate Residential (E-1-20) zone.

Location of Property: 3345 Linda Vista Drive, more particularly described as: Parcels 1 & 2 of Parcel Map No. 12410. Assessor's Parcel No.: 221-560-28.

Staff Presentation (Garth Koller):

Described request and location. PowerPoint presentation shown. Existing facility is 4,080 s.f. and is on 4.22 acres. Floor plan shown. Addition is for a library, dressing area & baptistery. Architectural elevations shown. Original CUP approved in '89. 35 parking spaces on site. Site is surrounding by single family homes. CUP is required to allow for a church within any zone. Staff received one comment regarding condition of landscaping. Plants have not been adequately watered. Landscape has since been rejuvenated with recent rain and project has been conditioned to replace dead plant material and properly maintain to include new landscape irrigation. Recommend conditional approval.


