



PUBLIC DANCE LICENSE PROCEDURES

Applicant Instructions

1. **FEE:** New and Renewal, Class A, B, C, and D is \$93.00
2. **LICENSE CLASSIFICATIONS:**
 - a.) Class "A" – daily or nightly dancing.
 - b.) Class "B" – dancing not to exceed three days or nights in any calendar week.
 - c.) Class "C" – dancing conducted one night or one day only.
 - d.) Class "D" – dancing conducted in a bona fide club.
3. **EXCEPTIONS** – The requirements of this chapter are not applicable to any City park which closes at or before 9:00 p.m.
4. Complete an "Application for Public Dance License,"; (If these apply) complete "Manager Registration," and "Owner Identification Sheet" form for the City of San Marcos.
5. Deliver the following:
NOTE: If applicant is also submitting an Entertainment License, only one set of photos and fingerprints are required.
 - a.) Completed application.
 - b.) A check made payable to the City of San Marcos for \$93.00 and \$78.00 if you are required to obtain the Manager Registration.
 - c.) All owners and managers must be fingerprinted. Applicants must return the second copy of the Live Scan Form to the City Clerk Department.
 - d.) Two 2" X 2" passport type photographs of all owners and managers.
 - e.) Floor Plan showing entry ways, exit doors, location of the bar(s), tables, dance floor, DJ or stage area, outdoor patios, etc.
 - f.) If establishment is selling alcohol we will need a copy of your ABC License showing any restrictions.
6. **Upon receipt of approvals from the Sheriff's Dept., Fire Dept. and Planning Division your Dance License will be issued. This process usually takes approximately 6-8 weeks. The Dance License will be valid for one year. You will be notified by mail when your renewal is due.**
