


Referrals Provided

In Quarter 3, 2019 (Jan - Mar 2019), 2-1-1 San Diego helped **551** low-income clients (income below 80% AMI) who resided in San Marcos (zip codes: 92069, 92078, 92079, 92096). These clients presented **1,716** needs, which resulted in **1,178** referrals to services to address these needs.









Gender Identity




Race/Ethnicity



This quarter, 73% of clients who called from San Marcos were **women**, which was greater than the total population of 2-1-1 clients (69%). 51% of the clients from San Marcos were **Hispanic or Latino**, which was greater than the total population of 2-1-1 clients (41%). Additionally, 4% of the San Marcos clients were **African American/Black**, which was lower than the total population of 2-1-1 clients (16%).

Age Group



Clients from San Marcos represent roughly the same age groups as the total population of 2-1-1 clients. This quarter, there was a comparatively smaller percentage of clients in the **50-59** age ranges (15%) and a larger percentage of clients in the **70-79** (9%) age ranges than the general 2-1-1 population.



Client Needs


Client needs are organized by a taxonomy structure. Taxonomy is a thorough classification system that distinguishes concepts, names those concepts, and puts those concepts into a hierarchical order. The first level is the most broad level, with up to six nested layers that progressively increase in specificity. 2-1-1 Customer Service Representatives document client needs using this structured system.

Needs by Taxonomy: Clients living in City of San Marcos




Basic Needs accounted for 42% of total needs for clients in the City of San Marcos this quarter. **Consumer Services** account for an additional quarter (17%), with an increased need this quarter for **Tax Organizations and Services** (16%). Below is a more detailed description of needs by category (second level needs). The most common basic needs are **Utilities**, **Housing/Shelter**, and **Food**.



Big things are happening with the North County Food Bank, and I'm excited to share them with you!

In the three years since the North County Food Bank (NCFB) came under the umbrella of the Jacobs & Cushman San Diego Food Bank, huge strides have been made to combat hunger in this community. We have tripled the number of people receiving food from the NCFB, and I'm very proud to share we've more than doubled the amount of food being distributed. In addition, we have tripled the number of schools on our Food 4 Kids Backpack Program! We now have more than 120 nonprofit partners across North San Diego County helping us to distribute healthy food to our neighbors in need. This is a truly grassroots effort to not only address food insecurity, but to ultimately put an end to poverty in our community.

One in eight people in North County lives with food insecurity – that means they don't always know where their next meal will come from. One in five children. Under the strain of low-wage jobs and the high cost of living, food insecurity is just one piece of the struggle our clients face. Many need assistance with housing, child care, education and health care too.

While we've made great strides at our existing 5,000 square foot NCFB, we ultimately want to move to a larger facility where we can share space with other nonprofits who will provide additional services for our clients. This wraparound service model will allow parents to meet many of their needs in a single trip, rather than spending time (and precious dollars) traveling to various offices around the county to meet their many needs. It will allow our clients to spend more time helping their children with homework, advancing their careers, and tending to all the other things every family needs to do. Please check out the enclosed article recently published in Ranch & Coast Magazine; Deanna Murphy did a great job providing an overview of the work we do and the vision moving forward.

Thank you for your ongoing support. Together, we can break the cycle of poverty and build a better future for North County.





A SMCF grant for Art Animates Life would facilitate a theatrical production and two or three public service short films specifically benefiting San Marcos nonprofits.

This year's theatrical production will be North County Player's, "Sherlock Holmes and the Case of the Christmas Angels." The show will benefit several San Marcos area charities including Art Animates Life itself. Past beneficiaries have included the Charity Wings Art Center, the San Marcos Historical Society, Survivors of Suicide Loss, and the San Marcos VFW. Beneficiary organizations are welcome to take as large a role as they wish in generating revenue for their organization -- or they can focus on doing the important work they do for our community and accrue donations automatically as attendees purchase tickets using the checkout code unique to their specific organization.

Grant funds would be used for facility and truck rentals, set construction, props, printing, costumes, and lighting, sound, and video equipment.

Art Animates Life events promote tourism and economic development by advancing the ideal of a vibrant, grassroots art community that is well integrated with governmental and other social institutions.

Donations from entities and individuals allow us to both maximize returns to our beneficiaries and keep ticket prices extremely low. North County Players ticket prices are typically 1/2 to 2/3 less than is normally charged for productions of comparable quality while providing a creative crucible that allows new artists to work side-by-side with seasoned pros in real world on-stage environments.

Roughly 1,000 people are directly served but, considering widespread social network penetration and ad buys (Facebook, The Reader, San Diego Magazine, The Paper, 92078, SHARE, et al.), web sites, and deep saturation with banners and flyers, the effective reach is many times larger.

No member of Art Animates Life receives payment in any form, including actors and production team members.

A grant from the San Marcos Community Foundation would be prominently noted in all press releases and on distributables including banners, flyers, video credits, show programs, and other promotional materials.

Over the past decade, Art Animates Life/North County Players theatrical productions have raised tens-of-thousands of dollars for North County San Diego area disaster relief, an arts nonprofit, a veterans museum, a municipal gallery, a community outreach center, an historical society, a veterans relief fund, several struggling community theaters, and more. Thousands of Southern California residents have attended North County Players shows.

Our newly-expanded video production capability, branded Art Animates Life Films (AALF), has already produced several public service announcements (PSAs) for area nonprofits including San Marcos' Charity Wings Arts Center and Escondido's Art Hatch. For 2019-20 we have scheduled projects with the San Marcos Boys and Girls Club, the San Marcos zzz food bank, and zzz zzz. The PSAs and short films we produce are provided absolutely free-of-charge to the associated charity and can be used by them without restriction for fundraising, organization web sites, grant procurement, general public education, and countless other purposes. In addition to PSAs, last year AALF produced a film ("Sky Takes a Bite Out of Crime") as part of our Young Filmmaker Series which was named a featured selection at the San Diego International Kids' Film Festival and has gone on to garner many YouTube views. The 30-minute short included several young actors and tech persons from the San Marcos and surrounding areas.

Our model benefits the greater community in several important ways:

- > Offers financial support for essential North County (often San Marcos) charities.
- > Provides excellent live theater at greatly reduced ticket prices and professional quality video productions free of charge.
- > Never charges a 'pay-to-play' fee of ANY kind, further enabling every member of the acting and creative community the opportunity to participate regardless of financial situation.
- > Produces shows and videos that are not only entertaining but educative and historically significant.
- > Finally, because Art Animates Life is a complete production entity that owns its own lights, sound, sets, props, costumes, video projection, and more, we are able to stage events at venues which would not otherwise be financially viable (e.g., a municipal gallery, an arts center in an industrial district, a veterans museum, a nearly 100-year-old community theater, etc.) in addition to renting fully-purposed local facilities if price fits our stringent budget guidelines.

As noted in our cover letter, Art Animates Life will give first priority to San Marcos/Lake San Marcos residents for all acting, crewing, and production positions. We will also first query San Marcos nonprofits, community venues, and businesses with sufficient space for a location to stage the show. Promotional and press materials associated with both events will reflect the above, as-well-as our receipt of and deep appreciation for a SMCF grant.

Previous years' shows have taken place at many San Marcos venues including the Charity Wings Arts Center, the San Marcos Historical Society, and the San Marcos Civic Center. All of this years' Art Animates Life Films' PSAs and promos will benefit San Marcos-based charities (currently scheduled: the SM Boys and Girls Club and the San Marcos' Wounded Warrior Homes).

Our primary goal is to nurture and grow both venerated and burgeoning American art forms by helping to ensure they remain accessible to ALL members of the community, regardless of personal means. Every family should be able to experience the unique wonder of live theater and every charity should be able to spread the word about the essential public works they perform via high-quality PSAs and short documentaries.




