COMMISSIONER SMITH MOVED TO APPROVE CONSENT CALENDAR ITEMS 1-2 AS PRESENTED, SECONDED BY COMMISSIONER MOCKUS AND CARRIED UNANIMOUSLY TO APPROVE.

COMMISSIONER HERNANDEZ MOVED TO APPROVE CONSENT CALENDAR ITEM 3 AS PRESENTED, SECONDED BY COMMISSIONER PRESTININZI AND CARRIED TO APPROVE. ABSTENTION: MOCKUS AND SMITH ABSTAINED.

REPORTS AND OTHER BUSINESS

4. Communications and PIO Department Introduction

Robin Rockey and Tess Sangster introduced themselves to the Commission. Robin reported they are happy to support the Parks and Recreation Department and that new and exciting updates will be rolled out over the next year. Robin spoke about the facility reservation campaign that the Communications Department promoted as well as the Jack's Pond Nature Center grant funding story that was picked up by four different news outlets.

Tess told Commissioners it is important to build relationships with the community and its partners and she works hard to keep those relations strong with CSUSM and Palomar College. The City is creating a new partnership with the National Latino Research Center.

Chair Franklin thanked the ladies for coming to the meetings and said he is very impressed with all they do with such a small team.

Commissioner Lindsay likes the new signage on San Elijo Road entrance and asked if they will be putting up more of those. Tess answered that there are two entry signs and 9 wayfinding signs throughout the City and they hope to add more.

Commissioner Robles is looking forward to attending the State of the Community event to see what the Mayor has to say.

5. Annual Staff Report, Senior Center Nutrition

Recreation Coordinator, Catherine Manis told Commissioners the nutrition program has been making a difference in senior's lives since 1983 when the program started. The nutrition program has strict guidelines that need to be followed, menu items are approved by a dietitian, and surrounding cities work together on best practices.

The nutrition program hosts many events throughout the year including an over 90's party where the oldest senior wins free lunch for the rest of their life. Transportation is provided by the San Marcos Unified School District and the suggested donation is \$1 and they get 15 riders per day. Every month they print 1,000 newsletters and also email these senior contacts and post on the City website to attract more seniors to the lunch program.

Chair Franklin thanked Catherine for all that she does for the seniors and for the informative presentation.

Commissioner Robles asked if Catherine has an estimation of how many seniors live in San Marcos and what percentage take advantage of the center. Catherine noted the senior population of San Marcos is about 12 percent. The Senior Activity Center has about 500 visitors a day so it is an active center. Commissioner Robles would like to see the demographics of the visitors at the center and even county wide if staff has access to them.

Commissioner Smith noted the center offers so much activities and classes for the seniors in San Marcos far beyond what most cities offer.

6. Youth Sports Council Meeting Minutes, September 3, 2019

Chair Franklin noted the meeting went well and everyone stayed on task.

Commissioners reviewed the Youth Sports Council Meeting minutes included in the meeting packet.

Chair Franklin mentioned that Lori with soccer asked for volunteer assistance. Franklin would like to get ahead of the game and have a way the sports organizations to share their resources.

7. Trails Advisory Committee – Options Discussion

Chair Franklin and Vice Chair Lindsay attend the meeting.

Vice-Chair Lindsay noted there was lots of discussion about the options for the committee. Lindsay feels we are off to a good start as there is participation and interest in the committee.

Chair Franklin would like the January 8, 2020 meeting posted on social media so we can keep the momentum of the participation.

8. Special Events List and Social Media Posts

Recreation Supervisor, Cheryl Salazar noted that Zen City has its plus and minuses. The challenge is that the program doesn't capture everything we would like it to.

Chair Franklin liked the social media post for the Double Peak Challenge with the runners and it had several images that tell a story.

ORAL COMMUNICATIONS

Parks & Recreation Director Buck Martin provided an update on the following items:

- The tennis community is requesting more court access time in the morning as they feel pickle ball is taking over. Staff worked to increase the capacity at Las Posas and Connors Park and at Woodland Park courts we are currently working with School District to acquire more public access time on those courts.
- Palomar College is offering a Monster Dash run on October 19th.
- Patty Morton will be recognized at an upcoming meeting for her work with the Trails Advisory Committee.
- Parks and Recreation and Storm Water department are working together to get Discovery Lake cleaned up and aerated.
- Staff will be attending upcoming meetings on shelter management to better assist the community in the case of an emergency.
- The Double Peak Challenge has 638 participants registered which is about 30% more than last year at this time. An outside social media company was hired to market the event.
- The nutrition program is developing steps to minimize the carbon footprint and be a better partner with the environment.
- The San Marcos Street Fair is October 13th and staff asked Commissioners to sign up if they can volunteer in the City booth.
