

Chair Franklin and the Commission recognized Patty Morton who has been an active leader and philanthropist in the San Marcos equestrian community for more than 20 years. She has served on the Trails Advisory Committee for more than 17 years. She volunteers and serves as Board Chair of the Twin Oaks Valley Equestrian Association, she supports the San Marcos Historical Society, contributes to San Marcos High School Future Farmers of America, and volunteers with the Therapeutic Equestrian program with TERI.

Chair Franklin noted Patty is the glue that binds the equestrian community together in San Marcos and thanked her for her years of service in our community.

## **REPORTS AND OTHER BUSINESS**

### **4. Annual Report, SM United/Albion North**

Lori Schultz reported for the San Marcos United/Albion North as they are now affiliated with the Albion Soccer Club. They had 22 teams this year up from 16 teams last year. There club focuses on developing the individual players technical ability. They also focus on offering scholarships with over 20% of their players being on a scholarship. For next season they anticipate fielding 30 teams.

### **5. Friends of San Marcos Parks and Recreation Check Presentation**

Kathryn Gray, Chair of Friends of San Marcos Parks and Recreation, presented a check to the San Marcos Promise for their partnership and support in the Double Peak Challenge event.

Lisa Stout, Executive Director of the San Marcos Promise, accepted the award on behalf of the organization which is an education foundation serving all 21,000 students in the district. This event is a fun and challenging event for the City, and is the Promise is looking forward to it again next year.

### **6. Annual Staff Report, Friends of San Marcos**

Kathryn Gray reported on the Friends of San Marcos Parks and Recreation which is a group that was founded in 2013 to enhance San Marcos Parks and Recreation in San Marcos. They are a nonprofit 501c3 with 13 board members.

Each member reaches out to the community to assess the needs and wants of the community and determine how those will fit within the parks master plan. The Friends raise funds in several ways including board member dues, fundraising events, and grant writing. The organization has donated almost \$45,000 towards community recreation programs since its inception in 2013.

The Friends look forward to growing and prioritizing projects, and will work on expanding their marketing efforts to increase exposure and community recognition.

Commissioner Robles asked how people can attend or approach the board. Kathryn explained that the board meetings are published on the website and the community can engage with them via Facebook, directly contacting a board member or through parks and recreation staff.

Andrea Gonzalez updated the Commission on what is evolving with the committee. From the ten interested community members who came to the September meeting only two have submitted their application. Since then Patty Morton has announced she will no longer be involved and one other interested person said they do not have the time to commit.

Andrea noted we may need to revisit the options for the committee as we are having a hard time getting committed members.

Chair Franklin would like to see a social media post with application deadline being before the next Commission meeting to increase interest.

Commission Mockus feels if we can get a notice through CSUSM and Palomar College it would be great to have a student involved.

Commissioner Robles feels if there was a booth at the next hike to promote the Committee and hopefully recruit a new member. Commissioner Robles and Sensmeier will attend the December 7<sup>th</sup> hike.

**10. Special Events List and Social Media**

Chair Franklin asked if we had a yoga event and if we can get a word count generated from Zen City. Darren Chamow noted he will get more detailed information and email the Commissioners.

Commissioner Robles asked if there have been any changes or implementations with the social media posts with the new staff. Darren Chamow noted we haven't seen too much change with the social media posts but we have a meeting set up to discuss the department marketing goals and vision.

Chair Franklin questioned why the Mission Hills application workshop was posted but it did not include other schools. Franklin asked us to check with communications when they are asked to highlighting one schools submission could we be proactive and ask the other schools to include them in the post.

**ORAL COMMUNICATIONS**

Brandon Van Zanten, has been a resident of San Marcos since 2012. He is an avid skateboarder has an interest in bringing a new skateboard park to San Marcos fairly quickly. He would like to know what the process is to get that going in the right direction.

Chair Franklin suggested Brandon network with community to get additional collaborators to assist him because this is a major project and will need the entire skate community to move

forward. Franklin noted the first step would be to collaborate with like-minded individuals and get a social media following to support the idea. Chair Franklin thanked Brandon for being an active member of the community.

Parks & Recreation Director Buck Martin provided an update on the following items:

- Recently Kimberly Valdovinos and Evan Hoenig applied for a grant through the Community Foundation and they were awarded \$3,000 for improvements to the Nature Center.
- The City received a site visit for the Prop 68 grant. If we receive the grant money it will fund a 2-5 & 5-12 playground, an inclusionary universal playground, butterfly garden, and dog park. The City asked for \$5.4 million and should hear in early spring if they are awarded.
- The Friends of San Marcos donated additional funding for the mountain bike area plans.
- Commissioners are invited to the ground breaking of the San Marcos Creek District on December 11<sup>th</sup> at 10am.
- Cheryl Salazar was recognized as employee of the quarter by the City.
- December events include the Tree Lighting and Breakfast with Santa.

#### **COMMISSIONER COMMENTARY**

Commissioner Robles asked if any of the staff attend the conference in Long Beach. Director Martin noted that this year a number of staff will be able to attend because it is very close. Robles asked if there is precedent to have a Commissioner attend one day. Martin said yes he has considered that and it hasn't been done in the past because cost is always a factor.

Commissioner Mockus asked when the next round of playground improvements will be identified. Darren Chamow noted Bradley Park is next on the list but we are waiting to hear if we get the grant and then we will decide from there.

Commissioner Sensmeier has noticed people on the exercise equipment every time she drives by the Senior Activity Center.

Chair Franklin attended the Veterans Day event and noted that staff did an amazing job coordinating the event. Franklin also requested that parks maintenance is made aware of how much the commission appreciates their efforts in keeping Woodland Park pond so clean. Franklin looks forward to finding additional trails advisory committee members and sharing the corresponding social media post once it is available.




