COMMISSIONER SENSMEIER MOVED TO APPROVE CONSENT CALENDAR ITEMS 1 AS PRESENTED, SECONDED BY COMMISSIONER HERNANDEZ AND CARRIED TO APPROVE. ABSTENTION: SMITH.

COMMISSIONER SENSMEIER MOVED TO APPROVE CONSENT CALENDAR ITEM 2 & 3 AS PRESENTED, SECONDED BY COMMISSIONER SMITH AND CARRIED UNANIMOUSLY TO APPROVE.

REPORTS AND OTHER BUSINESS

4. Annual Report, Pop Warner Football

Ryl Relatores, Vice President for San Marcos Pop Warner Football presented to the Commission. He noted Pop Warner football had a slight increase this year compared to previous years although the cheer program did loose attendance and only had two teams this year. The program uses Sunset Park and Connors Park for practices August – November. Several football and cheer teams went to national competitions this year and did very well.

Challenges for the league include parental aversion to tackle football and the cost for competitive cheer. Volunteers are lacking and the program is having to run at two separate locations which presents logistical challenges..

Ryl designed a new logo for the organization that included the football and cheer side as well as representation of the two San Marcos high schools and the compass from the City of San Marcos so all three entities are represented.

Chair Franklin thanked Ryl for his service to the community and asked if he received a guide on how to submit forms or requests to the City. Ryl noted the organization secretary handles all of that.

Commissioner Smith asked if there anything Pop Warner can do to make the parents feel safer about the sport. Ryl said increased training for the coaches and NFL is now way more involved. San Marcos follows the national rules and recommendations which really makes a difference.

5. Stroller Strides Commercial Park Use Application

COMMISSIONER SENSMIEIER MOVED TO APPROVE STROLLER STRIDES COMMERCIAL PARK USE AS PRESENTED, SECONDED BY COMMISSIONER SMITH AND CARRIED UNANIMOUSLY TO APPROVE.

6. Youth Sports Council December Meeting Minutes

Chair Franklin attended the Sports Council meeting. He had a few questions for staff including the documents each group fills out and submits to the City and asked if there is a more efficient process for this. Andrea Gonzalez answered they are making all the documents a fillable form and will include those in the website link sent out to all the organizations. Franklin also asked about the field allocation process and Andrea explained how that works.

Chair Franklin asked if it is a requirement for the Youth Sports Council members to present to the Commission and it is a requirement in their handbook. Franklin would like staff to start tracking their attendance.

7. Youth Sports Council and Trails Advisory Committee Signup

One Commissioner is needed to attend the November 3rd Youth Sports Council Meeting.

8. Trails Advisory Committee Applications

Staff noted that the January hike was canceled due to the weather so Commissioners were unable to do an outreach for members. Commissioners discussed having a table at the February 1st hike to gain committee members. Commissioner Hernandez will attend the hike.

Commissioner Robles noted a need to look at other ways of promoting the Trails Advisory Committee because the City posts don't much "likes" or interaction from the citizens.

Commissioners requested the flyer for the Trails Advisory Committee be sent to them electronically so they can share it.

MOVED BY COMMISSIONER SMITH, SECOND BY COMMISSIONER HERNANDEZ AND CARRIED UNANIMOUSLY TO APPOINT TORREY OLSON TO THE TRAILS ADVISORY COMMITTEE.

9. Special Events List and Social Media

Andrea Gonzalez reported to the Commission that the department was granted access to setup a Facebook group under the City of San Marcos. It will be a public group in the next 30 days and Cheryl Salazar will oversee the group. She is currently adding members and organizations connected to the City.

ORAL COMMUNICATIONS

Parks & Recreation Manager Darren Chamow provided an update on the following items:

- Emergency Shelter and Cert training will be held on January 22nd at the Community Center.
- Tree Lighting and Breakfast with Santa went really well. The Mayor attended both events and each event went smoothly.
- A New Democracy in Action project will be beginning in January. We will be partnering with a geography class to do a community survey. The kickoff is February 11th and the final reports will be in April and Commissioners will be invited.
- At a recent council meeting recycling and sustainability was brought up. Our department is internally changing some practices like removing plastic water bottles from the classrooms and creating a sustainability plan for the Senior Activity Center to be more environmentally friendly.
- The Senior Activity Center was awarded a \$15,000 grant and they will use that money to replace furniture at the center.

COMMISSIONER COMMENTARY

Commissioner Robles appreciated the events being on two different dates. Robles heard the parade was really well attended this year.

Commissioner Smith attended the tree lighting and it was well attended and there were new vendors this year.

Commissioner Sensmeier will be in attendance at the holiday lunch at the Senior Center.

Commissioner Hernandez thanked all the Commissioners for their support.

Chair Franklin asked staff if we know the process on making a recommendation or asking for shade structures over the bus stops. Staff is pretty positive that North County Transit District is responsible for that. Franklin through research has learned that communities that are less affluent don't have the structures and they are the ones who use it.



GUIDELINES – JANUARY 15, 2020

SECTION 1 Purpose

The purpose of the Trails Advisory Committee is to advise the Parks & Recreation Commission and through them the City Council, of the multi-use trail needs of the City and on the implementation of the City Master Trail Plan. Further, the Trails Advisory Committee shall encourage community involvement in development, maintenance and use of the trail system including equestrian and bicycle lanes and pathways within the city.

SECTION 2 Duties

The duties of the Trails Advisory Committee shall include the following:

- A. Monitor the City's Master Trail Plan and submit recommendations for trails-related matters to the Parks & Recreation Commission.
- B. Identify existing and future needs for trail development within the city, including interconnections with regional trails outside the city's boundaries.
- C. Review existing trail and Ranger programs and standards, recommending changes as deemed necessary.
- D. Review the status of existing trails and recommend future improvements and additions to the trails system.
- E. Recommend priorities for trails development for budget consideration and grant applications.
- F. Seek out and identify potential new sources of funding for trail development, improvement and maintenance.
- G. Encourage and advise on citizen involvement in the use, development and maintenance of trails, including Reserve Park Rangers and docents, Eagle Scouts, school groups, interns, etc.
- H. Discuss and receive input from members of the public about trails-related matters.
- I. Educate the public about the existence and scope of the City's Master Trail Plan and related matters.
- J. Advise and recommend interpretive and educational information along trails, through the use of kiosks, trail signage and interpretive centers.
- K. Foster collaborative partnerships to create trail connections within San Marcos and surrounding areas with both private and government entities including, but not limited to, HOAs and San Diego County.

SECTION 3 Appointment

- A. The Trails Advisory Committee shall consist of at least eight (8) members, one of whom will be a member of the Parks & Recreation Commission appointed by that Commission, and the remaining to be community members (including at least one

(1) alternate) appointed through an application process by the Parks & Recreation Commission.

SECTION 3 Appointment (cont'd)

- B. Committee members shall represent diverse trail user groups of the community, be residents of the city, except that up to three members may be property owners in the City's Sphere of Influence area.
- C. Members shall serve at the will of the Parks & Recreation Commission.
- D. The Parks & Recreation Director and/or his/her designee shall be an ex-officio member of the committee and serve in an advisory capacity.

SECTION 4 Terms of office

Members of the Trails Advisory Committee appointed by the Parks & Recreation Commission shall serve a two-year term, with no limitation on the number of terms that may be served.

SECTION 5 Voting

Each Committee member shall be entitled to one vote. Approval of any recommendation requires an affirmative vote from the majority of the members present, provided a quorum of at least five (5) members is present and voting.

SECTION 6 Termination of Membership

If a member misses more than two (2) consecutive meetings of the Committee, without prior authorization from the Chair, such member shall be deemed to have resigned from the Committee, and the position will be available for appointment of a different member.

SECTION 7 Meetings

- A. Regular meetings of the Committee shall be scheduled at least quarterly, or more often as needed, at a time and place within the City limits which is agreed upon in advance by the Committee.
- B. Special meetings and sub-committee meetings may be called at any time by the Chair, provided that notification is given to all interested parties.

SECTION 8 Compensation, Financial Disclosure

The members of the Committee will serve without compensation, and will not be eligible to have expenses associated with membership, such as mileage, reimbursed. Given these restrictions, although Committee members are still subject to the provisions of the Political Reform Act concerning conflicts of interest with respect to

voting, Committee members will not be subject to the filing of California Fair Political Practices Commission Form 700, Statement of Economic Interests.

SECTION 9 Officers

- A. The Officers of the Committee shall be a Chair and Vice-Chair, selected by the membership of the Committee. Other Officers may be appointed as necessary to carry out the work of the Committee.
- B. The Chair and Vice-Chair shall be chosen annually by the Committee at its January meeting.

SECTION 10 Duties of the Officers

A. Duties of the Chairperson

The Chair shall preside at all meetings of the Committee, shall act as the Committee's liaison to the Parks & Recreation Commission, and shall act as spokesperson at other events or meetings as requested by the Parks & Recreation Commission. The Chair shall present annually to the Parks & Recreation Commission at a regularly scheduled monthly meeting.

B. Duties of the Vice-Chairperson

In the absence or incapacity of the Chair, the Vice-Chair shall assume all duties of the Chair.

SECTION 11 Ad-Hoc Committees

The Committee may create such ad-hoc sub-committees as the business of the Committee may require. Each shall be made up of at least one but fewer than a quorum of Committee members and shall have such authority and perform such duties as the Trails Advisory Committee may determine.

SECTION 12 Procedures

These procedures shall be reviewed and revised as deemed necessary upon direction by the Parks and Recreation Commission.
