Mr. Pedersen,

I am writing to object to this proposal and ask the Planning Commission to NOT approve this multi-family building project commonly called Mariposa Phase II.

The reasons that I think this project should NOT be approved by the Planning Commission are:

- The area where this project is proposed is already very crowded both in terms of both traffic (especially during the school day) and parking. There are already approved plans in the same area to add over 100 NEW affordable housing apartments that will add to the crowded traffic and parking situation in the area. The addition of the 66 new affordable housing apartments proposed by this project will put a significant strain on the roads and parking in this area.
- It is unfair to upscale subdivisions like Vallecitos Ridge where home values average over \$900,000 to continue to have more and more affordable housing units right outside their subdivision. The homeowners in subdivisions like Vallecitos Ridge bought their homes in good faith that their home values weren't going to be placed in jeopardy by the actions of the Planning Committee.
- Even before the nearly 200 additional affordable housing units (above what existed last year) are constructed, most of the crime in this area was concentrated around the existing apartments on Richmar, Marcos St. and Liberty Street, many of which were/are going to be affordable housing units. Addition of more affordable housing units in the same, concentrated area increases the risk of this becoming a higher crime area. Again, the impact on the more upscale houses in the area needs to be considered when adding low income housing to an area. There have been a number of car and house break-ins over the years in Vallecitos Ridge including one caught on video this past week in the subdivision.

In summary, it appears that the Planning Commission, most of whom appear to live in expensive houses (\$930,000 to \$1.3 million) in areas of San Marcos where there is no or only a small number of affordable housing units, are approving plans that concentrate the low income housing in one area, adversely impacting the quality of life for everyone in the area, but especially for those people living in upscale housing in the area. San Marcos had become one of the most desirable areas in North County to live. I know it is lucrative for the city and builders to take advantage of state incentives to construct affordable housing but simply adding more affordable housing to areas mainly because they are already zoned for apartments is very short-sighted and, in my opinion, unfair to people who bought homes in the area with that perception that they were moving into a good area. Affordable housing, if it is added in San Marcos, should be spread out, especially to areas that currently have little or no affordable housing and, preferably, to open areas such as the vacant lot at Woodward and Mission Road. Spreading out the affordable housing in San Marcos is not what appears to be happening and that should be changed.
