MINUTES

Regular Meeting of the Parks and Recreation Commission

CALL TO ORDER

At 6:06 p.m. Parks and Recreation Commission Chair Franklin called the meeting to order.

PLEDGE OF ALLEGIANCE

Chair Franklin led the Pledge of Allegiance.

ORAL COMMUNICATIONS

There were no requests to speak.

VOLUNTEER RECOGNITION

The Parks and Recreation Commission recognized Ashley Knowlton for her volunteer work with the City in creating a Junior Adventure booklet for children to enjoy their time outdoors.

Ashley thanked Kim Valdovinos for allowing her to work with the City on this project.

Commissioner Robles congratulated Ashley for remaining in Girl Scouts this long as oftentimes girls depart the organization in middle school and asked what has motivated her to continue on. Ashley said enjoyed seeing the impact she can make in the community and see the kids' smiling faces when they complete the project.

Commissioner Smith told Ashley her booklet is super cool and can't wait to do the project with her daughter. Chair Franklin told Ashley her booklet was the highlight of the City booth at the street fair. Commissioner Mockus-Valenzuela congratulated Ashley for accomplishing her goal.

CONSENT CALENDAR

Vice-Chair Lindsay noted under the Directors Report the sustainability ordinance sentence needs to be reworded and completed to be better understood.

MOVED BY COMMISSIONER MOCKUS-VALENZUELA, SECOND BY COMMISSIONER SMITH AND CARRIED UNANIMOUSLY TO APPROVE CONSENT CALENDAR ITEMS #1 & 2 WITH THE AMENDMENT TO #1 AS STATED.

3. Annual Staff Report, Senior Services

Jennifer Overman, Recreation Supervisor gave the presentation.

Jennifer told the Commission this is her first report for Senior Services since she was moved over there in June of 2020 through now. Since the shutdown meals have been delivered to seniors Monday – Friday throughout the whole pandemic. The center continued to offer the catch a ride program, drive up puzzle check-out, book exchange, and virtual bingo. Right before the State opened back up they were able to have an ice cream social outside and more than 50 seniors attended and really enjoyed their time.

The phased reopening began on June 15th where the center opened the doors and provided a congregate meal in person. In July and August they added group classes back to the schedule, other passive activities, staff-led activities and monthly events.

A Mix and Mingle event will be held on Friday, October 22nd and it is the first after hour's event since reopening. They will have a live band "Retro Station" playing at the event.

Since the building was closed, Jennifer and the staff went through every closet and room, organized everything and cleaned everything from top to bottom. They replaced the furniture in the Horizon Room where the seniors eat lunch. They purchased new furniture for the hallway and library. All the signage in the building was updated and new bookcases were purchased.

Jennifer received a grant through the San Diego Senior Community Foundation for a program called *Connecting Seniors with Technology* and they purchased 25 LG tablets and Verizon internet plans. Participants had to be 65 or older, a San Marcos resident and meet the HUD income guidelines. Jennifer held tutorial classes and helped the seniors set up their tablets so they could communicate with family and friends during the pandemic.

Chair Franklin thanked Jennifer for the work that she does and she clearly is doing a great job for the community.

Commissioner Smith said the Senior Center really included the seniors as much as they could through the pandemic and glad it worked out so well. The technology component was a huge lifesaver for those seniors and she feels that really helped them stay connected.

Commissioner Robles said the Senior Newsletter is amazing and is so colorful and easy to understand. Robles asked if the Senior Center has ever been open on Saturday or Sunday's. Jennifer said yes it has been open on Saturday mornings in the past for a few classes like Zumba. Robles asked how they reach the hard to reach seniors or those who may not have a sense of belonging when they are there. Jennifer noted just getting people there is the hard part and once they come to the center they see how fun it is.

Vice-Chair Lindsay thanked Jennifer for her presentation and thanked her staff for providing what they did for the seniors as that was beneficial to their wellbeing. Lindsay asked if the ride service dropped off. Jennifer said they did still offer catch a ride through FACT and also had taxi script available but the lunch transportation through the School District did stop as seniors weren't attending lunch in person at that time.

Chair Franklin had a question about aggregated data and asked if we are capturing ethnicity of the participants in contractual classes. Jenifer noted we do not ask that for classes. Franklin asked if it was asked for the tablet program. Jennifer said she thinks it was a question but she didn't tabulate it. Chair Franklin asked what effort is being done in targeting communities that don't see themselves at the center. He mentioned that if we aren't gathering the data, we could be missing out on grant opportunities. Jennifer noted she has discussed visiting communities in the area especially in the Richmar area. Chair Franklin asked staff to see if other cities collect this data.

Commissioner Mockus-Valenzuela noted it would be good to collect that data to see who were are serving and reaching and what race and ethnicities ratios.

4. Trails Master Plan Update

Doug Grove, RHA Landscape Architects gave the presentation.

Doug has had the oversight of the Trails Master Plan (TMP) since 2016 and we have had 11 iterations since the start of the project and he is happy to present the final update tonight. The first TMP for the City was implemented in 1991. All existing and future trails were added into the plan after several meetings with the Trails Advisory Committee, City Staff, community residents and stakeholders were conducted.

Doug reviewed existing trails, regional connectivity, high impact locations, low effort locations with current access and future access, proposed trails, updated map, trails removed, priority rankings and a cost summary.

Chair Franklin thanked Doug for his thorough presentation. Chair Franklin asked if single track trails were identified. Franklin thanked Doug for sharing lots of information. Doug noted yes some are identified and there was more originally and they are listed in the plan as soft surface trails for the most part.

Commissioner Sensmeier said it is an amazing plan and asked if the Creekside project that is underway now is included in the analysis and what the impact of that is. Doug noted that it is included in the plan along with any other developments that the City is aware of at this time.

Commissioner Sensmeier noted that the Commission recently reviewed a proposal for e-bikes and asked if this plan is relevant to that proposed e-bike ordinance. Doug noted that the discussion did come up in the meetings and as part of this plan it does not need to be included in the document.

Vice-Chair Lindsay noted a new County Park is being built between Questhaven and Elfin Forest and our City trails may not be connecting to this but asked if there was any discussion on that area. Doug noted he was not aware of that park and that area has no planned trails in the plan but it could be added if needed. Lindsay asked once this plan is approved is there an administrative barrier to make changes to it in the future. Doug noted he doesn't believe so. Staff noted he will ask the Planning Department and get back with the Commission.

Commissioner Mockus-Valenzuela noted it could be as simple as adding in a disclaimer in the plan about changes may need to be prioritized.

Chair Franklin noted the date on the plan is June 14th and asked if there has been any changes since then. Doug noted that date was referring to the cost estimate and the actual plan right now is dated October.

5. Trails Advisory Meeting- October 13, 2021

Chair Franklin was present at the meeting and the minutes included in the packet captured everything discussed.

6. Park Naming Recommendation

Director Martin told the Commission that the name Gratitude Park is off the list as the person who sent it in has rescinded it.

Chair Franklin asked when the Highlands Project was approved and is shocked that the project is coming to the Commission at such a late stage. The Commission would like to request all developments that have been approved with a park amenity to be provided on an annual basis so they can request when a park naming opportunity will make it to them as a recommendation.

Commissioner Mockus-Valenzuela agrees with that as it will give them planning time as things come down the pipeline and we may have redevelopments coming to us as well and having a place holder name signals to the developer and the community that they will have a say in the naming.

Commissioner Robles shared the naming post with her community of Santa Fe Hills and some of the comments were that the park will already be called "Highlands".

Commissioner Mockus-Valenzuela would like to have a committee to review the names and reasoning behind them and she volunteered to be on the committee. Commissioner Robles and Vice-Chair Lindsay also volunteered.

7. Programming for 12-18 Year Old's

Commissioner Mockus-Valenzuela provided two pages of information from her research for the 12-18 teen programming. She discussed social equity in teen programming and also why teens often times don't participate and how to overcome that. She suggested broadening the programming offered and teens don't have money to pay for the programming so it should be low cost or free. Teens want a safe place to hang out and programming ideas include having equipment available for them to check out, cultural programming, job support, technology support and late night programming/events that the teens could be involved in.

Director Martin noted our department along with the Youth Commission have done teen programming with the County and SD Nights and we did have some success with it and we are looking at collaborating with the Respect Program with the Sheriffs. City of San Marcos donated a location in the Richmar community for to the Boy's and Girl's Club who will offer teen programming. We have also started our first ever E-Sports program with over 30 participants. The Youth Commission is meeting to set goals for themselves and the community.

Chair Franklin researched some programming in Los Angeles and Carlsbad areas which offered STEAM and leadership programming for teens. Franklin suggests that we provide all this information to the Youth Commission so they can begin to implement some teen programming. Franklin also suggested Parks and Recreation apply for more grants to capture the funds to provide the programming.

Commissioner Mockus-Valenzuela noted we are failing this age group of kids and we may need to look at this on a long term ongoing task. The City does so well on so many aspects with seniors and younger programming but we need to learn how to engage the teenagers in our community.

Commissioner Robles noted we already have many resources but the key is engagement and community outreach is highly needed. There is a need for scholarships for families to be able to pay for the programming offered.

PARKS AND RECREATION DIRECTOR REPORT

Director Buck Martin gave updates on department events and other items including ordinance change for E-Bike trails, social media post about 4th of July correspondence to the community, Community Neighborhood Grant through the County to help fund our bike park project, Spring Egg Scramble planning is underway and with the single use plastic ordinance underway we are getting creative on how to be more eco-conscious, the Breakfast with the Littlest Pumpkin event went well, Ride and Stride event with TOVEA said they had a good turnout. Upcoming events include the Halloween Party at the Wood House, teen scary movie event at the Wood House, the November Hike, and the Veterans Day Ceremony.

PARKS AND RECREATION COMMISSIONERS COMMENTS

Commissioner Robles suggested changing the summer hikes to earlier to beat the heat and not have to cancel them due to heat. Director Martin noted we will discuss this with Taylor and see what options we have.

Commissioner Sensmeier saw the fireworks posting and thanked staff for making sure that the community was updated. The street fair was packed and she did get a few questions that she didn't know the answer to, including dog parks.

Commissioner Prestinanzi asked if we have given it thought to have an evening hike in the summer to beat the heat. Director Martin said the Star Walk event is held in the evening and they had over 150 people in attendance last time so that is something to consider.

Commissioner Robles had a booth at the Street Fair for the San Marcos Prevention Collation and stated that there was so many dogs that next year she will have a dog water bowl to attract the owners. The Collation is hosting a breakfast at the Project Respect facility on Carmel and typically have the attendance of community members and leaders on the third Thursday of the month at 8am and said she will send out an invite.

Chair Franklin asked if there will be an update on the Bradley Park bike park as we are seeking grant money. Director Martin noted we have reached out for grants as this project will cost more than what is currently allocated and we can report out on this in the next few months. Chair Franklin asked for a higher level annual report of revenue and expenditures and Director Martin said Evan Hoenig reports on this annually.

YOUTH SPORTS COUNCIL MEETING

Tuesday, November 2, 2021

1 Civic Center Drive

Attendance: All members present except San Marcos Youth Basketball, San Marcos Youth Rugby and San Marcos Pop Warner.

Staff present: James Daza and Eric Leichliter.

Parks & Recreation Commissioner: Jay Franklin

Call to order

James Daza called the Youth Sports Council meeting to order at 6:08pm.

Approval of Minutes

Torry Schoch (San Marcos Youth Lacrosse) motioned to approve the minutes from the September 7, 2021 meeting. Buzz Byer (San Marcos Girls Softball) seconded the motion.

Motion carried 8-0.

San Marcos Unified School District Update/Facilitron

San Marcos Unified School District updates were provided by Peter Jenkins.

Peter stated that San Marcos Unified School District is planning to do more maintenance between sports seasons to try to improve their field conditions at various school sites. He is trying to work with the middle school athletic directors to get dates set that they may be able to close fields to perform the extra maintenance. Multiple YSC members stated they have been having issues with their insurance documents getting denied through Facilitron. They stated that they followed the School District guidelines and had to submit forms multiple times before they were approved. Doug Scharin (San Elijo AYSO 1505) notified Peter that they have had multiple instances during the fall season where they would show up for practices or games to find that the school had double booked school activity with San Elijo AYSO 1505 approved permitted time. Doug stated that he was never notified about the Double Peak School Carnival and had to cancel games after learning about it from one of the parents of a league participant.



James notified Peter of some parking issues at Hollandia Park due to a lot being closed at Mission Hills High School. Parents picking up students have been lining their cars along a red curb leading to the upper parking lot at Hollandia Park which has caused one way traffic to enter and exit the park which poses a safety issue. There has also been parking from football games on Friday evenings and cars have been in the lot after hours. James has notified SMUSD staff but there has not been any resolution.

Sport Field Updates

City sports field updates were provided by Stew Rutledge.

Stew stated that the infields at Field 4 and the North softball field at Bradley Park will be laser leveled in early January. Actual dates are dependent on the contractor availability and any inclement weather we may get. Stew stated that the scoreboards at Mission Sports Park are in the process of being repaired and upgraded to new parts. Stephanie Walker (San Marcos Youth Baseball) asked Stew about any improvements that they may be able to do to prevent the fields from being closed for so long after rain. She also notified Stew that the foul lines do not seem to be painted regularly like they are supposed to. The Connors Park multipurpose field recently had the excess rubber removed to improve field conditions. Stew and James stated there is about a year and a half left in the life of the turf before it will need to be replaced. Stew reported that the multipurpose fields are showing wear and tear and the traditional field closure during January through February will benefit all fields. Stew notified all soccer groups that there is some work taking place on the well system at Cerro de Las Posas Park and they may see barricades and caution tape near the field. Buzz Byer (San Marcos Girls Softball) asked Stew for instructions on how to operate the infield watering systems at Bradley Park Field 5, North and South. Stew stated he would follow up with Amanda Haas to get instructions on how to operate the watering systems.

James informed all members that the City is planning to continue with the traditional lighted multipurpose field closure from January 1, 2022 through February 28, 2022.

Park Rangers

James provided the Park Ranger hotline phone number (760-744-9494 ext 3707) to all members. He reminded all members that if they need assistance with another organization on their allocated fields to contact City staff or the Park Ranger hotline. If they encounter any



public safety issues at the parks to contact the Sheriff's Department non emergency line (760-510-5200) or 911 depending on the severity of the incident.

Snack Bar Keys

James reminded all members to provide City staff a copy of any snack bar or storage room key if they have changed it. Staff needs a copy in the event that any repairs need to take place and for the Fire Department volunteers to check all AED's that are locked in the snack bars.

Spring/Summer Field Allocation

James reminded all members that field request forms for the Spring/Summer 2022 field allocation are now due. He reminded all members that the allocation will be released the third week of December. James reminded all club soccer organizations that all tryouts will have to take place on their allocated nights.

Walnut Grove Parking Issues

James reminded City SC and other soccer members that the City has received complaints from park goers about illegal parking occurring near the north entrance to Walnut Grove Park. Sean Houshmandi (City SC San Marcos) told James that they have been posting signs there stating no parking and it has helped but there is still one or two vehicles a weekend that park there. City SC has also been posting signs at the horse park entrances stating no parking for soccer participants.




