**Re: Comment on Addendum to the University District Specific Plan Final EIR (SCH No. 2008101083) for University District Specific Plan Amendment (SP21-0002 / SP22-0002 / GPA21-0005 / SM21-0002 / SDP21-0003)

Dear Honorable Planning Commissioners and Mr. Piñon:

I am writing on behalf of Supporters Alliance for Environmental Responsibility (“SAFER”) regarding the University District Specific Plan Amendment Project (SP21-0002 / SP22-0002 / GPA21-0005 / SM21-0002 / SDP21-0003), including all actions related or referring to the proposed construction of a 484-unit, 12-story mixed-use project with 18,741 square feet of ground floor commercial space at the northwest corner of Campus Way and North City drive; a 25,000 square foot grocery store with 55,000 square feet of office space at the southeast corner of Carmel Street and Campus Way; and a 73 apartment unit, 5 story mixed-use project with 4,812 square feet of commercial space on the east side of Campus Way (“Project”), to be heard as Agenda Item 2 at the Planning Commission’s June 6, 2022 meeting.

SAFER objects to the use of the Addendum to the University District Specific Plan Final EIR (SCH No. 2008101083) prepared for the Project. Under the California Environmental Quality Act (“CEQA”), an addendum is not appropriate because the Project is not within the scope of the prior program EIR and there is new information available since certification of the 2002 EIR indicating new significant impacts and/or the availability of new mitigation measures. Therefore, SAFER requests that the Planning Commission decline to approve the Project at this time and, instead, direct staff to prepare an EIR for the Project prior to any approval.
