# MINUTES

## Regular Meeting of the Parks and Recreation Commission

### **CALL TO ORDER**

At 6:00p.m. Parks and Recreation Commission Chair Franklin called the meeting to order.

### **PLEDGE OF ALLEGIANCE**

Chair Franklin led the Pledge of Allegiance.

### **ORAL COMMUNICATIONS**

Director Martin introduced our newest staff member, Stacy Armacost, Senior Management Analyst and noted Stacy came from the private sector and the department is fortunate to have her as she handled everything from sales, marketing, and day to day operations. Stacy noted she worked for 21 years at Casa De Las Campanas and was the Director Administrative Services and Sales and Marketing. She has been here 7 days now and toured some of our parks and facilities and she looks forward to working with the Commission in the future.

**3. Annual Report**

Buzz Byer, San Marcos Girls Softball, gave the presentation.

Buzz Byer noted he is the president of San Marcos Girls Softball (SMGS) and they have more enrollment now than pre-covid numbers. They are continuing to market or target underserved areas in the community to get the word out about the program. They offer sponsorships to families in need through local sponsors and fundraising. SMGS board is going to work with Cal State University on a marketing plan for the club.

They hold Opening Ceremonies every year and they have a great time with a bounce house, picture booth and food. All Star season went well and two teams went to Nationals this year and both finished in the top 10 in their tournaments.

Buzz noted that Bradley Park is a blessing and a curse for SMGS as they have enough fields at the park to use but the upper level fields and the restrooms do need some work as they get clogged easily as the park is on a former landfill. He works closely with Public Works and James and Eric whenever there are issues.

Chair Franklin thanked Buzz for sharing everything that goes into SMGS and he thinks it's an awesome opportunity to leverage the CSUSM senior experience program as it will only strengthen SMGS.

Vice-Chair Lindsay asked if they have any field availability issues or constraints? Buzz noted it's a blessing with Bradley Park is perfect for Girls Softball and they don't have any issues. Buzz noted with the maintenance issues they are working through that and getting creative.

Commissioner Mockus-Valenzuela asked if the club engages with kids who are 14-18 and are aging out of 14U. Buzz noted with the older the girls it gets challenging as the girls often go play travel ball or they don't have enough interest or player positions to build a team, so they do reach out to other clubs to keep the girls playing.

Chair Franklin appreciates all the work and effort his organization is doing for the community. Franklin asked if he has seen any improvements after you have addressed it with the City. Buzz noted for some time yes, and they have done some diagnostics of the issue so what we have done in the meantime is hire Tegriscape to be on hand to tend to the restrooms.

Chair Franklin asked how old Bradley Park is and the restroom? Director Martin would guess 1960s but he will check on that. The County gifted San Marcos the parkland. Martin noted that Buzz does an amazing job with his organization and the City is working closely with him and the board with the upgrades at Bradley.

Commissioner Robles appreciates the scholarship offerings and asked if there is a system in place for donation of supplies like gloves, bats etc. Buzz noted equipment donation happens at the park and they email two years of participants and layout all the donations and families can pull from that. The club now has a fundraising seat on the board so they are doing more fundraising and this will help with the financial burden on the travel costs.

#### **4. Park Naming Policy Update**

Director Martin said the naming policy is with the City Manager's Office and he will provide feedback as it comes.

#### **5. Q4 Statistics Report**

Commissioners reviewed the statistics and asked questions and staff answered.

#### **6. September Meeting Cancelled**

Director Martin noted the September meeting will be cancelled as he and Andrea will be out of town at a National Parks and Recreation conference in Arizona.

### **PARKS AND RECREATION DIRECTOR REPORT**

Director Buck Martin informed the Commission on department events and updates including department personnel changes and new hires that happened over the past month. Two full time recreation leaders were hired are Judith Herrera and Erin Rimmereid and they were both longtime part time staff for the City.

The Summer Passport program is coming to an end and we redeemed about 175 prizes redeemed but we passed out 450 passports in English and 60 in Spanish so they will continue to be redeemed.

An email from the City Manager's office was released to the Department Directors providing an update on the construction of sports fields at the Rancho Tesoro site that will hopefully be available to the public early 2023. The email stated questions have come up regarding the naming of the park and we believe it is premature to get in a discussion about that and the conversations would be far more appropriate once we have a master plan of the park completed and are ready to build the whole project. In the meantime for purposes of listing the site and allocating the future fields we will be calling them "Rancho Tesoro Fields". Director Martin noted this is a placeholder name and the park will not be officially named until we have a completed park master plan.

The department is working on the RFP for next year's 4<sup>th</sup> of July fireworks show and we hope to get the same contractor to do it again. The Family Campout had over 200 participants and it was a great event ran by the youth programs staff. Junior Ranger Day was held last Saturday and it was a hot day but well attended. Vallecitos Water District will be paying for the transportation to the Nature Center field trips for Title 1 schools and the Friends will pay for the field trip entrance fee. October 16<sup>th</sup> will be the TOVEA Horse Heritage Day at Walnut Grove Park. Other events in August include a Movie in the Park, Summer Concert, Star Walk and the Double Peak Challenge on September 24<sup>th</sup>.

Vice-Chair Lindsay asked about the Park Naming Policy as we asked for some changes. Director Martin noted it is still in the City Manager's Office and they are working on it. Vice-Chair Lindsay noted he will contact the City Manager's Office.

Commissioner Mockus-Valenzuela wanted to circle back to the park playgrounds that will be updated this fiscal year and she knows some parks have been updated but is interested to see what is next and what pocket parks will be refreshed. Director Martin knows Public Works usually can redo 2-3 parks per year depending on the size of the park but Buck will ask to see what park is next.

Director Martin wanted to let the Commissioners know we have a challenge again with the Double Peak K-8 school as they are having a construction project that closed their parking lot so they asked to use the ridgeline trail head for drop-off and pickup times and we are in a compromised position with access and keeping people safe so we are working with the proper organizations.

### **ORAL COMMUNICATIONS**

Commissioner Mockus-Valenzuela said that the Woodland Park pond looks so clean and beautiful.

Commissioner Diaz asked if it is possible to provide the Commission minutes from past years in one place. Staff will check to see if we can provide the past minutes to Commissioners and provide them access.

Commissioners Smith said her daughter loved the passport program and enjoyed visiting the sites.

Commissioner Sensmeier noted she will be at the Youth Sports Council on September 6<sup>th</sup>.

Vice-Chair Lindsay noted that the time change of the summer hikes was well received and attendance did not drop off. The Star Walks have been so successful that parking has become an issue which is good news and bad news. Lindsay asked where we are at with South Lake. Director Martin noted it has been several years of no movement but we are hopeful that something will progress in the next 6 months.

Chair Franklin noted a hike around South Lake could get the community interested in that area and could spark something. Franklin noted he appreciates the internal growth and remembers we used to have a grant writer and asked if there is someone to advocate for grants. Director Martin noted that is part of the plan and delegated to the department analyst. Chair Franklin and Sensmeier will attend the upcoming General Plan meeting.

The Parks and Recreation September meeting will be canceled.

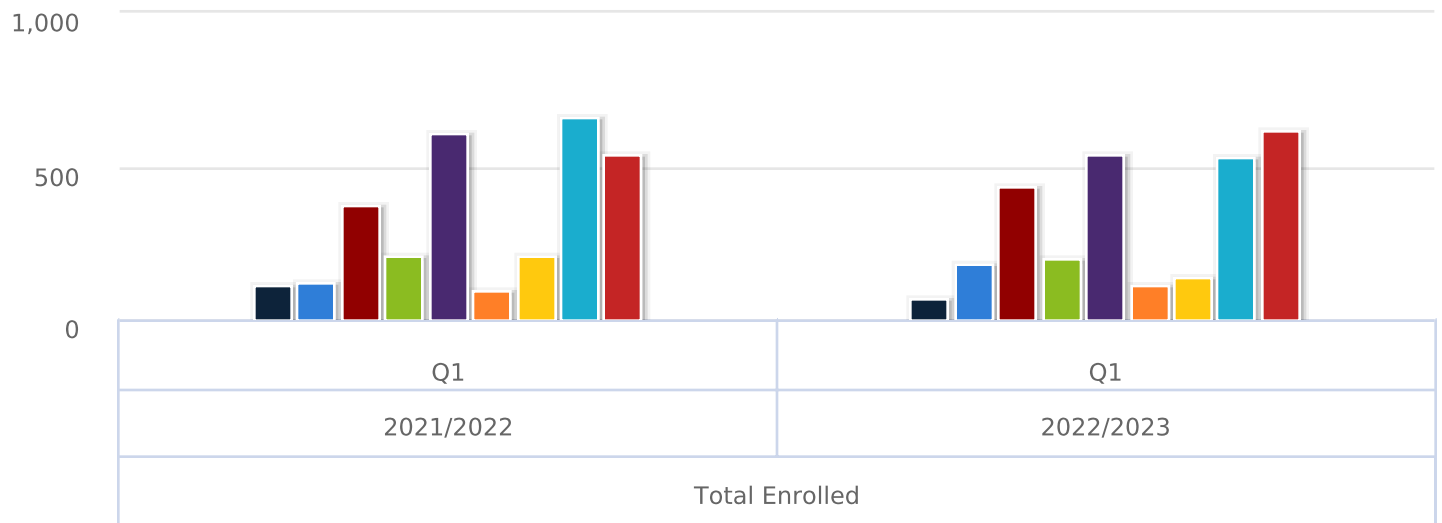

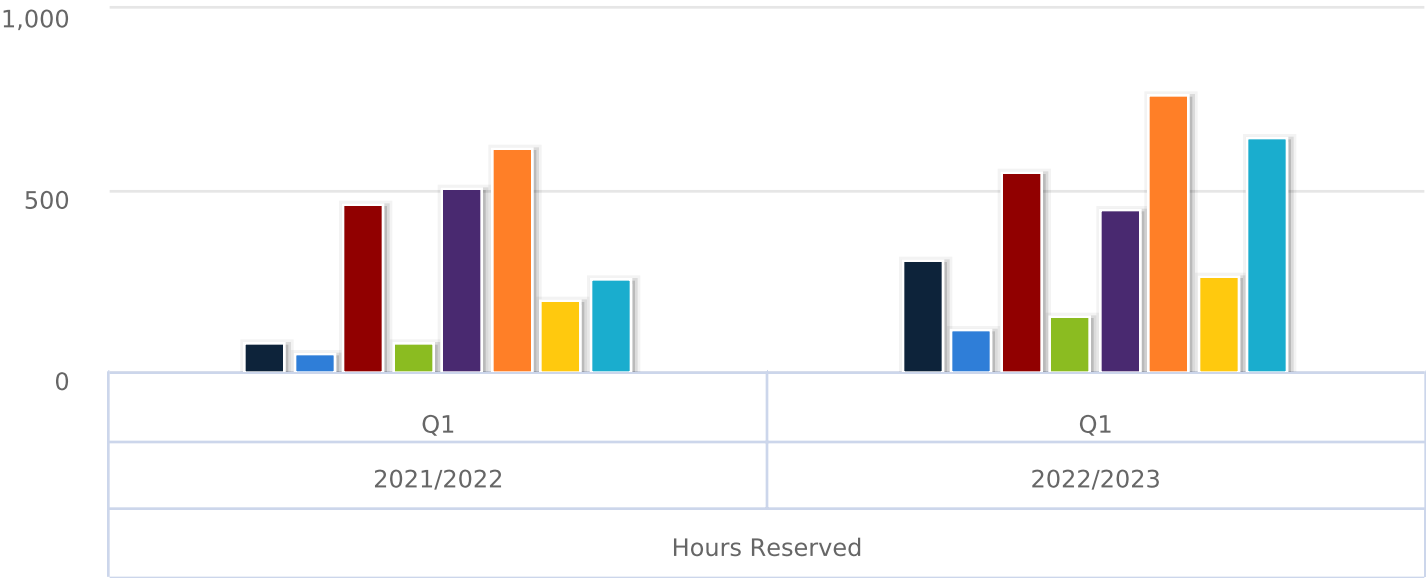

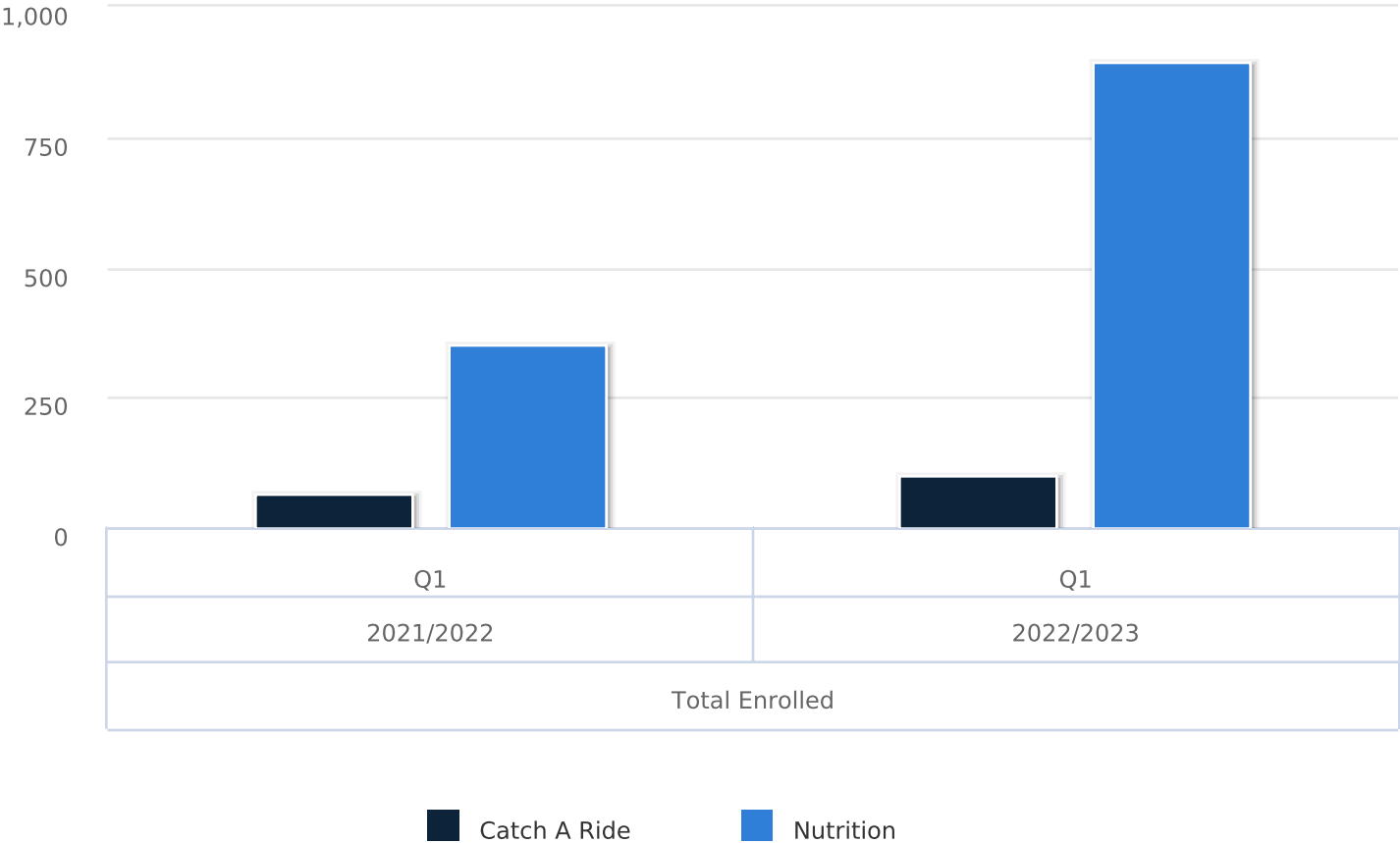

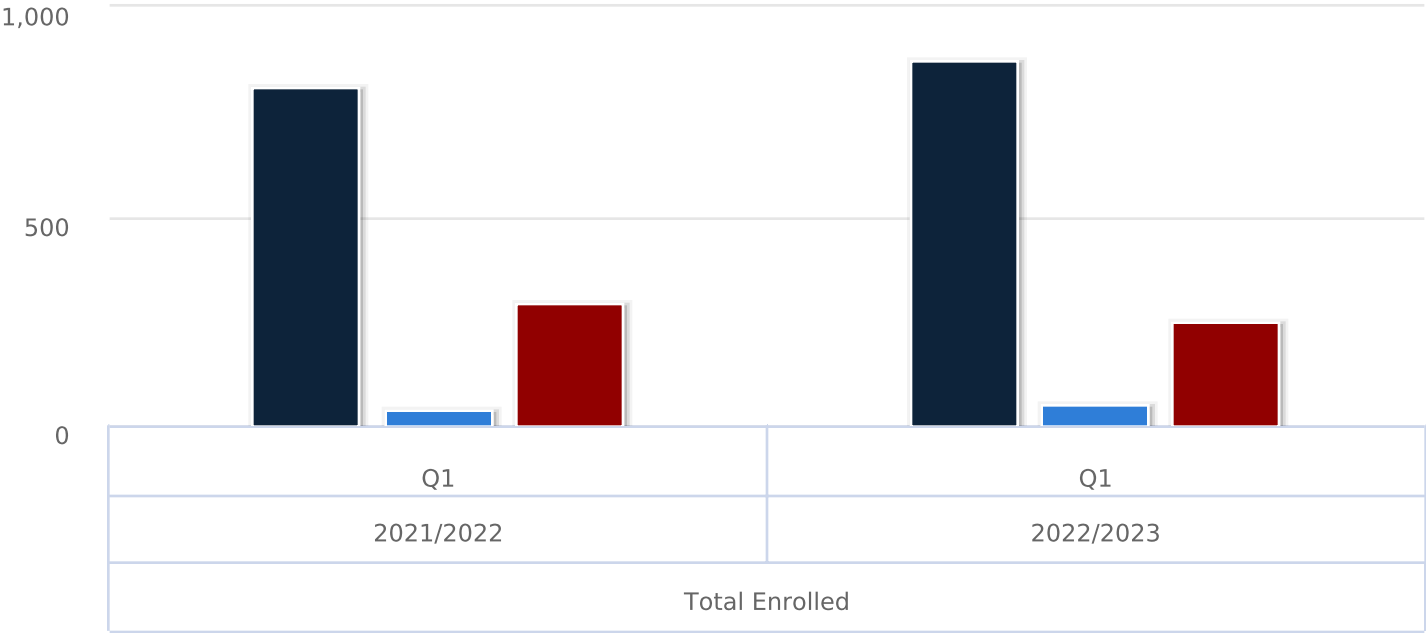

### **Sport Field Updates**

The sports fields update was given by Amanda Haas.

Amanda informed all members that:

- MSP field 4 scoreboard has been rechecked and is operational.
- Connors netting replacement project has been pushed back from September to October.
- Multicourt resurfacing project is complete. Connors Park turf replacement project is on track for December installation.





- Bradley field 4 outfield grass releveling project is complete. Approximately 55,000 square feet of sod installed.
- Sunset and Bradley arena netting replacement project is complete.
- MSP windscreen replacement project is almost complete, field 2 is left to complete project.

**CALL TO ORDER:** Parks & Recreation - Recreation Supervisor, Taylor Oshinski, called the meeting to order at 5:57pm.

### **ROLL CALL:**

City of San Marcos Staff: Taylor Oshinski and Hugh McMenamin

Not Present: John DeBevoise and Mary Stanford

### **OLD BUSINESS**

1. Taylor welcomed all in attendance to the October 12, 2022 TAC meeting. All members were present with the exception of John DeBevoise and Mary Stanford. Torrey Olson also joined as a guest until his application is approved by the Parks & Recreation Commission. Taylor explained that staff members would be looking down at their notepads/laptops while members are speaking so notes can be accurately documented for meeting minutes. He also wanted to ensure that members don't hesitate to ask questions if they have them. Round table introductions were conducted at this time since new members have joined and the group has not met for one calendar year.
2. Taylor notified the TAC members that an email will be sent seven days prior to each meeting. He requested to receive feedback if you are unable to attend the meeting. Commissioner Franklin requested an email be sent two weeks prior requesting agenda items from the members. All meetings for 2023 have already been scheduled and are available on the first page of the agenda. Meetings will be held quarterly from 6pm-7pm at the San Marcos Community Center.
3. Taylor stated that Vince from SDHC has been notified of the pampas grass concern David Simpson reported in the Double Peak Park area since these are not in City maintained areas. Taylor stated what the Rangers responsibilities are concerning opening and closing of parks, providing enforcement at the 38 parks and 70.5 miles of trails and assisting the Parks & Recreation Department at Special Events. He informed the group that our Rangers do not perform maintenance and the City has a Public Works team and multiple contractors. Randy Smith asked about P Mountain trails. Taylor responded that it is not the City's jurisdiction and it is private land. Calls should be made to SD Sheriffs for enforcement. David spoke about broken lodge poles around Double Peak trails. Taylor said to send him photos and a location on a map and they can be repaired by Public Works or contractors. Travis Lindsay clarified that attendees such as Torrey Olson should be able to speak but not act in an official capacity on the Commission at this point. Torrey then introduced himself and commented on lodge poles.

David spoke about the Belgian Waffle Ride and trails coming out of Stone Canyon development that were not clearly marked as the route. Taylor said BWR was responsible to mark the route on those trails and lacked signage, didn't provide volunteers and didn't adhere to the conditions of approval in the City approved Special Event Permit. Taylor explained that the City Rangers had to step up due to the lack of BWR staff and volunteers. Travis commented that BWR has improved over the years but still has some work to do. John commented on map boxes attached to kiosks and their ongoing condition and maintenance. Taylor stated that PW will perform minor maintenance to kiosks, but will not perform ongoing maintenance to Eagle Scout Projects, which include map boxes. Randy clarified that BSA and Eagle Scout projects of these types are not responsible to repair them either after completion. Travis confirmed the fact through his statements. Travis and Randy suggested that an alternate plan for ongoing maintenance needs to be developed, as well as alternate designs for trail map boxes. Randy commented that these could possibly be new Eagle Scout projects or team building days with the troops. Travis mentioned a problem on the Garden Trail above San Elijo Elementary School near Questhaven Rd. It has become a party spot for what appears to be teens. Taylor suggested that photos of problems always be sent to him so he can get them addressed with Public Works. David asked about locations of dog bag dispensers around Discovery Lake trails feeling there were not enough. Taylor identified where they are around that area. John Walsh mentioned that parent drop off and pick up from Double Peak School is still a problem at Ridgeline Trailhead. Taylor stated that Rangers are no longer present during drop-off and pickup and many City departments have reviewed this item: Parks & Rec, PW, Risk, Traffic, Engineering and City Attorney.

## **NEW BUSINESS**

1. Taylor provided an update on the status of each TAC member's terms. Taylor then read off all member's active terms and his or her end dates as follows: Torrey O. – 1<sup>st</sup> term expired. Awaiting 2<sup>nd</sup> term approval at October 2022 Parks & Rec Commission mtg. Olga F. – 1<sup>st</sup> term expires August 2024. John W. – 2<sup>nd</sup> term expires August 2024. David S. – 2<sup>nd</sup> term expires August 2024. Randall S. – 1<sup>st</sup> term expires August 2024. Mary S. – 1<sup>st</sup> term expires March 2023. John D. – 1<sup>st</sup> term expires March 2023. The agenda item of selecting Chair and Vice Chair was tabled until next meeting. Jay asked that role descriptions and guiding documents be made available to TAC members to share with the public and those interested. Taylor let the group know that he would include those in an email prior to the January 2023 meeting.
2. Taylor stated that two years ago the Trail Etiquette & Guidelines project was started and gave background to its development and current status. John W. asked if a different format can be discussed. David suggested simplifying it. Travis stated the initial concept of the brochure and why it has the current design and that it was for the communication of information to the public. He still believed this purpose was important to its existence. Travis, Jay, Randall and Olga all suggested several other ways to educate the public on trail etiquette. QR codes were discussed as a positive way to accomplish this. Taylor explained that the City does not plan to use QR codes as they have dealt with broken QR codes on trail marker signs in the past. The issue of e-bikes on trails was raised especially around Walnut Grove Park, and how to enforce and educate the public on use and

etiquette. Taylor asked that everyone please review the brochure for discussion at future meetings. Taylor notified the group that he would reach out to Mary S. and John D. to remind them of this project since they represent the equestrian community and how this group values the perspectives and input of all trail user groups.

3. Taylor described the City Hikes that occur the first Saturday of each month. The majority of the hikes take place at City of San Marcos trails and parks but also access surrounding City's trail systems so hikes do not become too repetitive. Taylor gave stats on attendees, length and duration of a typical hike series. He invited TAC members to attend the hikes and get informed. David requested to be added to the hike distribution list so he can attend future hikes.
