1. Approval of Minutes, 11/16/2022

MOVED BY COMMISSIONER MOCKUS-VALENZUELA, SECOND BY COMMISSIONER SENSMEIER AND CARRIED TO APPROVE CONSENT CALENDAR ITEM #1 AS PRESENTED. COMMISSIONER DIAZ ABSTAINED.

2. Approval of General Facility Scheduling, 1/19 – 2/15/2023

MOVED BY COMMISSIONER SMITH, SECOND BY COMMISSIONER MOCKUS-VALENZUELA AND CARRIED UNANIMOUSLY TO APPROVE CONSENT CALENDAR ITEM #2 AS PRESENTED.

REPORTS AND OTHER BUSINESS

3. Annual Report- City SC Soccer

Sean Houshmandi President of City SC gave the presentation.

Sean reported highlights from the 2022 season including their mission and vision for the club and the importance for sportsmanship within the league.

They have a recreation program with fall, winter and spring arena soccer. They offer competitive league play year round and also offer a TOPS program for youth with special needs. The recreation program had 115 teams with 1,332 players. The competitive program had 38 teams with 553 players.

City SC offers scholarships, they are involved in the community and host tournaments a few times a year. Sean also reviewed the objectives for the 2023 year.

Commissioners asked questions and Sean answered.

4. Annual Staff Report- Year In Review

Andrea Gonzalez, Assistant Director, gave the presentation.

Andrea reported on the department accomplishments and completed projects this past year. Andrea reported on new programs and events that include a trail champion program, a sports and swim camp at Las Posas Pool, Zumates class at Senior Activity Center (SAC) and added theater workshops at the Community Center.

Projects that are on the horizon include new artificial turf at Connors Park, re-surfacing of the pickle ball courts at Innovation Park, the renovation of the billiards room at the SAC, opening of South Lake Park to the public, construction of the Bradley Bike Park and the updating the City trail maps.

Upcoming projects include redevelopment of the playground at Simmons Park, two new bullpens at Bradley Park, upgrading the computer lab at the SAC, and update of the department's strategic plan.

Commissioners asked questions and Andrea answered or will follow up as needed.

5. Stroller Strides Commercial Use Application

Commissioners reviewed the application included in the packet.

Assistant Director Gonzalez noted this policy is still in the City Manager's office.

9. Youth Sports Council Meeting Minutes- December 6, 2022

Commissioners reviewed the minutes included in the packet.

PARKS AND RECREATION ASSISTANT DIRECTOR REPORT

Assistant Director Andrea Gonzalez informed the Commission on department events and updates.

The Trails Advisory Committee currently has five active members and they are accepting applications and need an equestrian person on the committee.

Rangers are able to write tickets again at City parks when there is a parking violation.

Commissioners are invited to the City's 60th birthday party event on January 24th at the Community Center.

The department hired Stephanie Wilson as Aquatics Supervisor and she started and has met her staff and visited the pools and is already working on summer recruitment.

A 1.2 acre park is being proposed in the restaurant row property and the City is cohosting the public workshop with the developer and that will take place on January 25th at the Community Center.

The City is going to turn off splash pads in the off season and will be closed this year in February and will be turned back on in conjunction of the San Marcos Unified School District's spring break.

ORAL COMMUNICATIONS

Commissioner Robles requested at a future meeting a status update of the language access plan. Chair Franklin brought this up at the GPAC meeting that it should be elevated and an advisory committee should be formed.

Commissioner Mockus-Valenzuela suggested looking into connecting neighborhoods to other neighborhoods and groups so we can have more interaction among different age groups, she is going to make this a goal.

Commissioner Prestininzi would like to have an update on the Discovery Lake aeration project.

Commissioner Sensmeier attended the Senior Activity Center holiday luncheon and it was very well attended and everyone was dancing and partying and the staff did a great job and a number of council members were present.

Commissioner Smith asked if the sheriffs are taking a more interactive approach with patrolling the parks. Gonzalez noted they are and we communicate with them if additional patrols are needed in a certain park or area. Smith said the Tree Lighting event was a great event and Santa was great.

Chair Franklin has a question for the TAC. What a quorum? And that we should not cancel the meetings when possible as it is a way to get public input and it's a lost opportunity.

Call to order

James Daza called the Youth Sports Council meeting to order at 6:08pm.

Approval of Minutes

Buzz Byer (SMGS) motioned to approve the minutes from the December 6, 2022 meeting. Torry Schoch (SM Youth Lacrosse) seconded the motion.

Motion carried 6-0.

San Marcos Unified School District Update

Ted Norman was present to represent SMUSD. Ted is the new Maintenance and Operations Executive for SMUSD and was a director of maintenance and operations at his previous employer. Ted stated that he had previous experience using Facilitron and there are resources that are available if any YSC members need any refresher trainings on how to utilize it. Ted reported that SMUSD is working with a contractor to assist in maintaining their school sites, however, a lot of that work has been postponed due to the rain.

James reminded YSC members that access to SMUSD fields requires permits through Facilitron. James also reminded all members that if any of their requests for school access are denied to let him know and he will work with SMUSD to resolve any issues if it follows the current JUA.

James reminded all YSC groups that the current start time at San Marcos Middle School is 6pm for all YSC members due to school activities.



Sport Field Updates

The sports fields update was given by Stew Rutledge.

Stew informed all members that:

-Connors turf replacement and fence project is still ongoing. The netting has been completed and the turf contractor is still finishing the installation of the turf. Stew said they should be finished installing the infill on February 8, and after that Public Works has a punch list of items that will need to be taken care of before the field will reopen. Stew informed soccer groups that there are now two 7v7 soccer fields at Connors Park with netting that will be behind the apartment side where the goals are placed. James notified the soccer groups that they will need to provide two sets of goals that must have wheels and need to be locked up after each use along the north side fence.

-Public Works was able to seed some of the multipurpose fields after the rain stopped to help get the fields ready for play when they reopen on March 1.

-James requested that if Connors is not open next week that Public Works open Hollandia Park Multipurpose field because YSC Soccer groups will be hosting tryouts.

-Bradley Park has had new base pegs, pitching rubbers and home plates installed at multiple fields over the last week.

-Torry Schoch (SM Youth Lacrosse) notified Stew that in the past, when they arrived at Connors on Saturday mornings for their games they noticed trash cans were overflowing from the day before. Stew will notify the janitorial contractor to add this location to an earlier stop on their route if possible.

-San Marcos Pop Warner has requested to have an AED placed at Connors Park in case of an emergency when YSC groups are using the field. James notified the YSC that Parks and Recreation will be following up in the coming weeks with an update on their request after meeting with City management.



Soccer Tournaments and Arena Seasons

James reminded all YSC soccer organizations that with the amount of tournament dates already provided along with field closure periods, the Parks and Recreation Department and Public Works are not able to approve any more tournaments at Walnut Grove at this time. James requested City SC and AYSO 127 to please provide their arena participation numbers to Eric as soon as possible so they can be billed accurately for their season.

SM Youth Rugby Termination from YSC

Jams notified all members that SM Youth Rugby has not attended a Youth Sports Council meeting for one calendar year and will be emailed a notice of termination of membership.
