OLD BUSINESS

8. A. Fulton Road Speed Cushion Pilot Program Study Results

Damian Schoenecke, Assistant Engineer-Traffic presented the update.

Traffic Commissioners discussions included: confirmation of areas of speed counts; requested to see data from the other areas of Fulton Rd. not currently included at the next update; recommended reduced speeds going over a speed cushion; is the traffic speed data accurately compared to each other.

Staff response: The speed counts confirmed from the sections of Fulton Rd. where the high volume of speeds occurred. Manufacturers recommended speed going over a speed cushion is 20 mph. Speed-readings are taken in areas where the maximum speed levels could occur, which also have behavioral components, and data is compared to each other for the same location.

NEW BUSINESS

9. A. Traffic Calming Policy Review/Workshop

Isaac Etchamendy, Development Services Director/City Engineer gave the presentation.

-What does traffic calming mean to you and what methods should be used for safety concerns?

Traffic Commissioners discussions included: Traffic calming measures mean finding ways to be proactive and reactive in the designing of projects and what will it look like in 5 to 10 years; the movement of traffic is a safe and reasonable speed, especially around school zones; a method prepared by engineers and government bodies to create safe roads for all travelers, utilizing current available options; the population has increased, to include seasonal populations and we have to plan accordingly for vehicle and pedestrian traffic to flow reasonably throughout the city.

-What are the residents responses regarding traffic in the city? Requested solutions?

Traffic Commissioners discussions included: better education for the young drivers; speeding concerns; construction traffic workflow; traffic volume; maintain safety; school traffic impacting residential neighborhoods; pedestrian bridge on Barham; adding a roundabout and how to negotiate it; warning signage of traffic delays, congestion, etc. with alternate routes; traffic signals that responds to the flow of traffic; information on the City's website to educate the public of how the city approaches possible solutions.

-What's the importance of a structure approach?

Traffic Commissioners discussions included: Listen to the resident's concerns and have then participate in solutions; as a Commission, do a better job of explaining the process; being able to step out of the box and use resources from other means to resolve a situation; taking the time to define the issue and resolutions; understanding of how long the solution takes.
