**PUBLIC HEARING**

**2. Project No: TA22-0002**

**Request:** Approve Resolution PC23-5068 to recommend to City Council approval and adoption of Text Amendment TA22-0002, Transportation Demand Management Policy and Categorical Exemption EX23-053.

**Planning Commissioners discussions included:** What are the unit thresholds; definition of parking cash out; concerns with offsetting costs; who is monitoring the requirements; enforcement for non-compliance; percentage of people who work here live here; we are going vertical and this is a great plan.

**Staff Response:** There is a table in the Climate Action Plan that documented these thresholds. Parking Cash Out is instead of employers providing free parking, they would provide free transit to their employees. The requirements are for the next 10 years of development, and the developers has already started abiding by the new conditions in the Climate Action Plan. The applicant is required to monitor and send the City a report. Code Enforcement would go out and talk to them to see if we can get compliance. Next step is a letter of violation. If there is still no compliance, then citations will be issued. A project can build offsite facilities, such as pedestrian connections and bicycle connections. There may be a project in a suburban area and has trouble meeting their TDM 10-point score and to meet it, they can provide those pedestrian and bicycle connections in an urban area of town.

**PUBLIC COMMENTS**

**Ashanti Norris, non-resident of San Marcos** – New resident to California expressed concerns over encouraging people not to drive to work, however a lot of people who work live in their vehicles because they cannot afford housing.

**Conrad Pawelski, CFO of Diamond Environmental in San Marcos** – Commented that most State suggested requirements do not fit individual cities, and cities should implement what works for them.

**PLANNING DIRECTOR RESPONSE:** The Housing and Neighborhood Services department can provide information on services for the homeless. The money that is collected and allocated is done through our Housing and Neighborhood Services department. I can meet with the Housing and Neighborhood Services manager to get some information for the Commission.
