2. APPROVE Resolution No. PC 23-5074 to adopt the Restaurant Row Specific Plan (SP22-0004) to establish development guidelines and serve as the primary land use, policy, and regulatory document for the 10.5-acre project site;
3. APPROVE Resolution No. PC 23-5075 for a General Plan Amendment (GPA22-0002) to change the General Plan land use designation of the project site from Mixed Use 1/MU 1 (20-30 du/ac) and Light Industrial/LI to Specific Plan Area;
4. APPROVE Resolution No. PC 23-5076 for a Rezone (R22-0002) to change the zoning designation of the project site from Mixed-Use 1 (MU-1) and Light Industrial (L-I) to Specific Plan Area (SPA);
5. APPROVE Resolution No. PC 23-5077 for a Tentative Subdivision Map (TSM22-0003) to subdivide the 10.5-acre project site into three lots, dedicate right-of-way, and to create up to 202 residential and 30 commercial condominium units;
6. APPROVE Resolution No. PC 23-5078 for a Site Development Plan (SDP22-0006) to provide for the orderly development of the specific plan area with 202 residential units and 10,400 square-feet of mixed-use commercial space; and
7. APPROVE Resolution No. PC 23-5079 for a Site Development Plan (SDP23-0004) to develop a 1.1-acre neighborhood public park.
