1. Approval of Minutes from February 21, 2024 meeting

Member Norris motioned to approve the minutes. Member McLane seconded the motion. All members voted to approve the minutes; motion passed 3-0.

2. Presentation on Active Transportation Plan (Stephanie Keller, Deputy City Engineer)

Stephanie Keller presented on the Active Transportation Plan (ATP). The ATP identifies high-stress environments for walking and biking, recommends and prioritizes transportation infrastructure, programs, and policies to improve mobility, and values connected, reliable active transportation. Stephanie presented on community outreach, existing conditions, pedestrian and bicycle toolkit, active transportation recommendations, and next steps.

3. Staff Updates

Saima Qureshy summarized the recent tour to the EDCO digester facility that some members and staff attended. Additional members expressed interest in attending another tour. Staff will coordinate with EDCO to schedule the tour. Saima also informed the members that member Larisey has resigned from the group.
