Indicated that it's been difficult getting CHP out to issue citations on the County side of the street, and that having more enforcement with the traffic calming measures implemented by the City will help with resolving the speeding.

Staff response: Staff indicated that they were in contact with a sergeant from the CHP about the speeding issue and gave the CHP sergeant the Sheriff's traffic sergeant's information to work on a team collaboration for enforcement.

Commissioner's discussions included: Speed feedback sign on opposite side of road; coordination with the high school on parking education.
