PUBLIC HEARING

2. Project No: TSM21-0004 & ND22-007

Applicant: Water Mill Homes, Inc.

Request: Tentative Subdivision Map for 9 single-family residential lots on a 10-acre property in the Agricultural (A-1) Zone.

Recommendation: Staff recommends approval

Associate Planner Norm Pederson: gave staff presentation.

Applicant Jim Manning of Manning Homes: gave applicant presentation.

OPEN PUBLIC COMMENTS

Phyllis Angelico, resident of San Marcos: expressed concerns about the birds found during the applicant's study versus how many birds witnessed around home and the bird's wellbeing. HOA responsibilities regarding the sewer tanks maintenance.

Planning Commissioners Discussions: Styles of home plans; containment of sewage in other properties; environmental survey done on the birds; nice addition to the area; number of homes built on the property; expected years the sewage tanks last before problems occur; this will be a good addition to area; looking forward to this project.

Applicant response: There will be 6 different styles. The sewage tanks are becoming popular due to grade problems. A tank was installed at a project in Rancho Cucamonga. The Homeowners Association will take care of it, and we will have back up pumps installed. We are not allowed to do construction during mating season. We are following what the code is requiring to be built on that property. The tanks are built to last



a very long time. Pumps are inside the tanks and when the sewage reaches a certain level, the pumps start up to pump the sewage out. This is a private pump that is maintained by the Homeowners Association.

Planning Director comments: There is a small correction to PC24-5124 on page 3 of D12 after the last word in the last sentence, it should read “Cultural Resources will be mitigated to a level less than significant.”
