Applicant: Frank Ogwaro for Baypoint Preparatory Academy

Request: A Conditional Use Permit to allow for the continued operation of a 200 student charter school in a 25,610 square foot portion of an existing industrial building located in the Multifamily Residential (R-3-10) Zone.
