3. Approval of Minutes from November 20, 2024 meeting

4. Presentation from Clean Energy Alliance

Rob Howard and Kaitlin McGee from Clean Energy Alliance (CEA) presented updates on CEA programs, enrollment statistics, and new initiatives. Key topics included a bill comparison for February 2025 rates, participation data, and the expansion of energy programs such as the Solar Plus Program and Battery Retrofit Program. The group discussed upcoming initiatives like the PeakSmart Savers Program and the Equitable Building Decarbonization Direct Install Program, aimed at increasing energy efficiency and clean energy adoption. A community engagement survey is also planned to assess customer needs and inform future program development.
