

- Maintain 204 miles of streets, 126 miles of storm drains and nearly 300 acres of parks

Population Outpacing Resources





By 2026 San Marcos will be managing **44 parks** which is a total of nearly **300 acres!**




Declining Road Conditions Over Time

Locally Controlled Funding for City Services

San Marcos is considering a one-cent sales tax measure on an upcoming ballot to provide local funding for essential public services and infrastructure, including:



Make improvements to roads, intersections, bike lanes and signals to improve traffic and safety and reduce congestion



Fix potholes and maintain city streets



Maintain and enhance quick response times for 9-1-1 emergencies



Provide fire protection and paramedic services



Clean and maintain local parks, trails, sports fields, playgrounds and community facilities



Keep trash and pollution out of our local lakes, creeks, and waterways

Fiscal Accountability and Local Control



Independent citizens' oversight committee and annual audits



Exemptions for essential purchases from sales tax



Legal requirement for funds to remain local and not taken by the State



Estimated 40% of current sales tax paid by tourists and visitors in San Marcos

Property Tax Dollar Allocation




