The Oral Communication segment is split on the agenda and begins with up to 15-minutes in which the Commission will hear as many speakers as possible. If necessary, any remaining speakers will automatically be called during the continuation of the Oral Communication segment at the end of the agenda. No action will be taken on any item until placed on an Agenda and due notice is given. The Youth Commission is prohibited by state law from taking action on items NOT listed on the Agenda.
