1) **CALL TO ORDER:** Acting Chairwoman Kildoo called the meeting to order at 6:31 PM.

2) **PLEDGE OF ALLEGIANCE:** Led by Acting Chairwoman Kildoo.

7) REPORTS

a) Sheriff's Department Report:

SERGEANT HAYNESWORTH reported that last month they responded to approximately 80 party calls and they are anticipating that number will grow throughout the holidays. They will be increasing patrol during the holidays and they will be targeting party buses and social host events where they believe underage drinking is occurring. They will also be conducting several DUI check points during the holidays. Regarding the party buses, he stated that it is usually the person that rents the party bus that brings the alcohol and gives it to the riders. Since the driver is not required to check the riders' age, there is underage drinking. The party buses pick up local college students at a pre-determined location and drive them throughout the County. When they return the riders are under the influence and get behind the wheel posing a threat to themselves and the community. The Sheriffs Department is looking into how to hold the party bus companies accountable.

COMMISSIONER MARTINEZ asked about the highlighted area in the middle on the October 2013 Disturbance Calls Report. Sergeant Haynesworth stated that area is Mission and Borden near the college. There were various types of disturbance calls but the majority was party calls. Commissioner Martinez also asked if the drivers of the party buses are required to attend the Responsible Beverage Sales & Service training. Deputy Romero indicated that since the driver is not selling or serving alcohol they are not required to attend the training.

ACTING CHAIRWOMAN KILDOO stated that this is something she would like to keep track of and be informed if any tools are needed. Sergeant Haynesworth stated that once they identify the particular companies they are going to hold them accountable with something like the social host ordinance.

b) Code Compliance Report:

INTERIM BUILDING OFFICIAL REYNOLDS stated there were no new cases to report and they continue to work on existing cases.

8) STAFF COMMENTS:

DEPUTY CITY MANAGER ROMERO provided to the Commissioners a handout called Guide to Party Bus Enforcement from the San Diego County Law Enforcement Task Force. She also provided the Commissioners the 2014 meeting dates.

9) COMMISSION COMMENTARY:

COMMISSIONER PARIS stated that tickets are on sale for the Festival of Trees Preview Party to be held on Saturday, November 23rd at 6:00 p.m. The cost is \$50 per person. This year there will be 100 trees on display and a boutique. Proceeds from all sales will go to Interfaith Community Services and to Palomar Hospital Foundation.



Disturbance Calls: December 2013








