**San Ysidro Land Port of Entry (LPOE) Improvements, San Diego County, CA****Project Manager****CLIENT: Helix Environmental**

Supervised an inventory and evaluation of cultural and historical resources within the 50-acre APE for the proposed LPOE improvements project. Managed a records search and literature review, archival research, survey, and documentation and evaluation of historical resources. Archival research was conducted to develop a historical context for the development of San Ysidro and to establish a detailed land use history for the project area. Inventory included 14 resources within the APE. One of these, the Old U.S. Custom House, was constructed in 1932 and has been listed on the NRHP since 1982. Two additional resources were recommended eligible to the NRHP, CRHR and/or the City of San Diego Historical Resource Register (City Register) as a result of this study. ASM's study included an assessment of impacts to these historic resources and recommendations regarding mitigation measures.
